#### RACE COMMENTS

##### Race 1 | **NORTHLAND BUSINESS SYSTEMS 3YO 1400**

**MIDNIGHT EDITION** (T Moodley) – Restrained shortly after the start to obtain cover. Over-raced in the early stages. Hung outwards rounding the final bend. Hampered near the 250 metres.

**CHICAGO JACK** (J Fawcett) – Over-raced in the early stages. Hampered near the 250 metres. When questioned regarding the performance rider could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormalities.

**NOTABADBERGS** (T Mitchell) – Raced wide without cover throughout. Lay inwards when placed under pressure early in the final straight having to be corrected by its rider.

**DOMAIN ACE** (B Rogerson) – Held up early in the run home until near the 250 metres and when shifting ground hampered **MIDNIGHT EDITION** and **CHICAGO JACK**. Lay outwards throughout the run home. B Rogerson was advised to exercise greater care in similar circumstances.

**K Rae** (SIMSALA) - Issued with a warning for presenting SIMSALA late into the enclosure.

##### Race 2 | **SUPPORT NORTH HAVEN HOSPICE MAIDEN 1400**

**PIRATES 'N' GOLD** (M Sanson) – Slow to begin.

**THE YES GIRL** (T Newman) - Began awkwardly losing ground. Reluctant to hit out in the early stages despite the efforts of its rider. When questioned, rider advised that she had recommended to connections the addition of blinkers and a step up in distance. Connections were advised that a warning would be placed against the mare's racing manners.

**JACK CRABB** (A Lawson-Carroll) - Slow to begin.

**GATE CRASHERS** (K Myers) - Restrained shortly after the start to obtain cover from a wide barrier. Raced greenly having to be steadied passing the 200 metres.

**SWEET BUT PSYCHO** (A Goindasamy) - Raced wide without cover throughout.

**BUENA NOCHE** (T Moodley) - Over-raced in the early stages.

**PROPAGANDA** (L Satherley) - Raced keenly in the middle stages. Made the bend near the 900 metres awkwardly shifting outwards.

**ELECTRIC DREAM** (J Fawcett) - Checked near the 1100 metres.

**LET IT BEGIN** (B Rogerson) - Held up early in the final straight having to shift ground inwards to obtain clear running approaching 250 metres.

**ARABELLA** (N Hailey) – Lay out passing the 150 metres having to be straightened by its rider.

**J Allen** (MONIQUE TONNERRE) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of **ELECTRIC DREAM** which was checked near the 1100 metres. After considering

submissions the Adjudicator imposed a suspension of J Allen's licence to ride in races from the conclusion of racing on Sunday 15 September up to and including racing on Sunday 22 September, 4 national riding days.

**Race 3** | **MANCO ENVIRONMENTAL MAIDEN 1200**

**RED INVADER** (N Hailey) - Slow to begin. Improved onto heels having to be steadied when racing keenly near the 800 metres.

**EGYPTIAN BLUE** (D Danis) - Slow to begin.

**MIRIAM** (M Sanson) - Began awkwardly losing ground. Raced four wide without cover throughout.

**KING WILLIAM** (T Newman) - Began awkwardly losing ground. Lost ground near the 800 metres when rider T Newman was adjusting her goggles. Improved wide from the 700 metres. Rider reported that the gelding hung outwards throughout and required the assistance of the Clerk of the Course after the finish line.

**CUSTOMIZED** (J Fawcett) – Got its head up when being steadied to take a trailing position passing the 900 metres.

**GO EASY** (T Mitchell) - Hung outwards from the 700 metres.

**MOUNT RUSHMORE** (T Moodley) - Raced wide without cover throughout. Lost the near hind plate during the running.

**FIRST DANCE** (A Goindasamy) - Held up rounding the final bend. Rider reported that the filly raced greenly on debut and would derive benefit from today's experience.

**SUAVETTA** (A Lawson-Carroll) – Held up rounding the final bend.

**MOSCHINO** (K Myers) - Held up rounding the final bend.

**S Ralph** (MOUNT RUSHMORE) - Issued with a warning for presenting MOUNT RUSHMORE late into the enclosure.

**Race 4** | **HARCOURTS JUST RENTALS 1100**

**HUZZAH** (M Sanson) - Slow to begin.

**HADID** (S Brown) - Slow to begin. Raced wide without cover throughout.

**DIOR SAUVAGE** (J Fawcett) – Over-raced on the bend near the 700 metres and then was allowed to stride forward to race three wide from that point. Dictated wider on the track over the concluding stages when FROSTFAIR lay outwards. Rider dropped her whip near the winning post.

**MAFIA MAMMA** (D Danis) – Raced wide without cover through the early to middle stages. Underwent a post-race veterinary examination after blood was seen in its mouth which revealed the mare to have lost a tooth.

**YARI** (B Rogerson) - Lay outwards in the run home. Briefly came together with SHOES approaching the 100 metres.

**GOLDBURG** (K Myers) - Placed in restricted room having to be steadied when runners to the inside shifted ground approaching the 200 metres, then shifted wider on the track to obtain clear running.

**FROSTFAIR** (A Goindasamy) - Held up early in the run home. Placed in restricted room having to be steadied when racing to the outside of SHOES which shifted ground near the 250 metres. T Moodley was advised to exercise greater care in similar circumstances. Lay outwards when placed under pressure over the final 200 metres.

**SHOES** (T Moodley) – Briefly came together with YARI approaching the 100 metres.

**S Autridge** (HUZZAH) - Issued with a warning for presenting HUZZAH late into the enclosure.

**P Stevens** (CARDINAL QUEEN) - Issued with a warning for presenting CARDINAL QUEEN late into the enclosure.

**S Brown** (HADID) - Apprentice rider S Brown was shown the replay and spoken to advisedly regarding using her whip above shoulder height on one occasion near the 200 metres.

**BRIAN LAMONT** (A Lawson-Carroll) - Slow to begin.

**TAHUROA HEIGHT** (T Newman) – Began awkwardly losing ground. Was under pressure at the 800 metres and gave ground from this point not being persevered with in the run home.

**DOUBLE TAKE** (J Nishizuka) – Raced three wide without cover throughout.

**BOSCH** (K Myers) – Lost the near hind plate during the running.

<b>Race 6</b>	<b>LION RED 2200</b>

**POLAMALU** (S Brown) - Slow to begin. Raced keenly through the early and middle stages causing its rider difficulty.

**DANZINO** (N Hailey) – Slow to begin.

**BECAUSE** (T Mitchell) - Slow to begin.

**NO PLAN BE** (T Moodley) - Had to be steadied near the 2000 metres when NAVY CHIEF shifted inwards when not fully clear.

**ENDEAN ACE** (M Sanson) - Got its head up when being steadied away from the heels of NO PLAN BE which shifted out briefly passing the 2000 metres.

**QUILL** (A Lawson-Carroll) – Raced three wide without cover in the early stages.

**HEART OF ALLADIN** (J Fawcett) - Began to over-race having to shift out to avoid heels near the 1600 metres and raced three wide without cover from that point.

**PERFECTMANZ** (K Myers) – Had difficulty obtaining clear running early in the final straight then inclined to lay across heels shortly after.

**BRUCEY LEE** (L Satherley) – Lay inwards when placed under pressure in the final straight. Rider reported that the gelding had felt indifferent in its action. Underwent a post-race veterinary examination which revealed no abnormalities. Stewards will follow up the post-race condition of the gelding with trainer K Knight in the coming days.

**D Danis** (NAVY CHIEF) - Issued with a warning after permitting his mount to shift inwards near the 2000 metres when not fully clear of NO PLAN BE which had to be steadied off heels.

<b>Race 7</b>	<b>HARCOURTS BREAM BAY 1400</b>

**PEARL OF ALSACE** (K Myers) – Hampered at the start losing ground then restrained behind runners to obtain cover. Shifted widest on the track to obtain clear running entering the final straight.

**EL VENCEDOR** (N Hailey) – Shifted out at the start hampering an outside runner. Raced three wide without cover throughout.

**MALT TIME** (A Lawson-Carroll) - Slow to begin. Held up early in the run home having to be angled outwards across heels near the 200 metres.

**FONTEYN** (T Mitchell) – Slow to begin.

**PATRICIA** (T Newman) - Over-raced for a distance passing the 1000 metres. Forced wider on the track rounding the final bend.

**MACH SCHNELL** (J Fawcett) – Lay outwards rounding the final bend forcing PATRICIA wider on the track.

**TERRA MITICA** (A Goindasamy) - Inconvenienced when MALT TIME shifted ground outwards near the 200 metres. Rider A Lawson-Carroll was advised to exercise greater care in similar circumstances.

**M Bradley** (SULABELLA) - Issued with a minor infringement and fined \$50 after failing to declare a rider for SULABELLA by the required time.

<b>Race 8</b>	<b>NAI HARCOURTS WHANGAREI 1600</b>

**I'M LULU** (T Moodley) – Shifted out abruptly at the start making firm contact with JACK IN THE BOX who was forced outwards crowding outside runners. Denied a run passing the 50 metres and had to be restrained away from heels over the concluding stages. Rider T Moodley was advised to exercise greater care and ensure there is sufficient room when attempting such runs.

**JACK IN THE BOX** (T Newman) - Contacted and crowded at the start. Finished last. When questioned, rider advised that the gelding was unsuited by today's good track conditions.

**AWHINA** (D Danis) – Crowded at the start.

**OCEANS OF STANIMA** (J Fawcett) - Crowded at the start losing ground.

**NIGELLA LANE** (J Allen) - Jumped inwards at the start making contact with FIRST FIVE.

**FIRST FIVE** (L Satherley) – Contacted at the start.

**BLUE MOON** (M Sanson) - Slow to begin.

**DELOREAN** (T Mitchell) - Raced clear in the lead alongside TRIGON LAD through the early and middle stages.

**S Fisher** (TRIGON LAD) - Was shown the replays regarding the tactics she adopted through the early and middle stages in the presence of trainer M Rogers for educational purposes. M Rogers advised that his instructions were to lead which was in accordance with the gelding's normal racing pattern. S Fisher added that taking a trail was not an option because her mount was racing keenly.

<b>Race 9</b>	<b>18 DEC RSN ROOFING CHRISTMAS AT THE RACES 1600</b>

The start of this race was delayed due to SAKURA ROSE proving difficult to load eventually being late scratched at 4.40 pm after refusing to load. Connections were advised the mare must barrier trial prior to racing next.

**LET FLY** (K Myers) - Began awkwardly losing ground. When questioned regarding the performance rider advised that the mare would be better suited to a step up in distance.

**MIGHTY BRIGHT** (B Rogerson) - Bounded at the start losing ground.

**ZLATNA** (J Fawcett) - Slow to begin. Rider reported that the mare hung outwards throughout and in her opinion would be better suited to a track with more give in the ground.

**SONOFABUTCHER** (M Sanson) - Slow to begin.

**MIGHTY CASTLE** (J Allen) – Raced three wide without cover throughout.

**SHOCKATILLATAP** (T Moodley) - Over-raced in the early stages getting its head up on a number of occasions. Improved onto heels having to be steadied near the 600 metres.
