Race 8 HILAL@GRANGEWILLIAM STUD 1400m

ICONIC LASS (T Davies) – Trainer R Buchanan reported to Stewards ICONIC LASS underwent blood tests on Tuesday 27 August and was examined by a Veterinarian on Friday 28 August, with no abnormalities being detected then on Tuesday 3 September, the mare received treatment by a physiotherapist for general muscle soreness. R Buchanan further advised ICONIC LASS has now been given a few days break and will start back with light track work.

Wanganui Jockey Club @ Wanganui, Saturday 31 August 2024**Race 9 ST JOHNS CLUB 2060m**

SMOKIN MO (O Bossom) – Trainer A Meadows reported to Stewards that on return to his stable SMOKIN MO underwent farrier attention which revealed a foot abscess to the left fore receiving the appropriate treatment. A Meadows further advised that it is his intention to continue on with SMOKIN MO'S current preparation once the abscess subsides.

RACE COMMENTS**Race 1 HASTINGS BLOSSOM FESTIVAL PREMIER 1600m**

The start of Race 1 was delayed approximately 4 minutes due to a loose pony in the centre inside the track.

ANAROA (J Parkes) - Slow to begin. Contacted passing the 600 metres.

MOOD CHANGER (S Weatherley) - Slow to begin. Held up until near the 150 metres.

DON PAULY (S Spratt) - Slow to begin. Had to steady away from heels near the 600 metres making contact with ANAROA.

INVESTIGATE (O Bosson) - Raced three-wide without cover until near the 900 metres. When questioned regarding performance rider advised that after having to work early under its top weight the gelding had been unable to finish the race off but should derive improvement from its fresh up run today.

CAST OF DIAMONDS (W Pinn) - Raced keenly in the early stages when being restrained.

MOONLIGHT HUSTLER (K Hercock) - Raced in restricted room for a distance approaching the 800 metres when racing keenly. Held up rounding the final turn and early in the straight having to be checked off heels near the 300 metres. Continuing to have difficulty obtaining clear running until near the 100 metres.

SUNSET BOULEVARD (R Elliot) - Held up for a distance passing the 350 metres.

PADDY GIFT (J Doyle) - Held up early in the straight until near the 200 metres.

Race 2 LIVAMOL – INTERNATIONAL HEALTH PRODUCTS PREMIER 1600m

WOLFGANG (M Cartwright) - Lost the left front plate approaching the 400 metres.

Race 3 NZB READY TO RUN TRAINERS SERIES PREMIER 1200m

MY ALIBI (C Barnes) - Slow to begin.

SASPERELLA (M Hashizume) - Restrained in the early stages to obtain cover from a wide barrier.

SPEED DIAL (K Chowdhury) - Slow to begin. Improved onto heels near the 100 metres and was unable to be ridden out for the remainder of the race.

CUBA STREET (W Pinn) - Improved onto heels and raced ungenerously when being steadied passing the 700 metres.

REPTAK (M Cartwright) - Raced wide without cover.

Race 4 | **COLLIERS COMMERCIAL HAWKE'S BAY PREMIER 2000m**

CROSS ROADS (S Spratt) - Knuckled on jumping away.

GRACE 'N' GLORY (M Hashizume) - Began awkwardly, losing ground.

AGERA (M Cartwright) - Restrained to obtain cover after jumping from a wide draw.

WHO KNOWS (L Sutherland) - Restrained to obtain cover after jumping from a wide barrier. Had some difficulty obtaining clear running in the straight, having to steady and shift outwards across heels passing the 200 metres.

THE FINNSTER (C Dell) - Raced wide in the early stages before improving forward outside the leader approaching the 1200 metres.

WHELITIN (K Hercock) - Raced wide without cover from the 1200 metres.

SASSY LASS (W Kennedy) - Held up for a distance passing the 350 metres.

EYEGEEGEE (C Grylls) - Steadied when placed in restricted room near the 250 metres to the inside of **DODGY ONE** (W Pinn). W Pinn was advised to exercise care when shifting ground.

DODGY ONE (W Pinn) - Had to be steadied when disappointed for a run passing the 100 metres to the inside of **CROSS ROADS**, which shifted ground marginally.

Race 5 | **EL ROCA – SIR COLIN MEADS TROPHY (Listed Race) 1200m**

MOVED TO STRIKE (O Bosson) - Slow to begin. When questioned regarding performance, rider advised the colt had been very disappointing and was unable to offer any excuse. A post-race veterinary examination found the colt to have an elevated heart rate with a poor rate of recovery.

SKIPPERS CANYON (W Kennedy) - Slow to begin.

SUPER PHOTON (J Doyle) - Raced three-wide without cover throughout.

BALLON D'OR (M Hashizume) - Raced keenly for a distance passing the 600 metres having to be restrained off heels.

SAVAGLEE (S Spratt) - Held up early in the straight having to shift outwards across heels to obtain clear running.

Race 6 | **THE PENINSULAR RESORT MOOLOOLABA PREMIER 1300m**

HOKITIKA BELL (J Doyle) - Slow to begin. Crowded concluding stages.

PSYCLONE (S Spratt) - Crowded shortly after the start losing ground.

SLIPPER ISLAND (O Bosson) - Held up for the majority of the final straight.

OVERDRAWN (M Cartwright) - Crowded concluding stages.

TESTWIN (J Parkes) - Crowded concluding stages.

FONSI (K Hercock) - Crowded concluding stages.

THE ENTERTAINER (W Kennedy) - Crowded concluding stages.

L Sutherland (SUPER WRAITH) - Defended a charge of careless riding in that she permitted her mount to shift inwards over the concluding stages crowding OVERDRAWN, HOKITIKA BELL, TESTWIN, FONSI and THE ENTERTAINER. After considering submissions the Adjudicative Committee found the charge to be proven and imposed a suspension of her licence to ride in races from the conclusion of racing on Saturday, 14 September until the conclusion of racing on Friday, 27 September, 7 national riding days.

Race 7 | **HBPB THOROUGHBRED BREEDERS GOLD TRAIL STAKES (G3) 1200m**

ANUSHKA SHESASTAR (J Doyle) – Declared a late scratching at 3.26pm after refusing to load. Connections were advised that the filly must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

PLEASING (J Chung) - Made contact with the running rail passing the 600 metres going off stride.

VELOCIOUS (C Grylls) - When questioned regarding performance rider could offer no excuse other than the filly being slow away. A post-race veterinary examination did not reveal any obvious abnormality.

SISTER PING (V Colgan) - Failed to leave the barriers taking no part in the race. A request for a ruling was filed with the Adjudicative Committee under the provisions of Rule 632(1) as to whether SISTER PING had been denied a fair start. After viewing relevant film footage and hearing submissions the Adjudicative Committee found that although SISTER PING had become fractious and attempted to rear a barrier attendant still had hold of the rein and accordingly ruled that SISTER PING be declared a non-starter, with all bets on that runner being refunded. Trainer C Ormsby was advised SISTER PING must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

Race 8 | **VET SERVICES EQUINE HAWKE'S BAY PREMIER 1200m**

WILD WEST (M Hashizume) - Underwent a pre-race veterinary examination after breaking through the front of its barrier stall and was cleared to start.

MERCHANT QUEEN (C Grylls) - Crowded leaving the barriers.

MAROTIRI MOLLY (K Hercocock) - Slow to begin. Had to be checked when improving onto heels over the concluding stages.

CANDLE (L Sutherland) - Slow to begin.

HAVARTI (K Chowdhooory) - Raced keenly in the early and middle stages. Underwent a post-race veterinary examination which revealed the gelding to have suffered cardiac arrhythmia. Trainer P Didham was advised that HAVARTI will not be permitted to start in any race or trial until providing a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of 1000 metres.

DUNEAGLE (C Dell) - Raced three-wide without cover throughout.

PAPA SURF (M Cartwright) - When questioned regarding performance the rider advised the gelding had felt indifferent in its action during the running. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

FARRAVALLO (J Chung) - Lost the left hind plate during the running.

Race 9 | **WESTBURY STUD TARZINO TROPHY (G1) 1400m**

GERIATRIX (J Parkes) - Slow to begin.

CROCETTI (W Kennedy) - When questioned regarding performance, rider advised that the gelding had travelled well and he had been confident of its chances but had then been quickly beaten once placed under pressure near the 200 metres and was unable to offer any excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

BONNY LASS (C Grylls) - When questioned regarding performance rider was unable to offer any excuse other than the mare possibly not backing up from its recent Te Rapa win. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

SACRED SATANO (R Elliot) - Lay inwards under pressure over the final 200 metres.

M Cartwright (GRAIL SEEKER) - Admitted a charge in that he made a celebratory gesture prior to the winning post. After hearing submissions, the Adjudicative Committee imposed a fine of \$600.

FINAL PURCHASE (B Jacobson) - Contacted the front of its barrier stall, which opened. Was removed from the barriers to undergo a veterinary examination before being cleared to start.

ROCKBURN (J Doyle) - Slow to begin.

GIACOMO (C Grylls) - Raced three-wide without cover throughout. Inconvenienced near the 250 metres.

DIMAGGIO (L Sutherland) - Disappointed for a run near the 300 metres, then having to be steadied off the heels of GIACOMO near the 250 metres when that runner was taken outwards by STERLING EXPRESS (W Kennedy) which shifted ground under pressure. W Kennedy was advised to exercise greater care when shifting ground.
