<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>PAT &amp; THE LATE JOHN SHANNON MAIDEN HURDLE 3000m</b>
<p><b>NO TEARS</b> (T Moki) - Slow to begin, tailed off throughout and proved uncompetitive, finishing some distance behind the second last runner. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Trainer A Baker was advised the gelding is required to trial due to being uncompetitive, however Stewards were advised the gelding is now retired.</p> <p><b>EMPIRE STATE</b> (H McNeill) - Retired from the event shortly after jumping the fence near the 900 metres when the rider considered something amiss. Underwent a post-race veterinary examination which revealed a right fore heel injury.</p> <p><b>SIR MAVERICK</b> (L Douglas) - Retired from the event after jumping the fence near the 900 metres when out of contention.</p> <p><b>MOLLY'S GOLD</b> (P Matthews) - Retired from the event near the 800 metres when out of contention.</p> <p><b>YOULEDO</b> (J Kozaczek) - Retired from the event prior to entering the home straight when out of contention.</p> <p><b>MURPHY</b> (N Downs) - Jumped the second-to-last fence awkwardly.</p> <p><b>T Moki</b> (NO TEARS) - Admitted a charge in that she failed to retire her mount when well back and out of contention. After hearing submissions the Adjudicative Committee imposed a fine of \$350.</p>	
<b>Race 2</b>	<b>TALANA HILL HURDLE 3000m</b>
<p><b>SEMPER MAGICO</b> (P Matthews) - Raced keenly after the start then fell at the second fence. MUGSHOT and DUKE OF PLUMPTON were both hampered by the fallen runner, having to take evasive action. Underwent a post-race veterinary examination which revealed a rib injury on the left side. Trainer M Oulaghan was advised SEMPER MAGICO requires a veterinary clearance prior to racing next. P Matthews was examined by St John personnel and</p>	

cleared to ride, however she stood herself down from her remaining ride after feeling unwell, so is now required to provide a medical clearance.

**MUGSHOT** (D Parker) - Hampered by the fallen runner at the second fence, having to take evasive action. Hampered by fallen runner at the fence near the 600 metres. Hampered at the last fence by the fallen runner.

**DUKE OF PLUMPTON** (N Downs) - Hampered by the fallen runner at the second fence, having to take evasive action.

**LEITRIM LAD** (J Kozaczek) - Fell at the fence near the 600 metres, hampering MUGSHOT. A post-race veterinary examination was clear. J Kozaczek was examined by St John personnel and stood down from his remaining rides today.

**VERRY FLASH** (J Parker) - Came together and bumped with DICTATION prior to the last fence. Fell at the last fence hampering DICTATION and MUGSHOT. Underwent a post-race veterinary examination which revealed a superficial wound to its left pastern. J Parker was examined by St John personnel and cleared to ride.

**DICTATION** (H McNeill) - Came together and bumped with VERRY FLASH prior to the last fence. Hampered at the last fence by the fallen runner.

**Race 3** | **FLAIR AMATEUR RIDERS 2100m**

**DOROTHY'S DAUGHTER** (E Quinn) - Began awkwardly.

**STEVE AUSTIN** (V Peebles) - Began awkwardly bumping TRAMORE.

**TRAMORE** (A Scott) - Bumped at the start.

**CALL ME JACK** (K Singh) - Began awkwardly.

**FABIAN HAWK** (A McIntyre) - Began awkwardly. Finished towards the rear. Underwent a post-race veterinary examination which was clear.

**LA JUNGLES** (N Jenkins) - Raced wide throughout.

**GO BUTCH** (O Helagi) - Held up rounding the final bend.

**Race 4** | **DERM & SUE CONGRATS FOR VEGAS MAIDEN STEEPLECHASE 4000m**

**MONITOR** (S Karnicnik) - Retired from the event near the 1700 metres when the rider felt there was something amiss. Underwent a post-race veterinary examination which revealed a tendon injury to the right foreleg. Trainer B Beatson was advised MONITOR requires a veterinary clearance prior to racing next.

**ZAC FLASH** (N Downs) - Jumped indifferently throughout.

**HE ZED GO** (C Wiles) - Hampered at the fence near the 600 metres. Retired from the event prior to the second-to-last fence.

**GREYSTONE** (E Farr) - Retired from the event prior to the second-to-last fence when out of contention.

**ZAC FLASH** (N Downs) - Retired from the event prior to the second-to-last fence when out of contention.

**ZEEFA ZED** (H McNeill) - Jumped the fence near the 600 metres awkwardly, hampering HE ZED GO. Jumped the second to last fence awkwardly hampering FABULOUS NANCY.

**FABULOUS NANCY** (L Douglas) - Hampered second-to-last fence when out of contention.

**MR FABULOUS** (T Moki) - Jumped the last fence awkwardly, unbalancing the rider. Lay out under pressure over the concluding stages.

**Race 5** | **DAVID & ELLEN OLIVER STEEPLECHASE 4000m**

**DONARDO** (C Wiles) - Jumped the fence near the 1900 metres awkwardly, unbalancing the rider.

**JAKAMA KRYSTAL** (L Douglas) - Landed awkwardly dislodging the rider at the fence near the 600 metres. Underwent a post-race veterinary examination after having blood present in a nostril on returning to the parade ring consistent with impact to the nose. L Douglas was examined by St John personnel and cleared to ride.

**RAUCOUS** (H McNeill) - Lost the near front plate during the running.

**Race 6** | **CELEBRATING SONYA MAIDEN 2200m**

**HE'S ALL FABULOUS** (L Douglas) - Began awkwardly, bumping HINKY ANNIE.

**HINKY ANNIE** (T Moodley) - Bumped at the start. Finished last. When questioned rider advised the mare had failed to see out the step in distance of today's event. Trainer reported the mare's future would be reconsidered.

**OUR DAYMO** (M Singh) - Restrained from its wide draw then over-raced for a short distance.

**GEORGIEWOOD** (L Sutherland) - Raced keenly through the early stages having to be steadied. Rider reported the gelding had failed to handle today's track conditions.

**LEPREKHAN** (M Hashizume) - Made the first bend awkwardly, dictating KEEN ON BUBBLES wider on the track.

**KEEN ON BUBBLES** (E Sole) - Dictated wider on the first bend.

**STANMORE** (C Dell) - Finished towards the rear. Rider advised the gelding had pulled up in a normal post-race condition and could offer no excuse. Trainer advised the gelding's future would be retired from their stable.

**Race 7** | **COPPERMINE CONTRACTING MAIDEN 1100m**

**L Douglas** who had been cleared by St John after being dislodged in Race 5 advised Stewards that he was feeling unwell and after further monitoring by Paramedics was stood down from his remaining two rides. L Douglas was advised that he is required to provide a medical clearance prior to his next ride.

**WIRE ROPE** (T Moodley) - Removed from its barrier after becoming fractious and underwent a veterinary examination prior to being declared a late scratching at 3.13pm. Trainer B Thurlow was advised WIRE ROPE is required to trial prior to racing next.

**CUISINE** (K Chowdhury) - Slow away. Raced greenly throughout the home straight.

**SHEZHAPPYONE** (C Lindsay) - Raced greenly throughout.

**CYPRESS** (L Sutherland) - Lay inwards under pressure from the 300 metres and had to be straightened on several occasions.

**HOLLYHOCKAROO** (T Davies) - Raced greenly in the home straight and shifted inwards and away from CYPRESS near the 200 metres and again a short distance further, near the 100 metres.

**FELUCCA** (M Hashizume) - Inclined to lay inwards throughout the home straight.

**THE MAUKU EXPRESS** (L Hemi) - Finished last. When questioned rider reported the filly raced greenly throughout, was not suited to the heavy track and in her opinion would improve with racing. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

**Race 8 ANNE & MICHAEL BEECH MAIDEN 1200m**

The start of this race was delayed approximately 6 minutes due to several runners requiring veterinary examination and TAKE IT dislodging its rider in the preliminary.

**Trainer K Duncan** (GAOTH) was fined \$50 (minor infringement) for presenting his runner without the notified gear (blinkers and ear covers).

**TAKE IT** (T Davies) - Late scratching at 3.44pm by Stewards after dislodging its rider during the preliminary and galloping some distance before being recaptured. Trainer S Brown has been advised that TAKE IT must trial prior to racing next.

**SILENT BID** (M Hashizume) - Underwent a pre-race veterinary examination at the barrier and declared a late scratching at 3.47pm.

**DE ORO CHARM** (C Dell) - Underwent a pre-race veterinary examination and cleared to start. Began awkwardly, hampering OSCAR and KING INCANTO.

**OSCAR** (J Riddell) - Hampered at the start.

**KING INCANTO** (J Mudhoo) - Hampered at the start, losing ground.

**FLORIN** (L Sutherland) - Began awkwardly losing ground. Held up rounding the final bend, having to be angled outwards near the 250 metres to gain clear racing room.

**POPPY'S GIRL** (K Chowdhoo) - Finished towards the rear. When questioned rider could offer no excuse.

**Race 9 WENHAM GRAIN & SEEDS 1400m**

**CARIGNAN** (T Moodley) - Began awkwardly. Raced greenly in the home straight and was inclined to shift outwards under pressure.

**RIDE THE TIDE** (J Riddell) - Began awkwardly.

**NOTABADBAR** (L Kauri) - Crowded at the start when runners either side began awkwardly.

**CALL A FRIEND** (J Chung) - Lay inwards throughout.

**Race 10 JOHN & NATALIE MABEY MAIDEN 1600m**

**FIVE BELLS** (A Mudhoo) - Slow to begin.

**GRAHAMS PRIDE** (J Mudhoo) - Began awkwardly, hampering GUZZLER.

**GUZZLER** (J Riddell) - Hampered at the start.

**FINNEAS** (T Bau) - Rider reported the gelding may have got its tongue over the bit.

**SWEET ENVY** (K Chowdhury) - Returned to the enclosure with a minor abrasion to the off-hind leg, which was treated by the veterinary surgeon.

**THIRSTY** (J Chung) - Commenced to weaken from the 350 metres, finishing last. J Chung advised the gelding travelled reasonably in or near the lead, but when taken on near the 600 metres failed to finish the race off. J Chung reported to Stewards that THIRSTY pulled up in a normal post-race condition but was disappointing. Trainer M Breslin advised Stewards the gelding is more suited to being ridden back in the field, however he will monitor THIRSTY over coming days and report any anomalies to Stewards.
