<p>DANCIN IN THE DARK (T Mitchell) - Slow to begin.</p> <p>GOLDEN (S Weatherley) - Restrained in the early stages to obtain cover from a wide barrier.</p> <p>WAINUI BAY (M Cartwright) - Lay outwards rounding the final bend having to be corrected by its rider.</p>

<p>STONYBRECK (R Goyaram) - Slow to begin. Raced keenly in the middle stages. Improved wide rounding the final bend.</p> <p>MISTER PUCCI (A Lawson-Carroll) - Restrained in the early stages to obtain cover from a wide barrier.</p> <p>SIDE EYE (T Mitchell) – Raced keenly in the early stages.</p> <p>HIT THE SWITCH (S Mxothwa) - Lay outwards when placed under pressure rounding the final bend.</p>	
Race 3	WAIPA EARTHWORKS MAIDEN 1300
<p>This race was delayed by 2 minutes due to horses proving difficult to load.</p> <p>I'M OUT THE GATE (C Grylls) - Reared behind the barriers dislodging its rider. Underwent a pre-race veterinary examination and was cleared to start. Rider C Grylls was uninjured. Began awkwardly losing ground. Commenced to give ground from the 600 metres. When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormalities. Stewards will follow up with trainer S Marsh on the post-race condition of the filly in the coming days.</p> <p>WAITERIMU (S Weatherley) - Proved difficult to load. Connections were advised a warning would be placed on the mare's barrier manners. Raced three wide without cover for the majority of the race. Lost the left hind plate during the running.</p> <p>SHE'S A BELLATRIX (A Lawson-Carroll) - Began awkwardly losing ground.</p> <p>MARKET SQUARE (M Hashizume) - Slow to begin.</p> <p>NAVY ICON (J Doyle) - Restrained in the early stages to obtain cover from a wide barrier.</p> <p>FLASH EFFECT (W Kennedy) – Raced wide in the early stages.</p> <p>ANOTHER FLOOZIE (M Cartwright) - Held up rounding the final bend and early in the straight.</p> <p>OBAN (J Fawcett) – When questioned regarding the performance rider advised that the gelding would appreciate a step up in distance.</p> <p>PENNY BLUE (S Brown) - Ducked outwards abruptly after the finish line dislodging its rider who was immediately attended to by St John Ambulance personnel and found to be uninjured.</p>	
Race 4	SADDLERY WAREHOUSE 1300

NO AGENDA NIGEL (B Rogerson) - Slow to begin. Raced keenly in the early and middle stages. Came together with SPIELBERG over the concluding stages.

SPIELBERG (W Kennedy) - Came together with NO AGENDA NIGEL over the concluding stages.

ALFRISTON (S Spratt) - Raced keenly through the early and middle stages. When questioned regarding the performance rider advised that the gelding failed to respond when placed under pressure in the final straight.

Race 5 | **SASTRATECH MAIDEN 970**

WEE THISTLE (T Newman) - Had to be steadied shortly after the start when racing to the inside of CANTATRICE which ducked inwards. Raced three wide without cover throughout. Lay out entering the final straight.

DON'T TELL RACHEL (M Cartwright) - Raced keenly in the early stages. Underwent a post-race veterinary examination which revealed a superficial graze to the front left stifle.

ORTEM LEGACY (S Spratt) - Raced in restricted room over the concluding stages.

Race 6 | **TAB 970**

CONMAN (L Satherley) - Removed from the barrier after being fractious to undergo a pre-race veterinary examination and was declared a late scratching at 3.31 pm. Connections were advised the colt will be required to barrier trial to the satisfaction of Stewards prior to racing next. Underwent a post-race veterinary examination which revealed skin off the left fore cannon with no apparent lameness.

CHARLES (T Mitchell) - Slow to begin.

BY HER RULES (V Colgan) - Began awkwardly. Connections were advised a warning would be placed on the filly's barrier manners. When questioned regarding the performance rider advised that the filly had failed to respond when placed under pressure.

LEGALLY BINDING (W Pinn) - Rider dropped his whip near the 50 metres.

Race 7 | **PRYDE'S EASIFEED 2000**

BIEDERMEIER (J Doyle) - Slow to begin.

SONOFABUTCHER (C Barnes) - Slow to begin.

SAN SIMEON (K Myers) - Raced keenly through the middle stages. Held up rounding the final bend before shifting across heels to obtain clear running near the 200 metres.

EVANA TRUMPALOT (B Jacobson) - Lay in passing the 300 metres making contact with the running rail and again passing the 200 metres.
