Rider **J Parkes** admitted a charge in that he was unable to make the contracted weight for his rides in Races 1 and 7 and was fined \$100 under the Minor Infringement Schedule. Rider replacements were made as per above Summary.

### RACE COMMENTS

#### Race 1 UNITED STEEL 1800m

**SALLY** (J Chung) - Began awkwardly hampering **FLANEUR**. Made the first bend awkwardly. Made the final bend awkwardly.

**FLANEUR** (K Kalychurun) - Hampered at the start.

**FIVE BELLS** (J Mudhoo) - Began awkwardly losing ground.

**CHILLI CON KHAN** (L Douglas) - Hung outwards throughout when leading before weakening entering the home straight. When questioned regarding performance, rider advised that the mare was comfortable in the heavy ground but may be better suited to right-handed tracks. A post-race veterinary examination did not reveal any obvious abnormality.

**FAUSTIAN BARGAIN** (L Kauri) - Lay out over the concluding stages.

**TISSE** (L Sutherland) - Lay in over the concluding stages having to be straightened.

**WHOSHE'S BOY** (T Newman) - Finished last and was not competitive. Trainer was advised the gelding will be required to trial to the satisfaction of a Stipendiary Steward prior to racing next. A subsequent veterinary examination did not reveal any obvious abnormality apart from a slow recovery rate.

**Race 2** | **WINSTONE WALLBOARDS 1200m**

**PEPPERY** (A Mudhoo) - Slow to begin. Rider dropped his whip near the 300 metres.

**RUNNINWITHTHEDEVIL** (J Nishizuka) - Began awkwardly.

**BRAZENBELLE** (T Davies) - Began awkwardly. When questioned regarding performance, rider was of the opinion the mare was unsuited to today's track conditions.

**BELLA TIMING** (R Goyaram) – Raced greenly over the concluding stages.

**WHOSHE'S GIRL** (K Kalychurun) - Finished last. Rider advised that the mare was unsuited to today's very testing underfoot conditions. Connections advised that the future of WHOSHE'S GIRL will be reassessed.

**THE ENTERTAINER** (L Sutherland) - When questioned regarding performance, rider was of the opinion the mare was unsuited to today's track conditions.

**Race 3** | **JAMES HARDIE 1400m**

**I DON'T** (R Goyaram) - Began awkwardly. Finished towards the rear. When questioned regarding performance, rider advised that the gelding was unsuited to today's heavy track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

**OCEAN ROAD** (A Riddell) - Began awkwardly. Over raced through the early stages.

**KORO'S PRINCESS** (J Chung) - Slow to begin.

**ROSESRRRED** (A Mudhoo) - Lay in under pressure in the final straight.

**MIGHTY BRIGHT** (C Dell) - When questioned regarding performance, rider could offer no excuse. A post-race veterinary examination did not reveal any obvious abnormality.

**Race 4** | **NEW PLYMOUTH BUILDING SUPPLIES 1400m**

**STREET GOSSIP** (R Goyaram) - Declared a late scratching on veterinary advice at 12:54pm after being injured at the start. Connections were advised that a warning will be placed against the mare's barrier manners.

**PASHAMAIA** (K Kalychurun) - Slow to begin.

**CANHEROC** (T Davies) - Slow to begin. Momentarily held up for clear racing room inside the final 50 metres.

**TAVIS COURT** (E Sole) - Began awkwardly.

**ISLINGTON LASS** (A Riddell) - Held up for clear running through the home straight. When questioned regarding performance, rider advised that the mare was unsuited to today's track conditions.

**C Butler** (CHAJABA) - Admitted a charge in that she struck her mount CHAJABA 6 times prior to the 100 metre mark and 5 more strikes inside the 100 metres. After considering submissions the Adjudicator imposed a fine of \$250.

**Race 5** | **MAKITA 1800m**

**JUSTASKME** (R Goyaram) - Slow to begin. Lay in over the concluding stages.

**LIQUID LES** (L Sutherland) - Finished towards the rear. When questioned regarding performance, rider advised that the gelding was unsuited to today's track conditions.

**URENUI** (E Sole) - Finished towards the rear. When questioned regarding performance, rider advised that the gelding was unsuited to today's track conditions.

**BELLADONNA LILY** (C Butler) - Finished towards the rear. When questioned regarding performance, rider advised that the mare was unsuited to today's track conditions.

**Race 6** | **STEEL & TUBE 2000m**

**AIN'T BAD** (C Dell) - Slow to begin.

**CHASE 'N' GOLD** (J Allen) - Restrained from a wide draw to obtain cover.

**MADAME MOET** (K Kalychurun) – Restrained from a wide draw to obtain cover.

**AMARILLO SLIM** (L Douglas) - Improved onto heels having to be steadied near the 1700 metres.

**CASCATELLA** (C Butler) - Shifted out when weakening passing the 800 metres resulting in AMARILLO SLIM and GRAND PROSPECT being tightened. Rider C Butler advised that the mare commenced to hang when weakening in the bad ground. C Butler was advised to exercise greater care when shifting ground. When questioned regarding performance, rider advised that the mare was unsuited to today's track conditions.

**DOROTHY'S DAUGHTER** (A Riddell) - Momentarily held up near the 600 metres and had to be steadied off the heels of the weakening DIVINE SPIRIT.

**Race 7** | **ITM NEW PLYMOUTH INTERPROVINCIAL 1600m**

**WHO KNOWS** (L Sutherland) - Restrained to the rear from a wide draw to obtain cover.

**RAGAMUFFIN** (B Jacobson) - Slow away.

**ARCADIAN LYNX** (L Hemi) - Over raced having to be steadied near the 1500 metres.

**WHO'S COMPLAININ** (C Butler) - Raced keenly passing the 1100 metres having to be steadied.

**TOBIAS** (E Sole) - Lost both hind plates during the running.

**Race 8** | **PASLODE 1600m**

**OUTER FOCUS** (J Riddell) - Restrained from a wide draw to obtain cover.

**BLACK ORLOV** (E Sole) - Slow away.

**GIRLS LIGHT UP** (R Goyaram) - Rider dropped his whip passing the 500 metres. When questioned regarding performance, rider advised that the mare was unsuited to today's track conditions.
