**RACE COMMENTS** 

Race 1 PRYDES EASIFEED MAIDEN 2140m

NO TEARS (T Bau) - Slow to begin.

IDENTIKIT (L Hemi) - Restrained to obtain cover.

**HALOUMI** (K Chowdhoory) - Over-raced through the early stages when being restrained to take cover. Finished towards the rear. When questioned, rider could offer no excuse.

**ARAMOHO** (M Singh) - Finished towards the rear. When questioned, rider advised the mare had raced handy on this occasion but in his opinion may be better suited to racing off the pace.

**SUBTLE IMAGE** (T Davies) - Lay inwards under pressure throughout the home straight and over the concluding stages shifted inwards and bumped IDENTIKIT, which became momentarily unbalance. T Davies was shown footage of her ride and advised she is expected to straighten her mount sooner than she did on this occasion.

Connections of the 2<sup>nd</sup> place runner, IDENTIKIT, viewed footage of the concluding stages before electing not to proceed with an objection against the first placed SUBTLE IMAGE.

## Race 2 HADLEY SEARLE @ SEAHORSE SUPPLEMENTS MAIDEN 1400m

**RED RIBBON** Trainer T Perry advised Stewards that RED RIBBON had sustained superficial injuries after getting down in the float enroute to the racecourse so was subequently declared a late scratching at 12.11pm by Stewards.

**CUBA STREET** (W Pinn) - Began awkwardly hampering TOUCH O'PARADISE. Raced ungenerously shortly after the start, having to be steadied abruptly when improving on to heels near the 1100 metres.

**TOUCH O'PARADISE** (J Riddell) - Hampered at the start.

**SWEET ADA** (C Dell) - Began awkwardly hampering SECLUSION.

**SECLUSION** (L Kauri) - Hampered at the start.

PERFECT POSY (T Allan) - Raced keenly through the middle stages.

**I AM JAZZ** (J Chung) - Made the final bend awkwardly, losing ground. J Chung reported the mare had reacted unfavourably when racing in restricted room amongst runners but finished the race off when in clear running.

#### Race 3 HYGAIN TRACKTORQUE MAIDEN 1200m

**THE GOLDEN BOY** (J Riddell) - Began awkwardly hampering OSCAR, which lost ground. Over-raced through the early and middle stages, then raced greenly for the remainder.

**OSCAR** (L Hemi) - Hampered at the start, losing ground.

**DAPPER DAN** (J Chung) - Over-raced through the early and middle stages.

**WAFT** (L Sutherland) - Briefly held up rounding the final bend.

#### Race 4 HW CAVANAGH AGGREGATES 1200m

**LUXURIANT** (W Pinn) - Improved on to heels, having to be steadied near the 500 metres.

## Race 5 MCMILLAN EQUINE FEEDS 2140m

**SAINT BERNARD** (K Chowdoory) - Restrained to the rear to obtain cover. Raced keenly through the early stages, having to be steadied. Lay inwards under pressure near the 100 metres. Rider K Chowdoory was shown footage of his ride, issued with a warning and advised he is expected to straighten his mounts sooner than he did on this occasion.

**JACK MORRISON** (K Hercock) - Steadied near the 100 metres when placed in restricted room when SAINT BERNARD lay inwards under pressure.

**K Chowdoory** (SAINT BERNARD) - Issued with a warning for permitting his mount to shift inwards near the 100 metres, hampering JACK MORRISON.

### Race 6 MAJESTIC HORSEFLOATS 2140m

THE JAKKAL (K Chowdhoory) - Began awkwardly losing ground.

**MAHOE** (W Pinn) - Made the bend into the home straight on the first occasion awkwardly.

JACKAROO (K Hercock) - Raced three-wide from the 1000 metres.

LOVEHELEN (M Hashizume) - Held up and unable to find clear racing room throughout the home straight.

**MONKEY TOWN** (L Hemi) - Underwent a post-race veterinary examination at the Trainer's request after appearing to have been galloped on during the running and was found to have lacerations on both sides of its left hock.

**MAGGIES CHOICE** (C Dell) - Finished towards the rear. C Dell dismounted the mare on pulling up after he considered something was amiss. MAGGIES CHOICE was attended to by veterinary staff and found to have a tendon injury to the right foreleg. Connections were advised that MAGGIES CHOICE requires a veterinary clearance prior to racing next.

#### Race 7 FIBER FRESH ACTIVE 1000m

**PARTY ROCKING** (J Chung) - Began awkwardly hampering outside runners.

**ARDEE BOY** (T Davies) - Hampered at the start when runners either side shifted ground.

**COVERMEINSUNSHINE** (M Hashizume) - Hampered at the start when runners either side shifted ground.

JUS WING IT (E Sole) - Began awkwardly hampering inside runners.

MALMAISON (W Pinn) - Tightened near the 700 metres.

**GET FUNKY** (C Dell) - Tightened near the 700 metres.

**THATZ DAISY** (T Bau) - Tightened near the 700 metres. Finished well back. A subsequent race veterinary found the mare to have pulled up in a normal post-race condition.

**J Chung** (PARTY ROCKING) - Issued with a warning for permitting his mount to shift inwards when not fully clear of MALMAISON, GET FUNKY and THATZ DAISY which were tightened near the 700 metres. Stewards took into account the tendency of PARTY ROCKING to lay inwards making the corner when assessing the interference.
