#### SUPPLEMENTARY

#### RACE COMMENTS

##### Race 1 | NEW ZEALAND HORSE AMBULANCE TRUST MAIDEN HURDLE 3100m

**HE ZED GO** (P Matthews) - Slow to begin. Jumped the first fence in the home straight on the first occasion awkwardly. Lost the near fore plate during the running.

**CANULOVEMEAGAIN** (J Parker) - Slow to begin. Hit the fence near the 1200 metres. Retired from the race when well back and out of contention after jumping poorly throughout.

**YOULEDO** (T Moki) - Jumped the fence near the 1000 metres awkwardly.

**ROCEM** (K Wiles) - Landed awkwardly at the second-last fence.

**MR FABULOUS** (J Kozaczek) - Finished well back. When questioned, rider was of the opinion the gelding was better suited to a more-roomier track.

**P Matthews** (HE ZED GO) - Spoken to regarding her whip use on a runner out of contention.

##### Race 2 | BIG BLADE HURDLE 3100m

**FOURTY EIGHT** (S Fannin) - Jumped the fence near the 900 metres on the first occasion awkwardly.

**GO BUTCH** (H McNeill) - Fell at the jump near the 900 metres. H McNeill was attended to by Paramedics and cleared to ride. Underwent a post-race veterinary examination which was clear.

**LORD SPENCER** (L Douglas) - Hampered by the fallen runner near the 900 metres, losing ground, and was subsequently retired from the event when well out of contention. Underwent a post-race veterinary examination which was clear.

**SHOCKING PENNY** (C Wiles) - Retired prior to entering the home straight when out of contention.

**J Parker** (LEITRIM LAD) - Spoken to regarding his whip action (shoulder height).

**N Downs** (ATA RANGI)- Spoken to regarding his whip action (shoulder height).

##### Race 3 | CLAYTON YAXLEY MAIDEN STEEPLECHASE 3900m

**ZEEFA ZED** (H McNeill) - Jumped the second fence awkwardly. Hampered 1200 metres.

**BROTHER MAX** (P Matthews) - Hit the fence near the 1200 metres on the final occasion, dislodging a panel, hampering the following runners, which were all placed at a disadvantage: MONITOR, FABULOUS NANCY, ZEEFA ZED and KHAFEEF with the rider being dislodged.

**MONITOR** (S Karnicnik) - Hampered 1200 metres, with the rider losing the use of his inside iron. Retired from the event prior to entering the home straight when well out of contention.

**FABULOUS NANCY** (L Douglas) - Hampered 1200 metres.

**KHAFEEF** (J Parker) - Hampered by the dislodged panel at the fence near the 1200 metres, dislodging the rider. A post-race veterinary examination was clear. J Parker was subsequently cleared by Paramedics.

**JOLLY MOLLY** (C Wiles) - Hampered 1200 metres.

**NO TEARS** (T Moki) - Finished well back after racing handy throughout and commenced to give ground from near the 800 metres. Underwent a post-race veterinary examination which was clear. Connections advised the gelding's future will be reassessed.

**Race 4** | **HEATHER D. YAXLEY-MARTINEZ STEEPLECHASE 3900m**

**TORQUE TIME** (J Kozaczek) - Jumped the fence near the 1000 metres on the first occasion awkwardly.

**LOCHWINNOCH** (H McNeill) - Hit the fence near the 900 metres.

**KEYBOARD WARRIOR** (S Karnicnik) - Retired prior to the last fence when well out of contention. Underwent a post-race veterinary examination which revealed lameness in the right hind. Connections were advised a veterinary clearance is required prior to **KEYBOARD WARRIOR** racing next. Trainer H Weller advised the gelding has now been retired.

**DAL KILCHOAN** (N Downs) - Shifted inwards after jumping the third-last fence, hampering **AFTERALLTHISTIME** prior to being straightened.

**AFTERALLTHISTIME** (D Parker) - Hampered after jumping the third-last fence.

**Race 5** | **FLAIR AMATEUR MAIDEN 2100m**

**KEEPZ OCCURRING** (C Rennie) - Dislodged the rider as the gates opened. Following the race, it was brought to the Stewards' attention by gate staff that the starting gates failed to open when the Starter initially activated the start system. Immediately on reactivating the start button the gates opened simultaneously and correctly. Stewards requested a ruling from the Adjudicative Committee which determined that **KEEPZ OCCURRING** had been denied a fair start due to a mechanical fault so was declared a non-runner. No other runner was affected by the occurrence. Rider C Rennie was uninjured.

**LEPREKHAN** (E Quinn) - Began awkwardly. Over-raced in the early stages when being hampered by the riderless horse ahead.

Gates were tested on several occasions prior to the next race, with no issues detected.

**Race 6** | **NORWOOD 2100m**

**BATTLE SECRET** (M Hashizume) - Began awkwardly and then raced keenly early.

**UP 'N' GONE** (C Butler) - Raced keenly in the early stages.

**A Riddell** (YOLO) - Shown footage of her use of the whip in the home straight in the presence of the Apprentice Mentor.

**Race 7** | **HOLDEM CONTRACTING MAIDEN 1200m**

The start of this race was delayed due to **MADAMKIPYEGON** escaping riderless prior to being late scratched by the Stewards.

**MADAMKIPYEGON** (A Mudhoo) - Late scratched by Stewards at 2.57pm. Connections were advised the filly is to trial prior to its next start.

**BLUE RATA WAREA** (C Butler) - Underwent a pre-race veterinary examination and was cleared to start after dislodging the rider and galloping a short distance during the preliminary. Lost the near hind plate during the running.

**WAZA DREAM** (T Davies) - Over-raced in the early stages.

**SHAWSHANK** (L Sutherland) - Rider dropped her whip shortly after entering the home straight.

**VIBRATION** (J Chung) - Raced greenly in the home straight and was inclined to shift out under pressure over the final stages.

**PERFECT PETE** (L Douglas) - Shifted outwards over the final stages

**GRIT** (K Hercock) - When questioned, rider was of the opinion the mare is now looking to step up over more ground.

**FULL TIME LASS** (M Hashizume) - When questioned into the run of FULL TIME LASS M Hashizume had no excuse. Trainer S Gordon advised Stewards the mare will be spelled.

**Race 8 HILAL@GRANGEWILLIAM STUD 1400m**

**HALF OF NOTHING** (M Sanson) - Slow to begin.

**FLEMING** (K Hercock) - Jumped awkwardly, making contact with its barrier stall. Over-raced in the early stages. Came together and bumped with SHEEZ DOMINANT (M Hashizume) on the home turn.

**SHEEZ DOMINANT** (M Hashizume) - Came together and bumped with FLEMING on the home turn with M Hashizume being spoken to by the Stewards regarding extending his arm when maintaining his balance.

**ICONIC LASS** (T Davies) - Not persevered with in the home straight. A subsequent veterinary examination revealed the mare to be lame in the right hind. Connections were advised a veterinary clearance is required prior to the mare's next start.

**Race 9 TARANAKI/WHANGANUI BREEDERS ASSOCIATION HANDICAP 1400m**

**MORE TO BE WRITTEN** (E Sole) - Began awkwardly crowding PASHAMALA.

**PASHAMALA** (K Kalychurun) - Crowded at the start, losing ground.

**SOTIRIO** (L Hemi) - Improved on to heels, having to be steadied near the 900 metres. Held up for some distance rounding the home turn, gaining clear running near the 300 metres.

**CARIGNAN** (L Sutherland) - Finished well back. When questioned rider could offer no excuse.

**Race 10 THE BOLD ONE@GRANGEWILLIAM STUD MAIDEN 1600m**

**PASSENGER** (K Chowdhoo) - Slow to begin. Steadied off heels approaching the 1200 metres. Shifted outwards under pressure over the concluding stages. K Chowdhoo was spoken to with regards his failure to take corrective action after his mount shifted outwards abruptly over the concluding stages.

**BOY** (K Hercock) - Slow to begin. Disappointed. Rider had no excuse.

**BELLE LAUREL** (J Chung) - Slow to begin.

**THE CARTEL** (C Grylls) - Over-raced in the early stages and had little left at the finish.

**CHICFLIX** (M Hashizume) - Finished some distance last and was not persevered with. A subsequent veterinary examination revealed evidence of a virus, with the Trainer to monitor the progress of CHICFLIX over coming days and report back to Stewards.
