Race 7 – Sweynesse Stakes

FARRAVALLO – Post race was found to be lame in the left fore and was subsequently treated. FARRAVALLO has now been sent for a spell.

RACE COMMENTS

Race 1 HAPPY HIRE 1400m

WINGMAN (C Grylls) - Slow to begin. Contacted and forced wider passing the 500 metres when SKIPPERS CANYON (K Hercock) shifted outwards. K Hercock was advised to exercise greater care when shifting ground.

MADAME SAIL (J Chung) - Raced three-wide without cover in the early stages. Contacted and forced wider on the track passing the 600 metres when WINGMAN (C Grylls) shifted outwards. C Grylls was advised to exercise greater care when shifting ground.

LIBRERO (R Goyaram) - Over-raced in the early stages. Held up for several strides passing the 200 metres.

SKIPPERS CANYON (K Hercock) - Had to be shifted outwards across heels near the 250 metres to find clear racing room.

HOLLYWOOD DRIFT (M Cartwright) - Steadied to avoid the heels of the runner in front passing the 500 metres. Not persevered with over the concluding stages when well beaten, with the rider advising the gelding was not comfortable in today's Heavy track conditions.

WIRE ROPE (K Myers) - K Myers had no tangible excuse for the disappointing performance of WIRE ROPE.

Race 2 HAPPY 70TH WARREN COLLETT 2400m

HILL OF KINGS (T Comignaghi) - Raced three-wide without cover for the majority of the event.

TRANZED (J Riddell) - Rider reported the gelding did not handle today's Heavy track conditions. A post-race veterinary examination was clear.

DAYMO (M Singh) - Lay outwards under pressure and shortly before the winning post made contact with LOSTCAUSE.

LOSTCAUSE (L Hemi) - Lay inwards over the concluding stages and was contacted and unbalanced just short of the winning.

Following the running of the race, connections of the second placed horse LOSTCAUSE, J-L Lupton, lodged a protest with the Adjudicative Committee alleging interference over the concluding stages by the first placed horse OUR DAYMO. After considering submissions the Adjudicative Committee upheld the protest. Placings are now: 1st LOSTCAUSE, 2nd OUR DAYMO.

M Singh (DAYMO) - Defended a charge in that he struck his mount DAYMO eight times prior to the 100-metre mark. After considering submissions and viewing replays the Adjudicative Committee found the charge proved and imposed a suspension of his licence to ride in races from the conclusion of racing on Sunday, 3 November, until the conclusion of racing on Sunday, 10 November, 5 national riding days.

Race 3 GRAHAM'S PAINTERS 900m

TOO SWEET (L Sutherland) - Jumped away awkwardly and made contact with the gate. Had some difficulty obtaining clear running early in the run home.

BELZONI (J Doyle) - Went off stride shortly after the start and was pulled up immediately by the rider and attended to by the veterinarian. A subsequent veterinary examination revealed no obvious abnormalities, with BELZONI being able to be led back to the stalls. Rider J Doyle advised that he believed the gelding to have locked a stifle at that point in the race and for safety reasons retired his mount from the race. Stewards will follow up with connections in coming days.

LANDLOCK (K Myers) - Rider reported the gelding had not handled today's Heavy track conditions.

Race 4 BILL TITO BOOK REPAIR SPECIALIST 1000m

PARTY ROCKING (J Chung) - Bounded at the start losing ground.

WRITTEN UP (C Lindsay) - Began awkwardly losing ground.

BELLA VOCE (W Pinn) - Shifted inwards at the start making firm contact with LEINSTER. Briefly held up passing the 100 metres.

LEINSTER (C Barnes) - Contacted at the start. Rider C Barnes reported the gelding did not handle today's Heavy track conditions.

GURTLYN (E Sole) - Began awkwardly losing ground.

PEPEHA (T Comignaghi) - Got its head up when being steadied off heels near the 800 metres. Rider reported the gelding did not handle today's Heavy track conditions.

S Walsh (JUS WING IT) - Fined \$50 under the Minor Infringement Schedule when presenting and racing her runner JUS WING IT without notified side winkers.

Race 5 WRC LIFE MEMBERS 1000m

KANA (M Hashizume) - Began awkwardly, shifting outwards, making contact with LINCOLN'S KRUZ.

LINCOLN'S KRUZ (K Myers) - Contacted at the start.

REIGN IT IN (J Chung) - Slow to begin. Raced keenly in the early stages

RUSTY LANE (A Riddell) - Near the 800 metres had to be steadied when awkwardly placed on the heels of LINCOLN'S KRUZ, which shifted ground at this point. K Myers was advised to exercise greater care.

MILLEFIORI (W Pinn) - Rider reported the mare had not handled today's Heavy track conditions.

Race 6 DAVID BUTLER MEMORIAL 1600m

OUTER FOCUS (R Elliot) - Slow to begin. Rider could offer no tangible excuse for the disappointing performance. Underwent a post-race veterinary examination which did not reveal any abnormalities.

JACKAROO (K Hercock) - Steadied away from heels passing the 1000 metres when racing keenly.

SOTIRIO (L Hemi) - Crowded and checked near the 250 metres when MEANDEEL (R Goyaram) shifted inwards.

MEANDEEL (R Goyaram) - Shifted inwards near the 250 metres, crowding and checking SOTIRIO.

R Goyaram (MEANDEEL) - Admitted a charge of careless riding in that he permitted MEANDEEL to shift inwards when not sufficiently clear of SOTIRIO, which was crowded and checked near the 250 metres. After considering

submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Tuesday, 5 November, until the conclusion of racing on Wednesday, 13 November, 6 national riding days.

Race 7 GEE & HICKTON FUNERAL DIRECTORS THOMPSON HANDICAP (G3) 1600m

Trainer C Cole (KIND THOUGHTS) - Admitted a breach of Rule 534(1) in that he scratched his runner without authorisation at 3.18pm, with the Adjudicative Committee imposing a fine of \$450.

DISS IS DRAMATIC (T Comignaghi) - Slow to begin. Lay inwards early in the run home making contact with COLORADO STAR before being straightened by the rider.

COLORADO STAR (J Chung) - Contacted and raced in restricted room near the 350 metres.

LIFFEY (K Hercock) - Slow to begin.

MAKE TIME (C Barnes) - Slow to begin.

HE'S A DOOZY (M Hashizume) - Over-raced in the early stages.

SPENCER (J Doyle) - Rider reported the gelding did not see out the distance of today's race.

Race 8 JOHNATHAN PARKES MEMORIAL 1400m

There was a delay to the start of this race due to ENRICO requiring farrier intention at the start area.

SHELBYROCK'N (E Sole) - Shifted out abruptly at the start crowding outside runners.

FLYING CELEBRATION (J Chung) - Crowded at the start losing ground when runners either side shifted.

BELLADONNA LILY (C Barnes) - Slow to begin. Shifted ground inwards under pressure over the concluding stages.

MAZZUCATO (W Pinn) - Crowded at the start losing some ground. Rider could offer no tangible excuse for the disappointing performance.

WHANGAEHU (C Butler) - Slow to begin.

LANTERN WAY (J Riddell) - Rider could offer no tangible excuse.
