#### **RACE COMMENTS**

### Race 1 MAINFREIGHT 1100

TARTAN VIBES (T Newman) – Crowded shortly after the start losing ground. Raced keenly in the early stages.

NO AGENDA NIGEL (B Rogerson) - Slow to begin.

**SALTNESSE** (M Hashizume) - Raced in restricted room to the inside of MONIQUE TONNERRE just prior to the finish line.

**MONIQUE TONNERRE** (J Fawcett) – When questioned regarding the improved performance Trainer S Ralph advised that the mare appreciated racing in a freshened state and being ridden in a positive manner.

Following this race the track was downgraded to Soft 6.

## Race 2 NOTTINGHAM CASTLE HOTEL MAIDEN 2200

**ZEDZOOM** (N Hailey) – Began awkwardly losing ground. Made the bend near the 1900 metres awkwardly shifting outwards forcing WHOSHE'S BOY onto the heels of LORD GOLIATH.

LI LI (M Cartwright) - Crowded shortly after the start losing ground.

WRY SMILE (S Spratt) - Began awkwardly losing ground.

**LA GRANGE** (M Sanson) - Began awkwardly losing ground. Over-raced in the early stages and had to be firmly restrained off heels passing the 1400 metres.

LORD GOLIATH (W Kennedy) - Began awkwardly then crowded shortly after having to be steadied.

**WHOSHE'S BOY** (V Jalalkuncha) - Had to be firmly restrained after being forced onto heels near the 1900 metres. Underwent a post-race veterinary examination which revealed a small laceration to the left hind tendon.

**TIFFANEE** (D Danis) – Raced wide in the early stages. When questioned regarding the performance rider advised that the mare failed to handle today's track conditions.

BARREL (K Myers) - Held up for clear running early in the final straight.

THE YES GIRL (T Newman) - Crowded having to be steadied near the 300 metres.

M Sanson (LA GRANGE) - Issued with a warning for her whip use on a runner out of contention.

Following this race the track was downgraded to Soft 7.

#### Race 3 DONAGHYS PRO-DAIRY MAIDEN 1400

JOEJOECCINI (C Barnes) - Slow to begin.

VADASHA (G Rooke) - Began awkwardly losing ground.

**TUXEDO** (J Doyle) – Raced keenly in the early stages. Lay outwards when placed under pressure over the concluding stages.

THINK I GOT CHA (L Satherley) – Steadied off heels when racing keenly approaching the 500 metres.

**ON THE TOWN** (M Cartwright) – When questioned regarding the performance rider advised that the gelding failed to handle today's heavy track conditions.

**M Cartwright** (ON THE TOWN) – Reminded of his obligations to ride his mounts out fully to the end of the race when circumstances permit.

#### Race 4 DONAGHYS TASMAN TIM MAIDEN 1400

**MAGEE** (L Satherley) - Underwent a pre-race veterinary examination after being kicked by another runner behind the barriers and was declared a late scratching on veterinary advice at 2.31 pm.

**EIGHT PENCE** (T Mitchell) – Crowded shortly after the start losing ground.

ROCK NO WAR (M Hashizume) - Began awkwardly losing ground.

GOLD CURRENCY (J Fawcett) - Raced keenly in the early stages. Briefly contacted approaching the 350 metres.

**SABIK** (S Spratt) - Lay outwards when placed under pressure making brief contact with GOLD CURRENCY approaching the 350 metres having to be corrected by its rider.

Connections of the second placed horse GOLD CURRENCY viewed Stewards footage of the final straight before electing not to proceed with a protest against SABIK.

### Race 5 DONAGHYS UDDERMAX MAIDEN 1200

**CHARLES** (B Jacobson) - Slow to begin. Tailed off through the early and middle stages despite the urgings of its rider and finished a distant last. When questioned regarding the performance rider advised that the gelding failed to handle today's heavy track conditions. Underwent a post-race veterinary examination which revealed no abnormalities. Connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

HANKEE ALPHA (L Satherley) - Crowded shortly after the start losing ground.

LOVE SYMBOL (W Kennedy) - Raced keenly for a distance when being restrained in the early stages.

**VIVA GLAM** (J Doyle) - When questioned regarding the performance rider advised that the filly failed to handle today's heavy track conditions.

#### Race 6 NZB MEGA MAIDEN SERIES MAIDEN 1200

FURY'S DAUGHTER (D Danis) - Began awkwardly losing ground.

GOLD CARD (J Doyle) - Began awkwardly then crowded shortly after losing ground.

SKIPPING (G Rooke) - Slow to begin.

TRANSATLANTIC (M Hashizume) - Raced keenly for a distance passing the 800 metres.

**BUENA NOCHE** (A Lawson-Carroll) – Hung outwards in the final straight with the mare being unable to be fully tested by its rider.

**K Pertab** (BRILLIANT BATTLE) - Admitted a charge in that he failed to scratch BRILLIANT BATTLE by the required time. After considering submissions the Adjudicator imposed a fine of \$150.

#### Race 7 DONAGHYS N-BOOST MAIDEN 1200

**CELTIC BLING** (V Colgan) - Crowded shortly after the start losing ground.

BY HER RULES (K Myers) - Began awkwardly shifting outwards making contact with CELTIC BLING.

MISS FLOWER (B Jacobson) - Slow to begin.

BASEL WARRIOR (C Barnes) - Contacted shortly after the start losing ground.

**TRUE PROMISE** (G Rooke) - Following the running of this race the rider of the ninth placed runner TRUE PROMISE was unable to draw the proper weight being 0.6 kgs under the weight allocated by the handicapper. A Request for a Ruling was filed with the Adjudicator and after hearing submissions TRUE PROMISE was disqualified from ninth place. In addition, under the provisions of [Rule 537(2)], G Rooke's riding fee was forfeited.

**G Rooke** (TRUE PROMISE) - Issued with a Minor Infringement and fined \$300 after weighing in 0.6 kgs under the weight at which he weighed out at.

Following the running of this race V Colgan was stood down from his remaining ride. V Colgan is to provide a medical clearance prior to riding next.

## Race 8 DONAGHYS BUTCH COOMBE MEMORIAL CUP 1400

**POLAMALU** (M Cartwright) - Slow to begin. When questioned regarding the improved performance Trainer N Bishara advised that the gelding appreciated being freshened since its last run and the drop back in distance.

WHOSHE'S GIRL (V Jalalkuncha) - Slow to begin.

**HUZZAH** (M Hashizume) - When questioned regarding the performance rider advised that the gelding failed to handle today's heavy track conditions. Underwent a post-race veterinary examination which revealed no abnormalities.

K Stott (BLONDIE) - Spoken to advisedly with regards to his whip use in the final straight.

#### Race 9 ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1400

**ALMANDA** (W Kennedy) - Began awkwardly losing ground. Gave ground from the 600 metres. When questioned regarding the performance rider could offer no explanation.

**SWEET AND SASSY** (T Newman) - Raced keenly through the early and middle stages. Had to be steadied when forced wider on the track near the 350 metres.

LADYLOU (C Grylls) - Had to be steadied when forced wider on the track near the 350 metres.

**MISS UNDERSTOOD** (K Myers) - Raced greenly throughout the final straight despite the efforts of its rider inconveniencing several runners to varying degrees.

VADANOVA (M Hashizume) - Improved onto heels having to be steadied near the 200 metres.

**PRIVATE TREATY** (J Fawcett) - Inconvenienced near the 100 metres having to be steadied when MISS UNDERSTOOD was laying outwards.

**REIMAGINED** (M Cartwright) - Inconvenienced near the 100 metres having to be steadied when MISS UNDERSTOOD was laying outwards.

Connections of the fourth placed horse VADANOVA viewed Stewards footage of the final straight before electing not to proceed with a protest against MISS UNDERSTOOD.
