Race 1 - VALE TOM FRASER FJC LIFE MEMBER MAIDEN 1600m

TOWROPE (H Grace) - Trainer Mr. W Thurlow reported to Stewards he was satisfied with the post-race condition of the gelding however TOWROPE has now been sent for a spell.

RACE COMMENTS

Race 1 LA NUOVA TWILIGHT FIESTA 22ND NOVEMBER MAIDEN 2000m

LAZY (L Hemi) - Shifted ground outwards on jumping hampering UNUSUAL PROSPECT.

UNUSUAL PROSPECT (J Doyle) - Hampered on jumping losing ground. Held up for clear running until near the 200 metres.

JAMAICA FAREWELL (T Newman) - Began awkwardly making contact with UNUSUAL PROSPECT. Rider reported that the mare had raced greenly under pressure in the straight.

BELLE LAUREL (E Sole) - Slow to begin.

JUST LOOKING (T Davies) - Slow to begin then further hampered by MILANESE which shifted outwards shortly after the start. Lay inwards in the straight and was unable to be fully ridden out.

MOLASSES (L Sutherland) - Raced ungenerously when being restrained in the early stages and over racing through the middle stages. Raced three wide without cover throughout.

MILANESE (G Rooke) - Shifted outwards on jumping hampering JUST LOOKING. Rider dropped his whip passing the 300 metres.

DOJAKATA (K Stott) - Lost the left hind plate leaving the barriers.

K Stott (DOJAKATA) - Issued with a warning after striking his mount DOJAKATA in two consecutive strides approaching the 50 metre mark, with Stewards taking into account his clear recent record with regard to any breach of a whip rule.

The track was downgraded to Soft 7 retrospective to Race 1.

Race 2 PENINSULAR BEACHFRONT RESORT MAIDEN 1200m

SESIMBRA (A Lawson-Carroll) - Jumped away awkwardly making contact with OUR TIME.

OUR TIME (L Sutherland) - Contacted start. Had to be steadied and shift outwards to avoid the heels of JUSTADUDE when that runner was giving ground quickly near the 450 metres. Lay out rounding the final turn. Was reported to be coughing post-race with a slow recovery undergoing an endoscopic examination which was clear. Stewards will follow up in coming days.

OW CELEREESE (K Chowdhoory) - Slow to begin.

MAFIA WHISPERS (J Fawcett) - Raced keenly in the lead through the early and middle stages.

JUSTADUDE (G Rooke) - Checked passing the 550 metres losing ground then failed to recover dropping out to finish a distant last. A post-race veterinary inspection did not reveal any significant abnormality other than a superficial wound to the right hind coronet.

A Lawson-Carroll (SESIMBRA) - Admitted a charge of careless riding in that he permitted his mount SESIMBRA to shift outwards when not sufficiently clear of JUSTADUDE which was checked passing the 550 metres. After considering submissions the Adjudicator imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Saturday 16 November until the conclusion of racing on Saturday 23 November, 5 national riding days.

Race 3 XMAS AT THE RACES FRIDAY 5TH DECEMBER MAIDEN 1400m

I PARK (A Lawson-Carroll) - Slow away. Ducked outwards abruptly then when being corrected shifted back inwards abruptly unbalancing the rider who was dislodged near the 1200 metres. A Lawson-Carroll was attended to by St Johns ambulance personnel and found to be uninjured. A post-race veterinary inspection did not reveal any obvious abnormality.

TOR MENT TOR (K Kalychurun) - Began awkwardly losing ground. Raced keenly in the early stages.

KAPALUA (L Sutherland) - Raced keenly in the early stages. Checked passing the 300 metres.

COTTON ROCA (K Chowdhoory) - Raced three wide without cover.

MERCHANT BANKER (C Butler) - Inclined to lay inwards passing the 100 metres.

C Barnes (PALMAROW) - Admitted a charge of careless riding in that she permitted her mount PALMAROW to shift outwards when not clear of KAPALUA which was checked near the 300 metres. After considering submissions the Adjudicator imposed a suspension of C Barnes' licence to ride in races from the conclusion of racing on Saturday 16 November until the conclusion of racing on Friday 22 November, 4 national riding days.

Race 4 THE NATION BAR FRIDAY 27TH DECEMBER 2024 1400m

BELLEZOR (C Barnes) - Slow to begin.

SUPER WRAITH (L Sutherland) - Restrained from a wide barrier to obtain cover.

RUA ROCKS (E Sole) - Raced three wide without cover throughout.

KAKADU (J Fawcett) - Failed to respond once placed under pressure in the straight dropping out to finish last. When questioned regarding performance, rider was of the opinion the gelding had not been suited to today's track condition returning from a spell. A post-race veterinary inspection did not reveal any obvious abnormality.

CALEDONIE (C Butler) - Had to be steadied off heels passing the 100 metres.

Race 5 GRANGEWILLIAM STUD MAIDEN 1400m

BLUE RATA WAREA (R Elliot) - Jumped away awkwardly contacting ASTUCIA.

ASTUCIA (L Hemi) - Contacted at the start losing ground.

BAK DA ANGEL (C Barnes) - Raced greenly passing the 1000 metres.

MORYANA (A Lawson-Carroll) - Had to be steadied near the 1000 metres when BAK DA ANGEL was racing greenly.

GILLIAN (J Fawcett) - Had to be steadied when placed in restricted room passing the 400 metres to the inside of FUGAZI which was dictated inwards by SIDE PIECE (K Stott). After questioning riders and viewing films, it was determined that SIDE PIECE which had improved onto the heels of BOLT then had to shift inwards to avoid that runner's heels when BOLT lay inwards when weakening.

Race 6 ENTAIN/NZB INSURANCE PEARL SERIES 1800m

The start was delayed approximately 3 minutes after **N** Hailey changed from incorrect colours at the barriers, and **PRIVY GARDEN** which became fractious in its stall was removed to undergo a veterinary inspection before being passed fit to race. N Hailey was spoken to by Stewards and reprimanded.

COURT OF APPEAL (K Stott) - Slow to begin.

BALLROOM BLITZ (C Butler) - Raced keenly throughout. Raced ungenerously rounding the first bend contacting MODERNISE.

MODERNISE (T Newman) - Contacted rounding the first bend. Came under pressure approaching the 600 metres and failed to respond. Rider advised that the mare had been making abnormal breathing noises. A post-race veterinary inspection did not reveal any obvious abnormality. Trainer R McCarroll indicated the mare will now be retired from racing.

PRIVY GARDEN (G Rooke) - Improved onto heels having to be steadied passing the 600 metres.

UNUSUALLY PETITE (J Doyle) - When attempting to improve to the outside of O'RIORDAN raced greenly and lay inwards becoming awkwardly placed on that runner's heels having to be checked passing the 400 metres.

Race 7 THE NED FASHION QUALIFIER 14TH FEBRUARY MAIDEN 1600m

R Patterson (FREEBELLE) - Fined \$100 under the Minor Infringement Schedule after presenting the mare with unnotified gear (pre-race ear covers).

FREEBELLE (L Douglas) - The start was delayed approximately 12 minutes after FREEBELLE dislodged its rider then escaped from the Clerk of the Course enroute to the barriers, galloping for some distance before running through the running rail which required repair involving a replacement section of rail. FREEBELLE was declared a late scratching at 4:35pm on veterinary advice.

MASAKO (K Kalychurun) - Slow to begin losing ground. Underwent a post-race veterinary inspection after blood was observed in its mouth and was found to have a small wound from bitting its tongue.

TAUPO DANCER (N Hailey) - Slow to begin.

SWEET ENVY (K Stott) - Jumped away awkwardly contacting HI YO LEGACY.

HI YO LEGACY (G Rooke) - Contacted at the start losing ground.
