Race 7 WINDSOR PARK STUD SOLILOQUY STAKES 1400m (G2)

ARCHAIC SMILE (R Elliot) – Trainer T Pike reported to Stewards that on Monday 28 October, ARCHAIC SMILE, underwent a veterinarian examination with no abnormalities being detected. T Pike further advised ARCHAIC SMILE has been sent for a short spell and will look to resume racing early next year.

Race 2 ALL THE NEWS @ TRACKSIDE.CO.NZ 2400m

HOOTIE JOHNSON (T Newman) – Trainer S Manning reported to Stewards he was satisfied with the post-race condition of the gelding, however, HOOTIE JOHNSON has now been sent for a spell.

RACE COMMENTS

Race 1 SKYCITY HAMILTON WAIKATO CUP DAY 14 DEC 2200

FASHIONISTA (C Barnes) - Slow to begin (5L). Connections were advised that a warning would be placed against the mare's barrier manners.

VERISMO (S Weatherley) - Slow to begin.

RAVENNA ROSE (C Butler) – Raced keenly through the early and middle stages. When questioned regarding the performance the rider could offer no excuse.

NAKAMOTO (L Satherley) - Lost the near hind plate during the running. Rider reported that the mare had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which found the mare to have experienced an episode of bilateral Epistaxis. NAKAMOTO shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian. Trainer R Liefting advised that the mare would now be retired.

Race 2 IMPACT OFF ROAD 1400

BOXMOSS (W Kennedy) - Slow to begin. When questioned regarding the performance the rider advised that the gelding had travelled comfortably enough throughout however had failed to respond when placed under pressure. Underwent a post-race veterinary examination which did not reveal any abnormality.

JETHRO TULL (J Fawcett) - Knuckled on jumping away.

KASUKEDO (L Satherley) – Began awkwardly. Lay inwards near the 700 metres contacting FORCE OF NATURE.

STIPULATOR (B Jacobson) – Raced keenly through the early and middle stages when leading.

ALL SHOOK UP (T Newman) - Crowded shortly after the start losing ground.

FORCE OF NATURE (G Rooke) – Contacted near the 700 metres.

Following this race the track was upgraded to Good 4.

Race 3 HALLMARK STUD 2YO 1100

DO YOU JUST (M Hashizume) - Slow to begin. Steadied when placed in restricted room passing the 600 metres.

THAT'S GOLD (A Lawson-Carroll) - Began awkwardly then restrained to obtain cover in the early stages from an outside barrier. Improved onto heels passing the 800 metres having to be firmly restrained.

ROMANOFF (D Mansour) - Raced keenly in the early stages then made the bend near the 800 metres awkwardly and continued to over-race through the middle stages. Rider dropped his whip passing the 50 metres.

LA DORADA (V Colgan) - Raced three wide without cover for the majority of the race.

CURZON PARK (J Fawcett) - Steadied when placed in restricted room approaching the 250 metres. Inconvenienced just prior to the winning post when racing to the outside of PRINCESS ELSA which shifted out slightly. G Rooke was advised to exercise care.

PRINCESS ELSA (G Rooke) - Shied away from the running rail approaching the 100 metres and went off stride, losing momentum. Underwent a post-race veterinary examination which found the filly to be suffering from heat stress which was treated.

Race 4 MAVEN WAIKATO 1300

KEEGAN (C Barnes) - Restrained to obtain cover in the early stages from the outside barrier.

ZA SPIRIT (T Newman) – Raced keenly in the early stages.

REPUTATION (J Nishizuka) – Lay out rounding the final bend forcing OUR ABSOLUTE wider on the track. Continued to lay out when placed under pressure in the final straight.

OUR ABSOLUTE (L Satherley) - Forced wider on the track rounding the final bend.

ETHEREAL STAR (D Mansour) - Held up rounding the final bend and early in the straight. When questioned regarding the performance the rider advised that the mare had presented in a fresh state and was of the opinion that it would derive benefit from today's race.

CANDLE (V Colgan) - When questioned regarding the performance the rider advised that the mare had failed to respond when placed under pressure. Underwent a post-race veterinary examination which revealed a minor laceration on the left hind fetlock.

Race 5 MAJESTIC HORSE FLOATS 1200

ALFRISTON (M Hashizume) - Slow to begin.

MOET DOWN (J Nishizuka) - Held up rounding the final bend before shifting outwards near the 400 metres making contact with MONIQUE TONNERRE.

MONIQUE TONNERRE (T Newman) – Contacted near the 400 metres.

Race 6 LEGACY LODGE SPRINT 1200 (Listed Race)

UDERZO (A Lawson-Carroll) - Began awkwardly losing ground. Raced keenly in the early stages. Had to shift outwards early in the final straight to obtain clear running.

PROVENCE (C Barnes) - Restrained to obtain cover in the early stages from the outside barrier.

CHURCHILLIAN (G Rooke) – Raced three wide without cover throughout.

SHORT SHORTS (L Satherley) - When questioned regarding the performance the rider advised that in her opinion the mare would derive benefit from today's run and would be better suited to the right-handed way of going. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 7 FRESH CHOICE LEAMINGTON MAIDEN 3YO 1600

CLEW BAY (S Weatherley) - Knuckled leaving the barriers, losing ground. Improved onto heels passing the 50 metres having to be briefly steadied. When questioned regarding the performance the rider advised that after beginning poorly the filly had settled further back than intended adding that it had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which did not reveal any abnormality.

VENDABELLE (L Satherley) - Slow to begin.

DUBAI GOLD (J Nishizuka) – Raced keenly through the middle stages.

WYNDSONG (T Newman) - Held up rounding the final bend.

Race 8 FLAIR'S FINAL FLING 1600

RAGAMUFFIN (B Jacobson) – Slow to begin. Raced wide without cover throughout.

SIDE EYE (J Nishizuka) - Slow to begin.

COLORADO SILVER (A Lawson-Carroll) – Raced wide without cover throughout.

CHANNEL SURFER (L Satherley) - Held up for a distance passing the 300 metres.

APACHE ANNE (C Barnes) – Had some difficulty obtaining clear running early in the final straight.

QALI AL FARRASHA (A Riddell) - Lay outwards when placed under pressure in the final straight.

LIVID SKY (S Weatherley) - Lay outwards when placed under pressure in the final straight. Forced wider approaching the 200 metres by QALI AL FARRASHA which lay out when placed under pressure. When questioned regarding the performance the rider advised that the mare had settled further back than intended adding that he had been disappointed in the performance.

R Patterson (RAGAMUFFIN) - Issued with a Minor Infringement and fined \$50 for failing to declare a rider for RAGAMUFFIN by the required time.
