| <b>Race 1</b>  | <b>WOBURN FARM MAIDEN 1150</b> |
| There was a delay to the start of this race due to PROBOY being fractious. |                                |

**PROBOY** (B Jacobson) - Late scratched on veterinary advice at 12.43 pm after becoming fractious in the barrier. Connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**LOVE SYMBOL** (W Kennedy) – Began awkwardly. Lay outwards when placed under pressure over the concluding stages.

**APPROACHING** (G Rooke) - Underwent a pre-race veterinary examination at the barriers due to the horse in the next barrier stall being fractious and was cleared to start. Slow to begin then ridden with urgency to recover.

**WILLYDOIT** (M Hashizume) - Restrained to obtain cover in the early stages after jumping from the outside barrier.

**RIBKRAKA** (K Stott) – Lay outwards when placed under pressure over the concluding stages.

Following this race the track was upgraded to Good 4.

**MY FAITH** (C Barnes) - Began awkwardly then restrained to obtain cover from the outside barrier.

**BREGO** (S Weatherley) - Slow to begin. Raced keenly in the early stages.

**MASSARI** (M Hashizume) - Slow to begin.

**VENETIAN** (W Kennedy) – Slow to begin. Shifted across heels to obtain clear running near the 200 metres.

**LITTERAL** (S Spratt) – Raced three wide without cover throughout.

**KARYON** (B Rogerson) – Over-raced in the early stages.

**CLEAR CONSCIENCE** (M Cartwright) - Had difficulty obtaining clear running for the majority of the final straight then crowded for room near the 75 metres having to be steadied.

**L Noble** (VENETIAN) – Issued with a Minor Infringement and fined \$50 after failing to declare gear (blinkers) for VENETIAN by the required time.

**CITY OF ANGELS** (C Barnes) - Slow to begin.

**SHE'S ALL THAT** (M Hashizume) – Contacted leaving the barriers. Lay inwards when placed under pressure in the final straight.

**EMBOSSSED** (S Spratt) - Jumped inwards at the start making contact with SHE'S ALL THAT.

**INSTINCT** (J Doyle) - Over-raced in the early stages.

**MIRIAM** (C Grylls) – Raced three wide without cover throughout.

**VOUNTEER** (G Rooke) - Had to be steadied off heels near the 900 metres.

**VIENI SU** (W Kennedy) - Raced greenly and went off stride just prior to the finish line.

| <b>Race 4</b>   | <b>OHUKIA LODGE MAIDEN 1100</b> |
| <p><b>MIVIRGO</b> (S Spratt) - Reared as the start was effected, losing considerable ground. Connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p><b>NASHA MALA</b> (S Weatherley) - Slow to begin.</p> <p><b>SMASHING SISTER</b> (C Grylls) - Restrained to obtain cover in the early stages after jumping from the outside barrier.</p> <p><b>OFFLINE</b> (J Nishizuka) - Began awkwardly.</p> <p><b>ADLERIAN</b> (M Sanson) - Began awkwardly. Raced wide throughout.</p> <p><b>HIGHGRASS</b> (G Rooke) – Raced three wide without cover throughout.</p> <p><b>THE FELON</b> (L Satherley) - Improved onto the heels of a weakening runner having to shift ground outwards over the concluding stages.</p> <p><b>TIME WILL TELL</b> (M Cartwright) - Lay outwards when placed under pressure passing the 200 metres.</p> <p><b>MY SHARONA</b> (M Hashizume) - Raced in restricted room when improving to the inside of SKY DO passing the 50 metres.</p> <p><b>JOYSTAR</b> (C Barnes) - Finished a distant last. When questioned, rider advised that the mare never travelled throughout the running. Underwent a post-race veterinary examination which revealed no abnormalities.</p>  |                                 |
| <b>Race 5</b>   | <b>REGAL FARM 2200</b>          |
| <p><b>BECAUSE</b> (M McNab) - Slow to begin. Held up before shifting ground inwards to obtain clear running near the 200 metres.</p> <p><b>WRY SMILE</b> (S Spratt) - Raced keenly through the early and middle stages.</p> <p><b>EMBER ATTACK</b> (R Elliot) - Attempted to improve into a marginal run which diminished when TURNAROUND (G Rooke) lay outwards when placed under pressure with contribution from an outside runner in WRY SMILE (S Spratt) which lay inwards passing the 400 metres. As a result, EMBER ATTACK had to be steadied before shifting ground inwards to obtain clear running. Riders G Rooke and S Spratt were advised to exercise greater care in similar circumstances.</p> <p><b>CHILLI CON KHAN</b> (N Parmar) - Had to be steadied when placed in restricted room to the inside of WRY SMILE which lay inwards under pressure passing the 400 metres.</p> <p><b>BARREL</b> (K Myers) - Lay outwards when placed under pressure inconveniencing THE STORYTELLER which had to be steadied passing the 300 metres.</p> <p><b>THE STORYTELLER</b> (M Cartwright) – Inconvenienced passing the 300 metres.</p> <p><b>CAMACHO</b> (L Satherley) – Lay inwards when placed under pressure passing the 300 metres.</p> <p><b>M Cartwright</b> (THE STORYTELLER) - Issued with a warning for leaving the course without the permission of Stewards.</p> |                                 |

| <p><b>EMMY DAZZLER</b> (W Kennedy) - Restrained to obtain cover in the early stages after jumping from the outside barrier.</p>   |                                 |

**EIGHT LUCKY PRAWNS** (S Weatherley) - Held up for clear running until near the 200 metres.

**CUPID'S ARROW** (M Hashizume) – When questioned regarding the performance rider advised that the mare was unable to make up ground from its rearward position on a slow tempo. He added that in his opinion the mare would appreciate a track with more give.

**Race 7** | **RIVERSLEY PARK MAIDEN 1400**

**JOEJOECCINI** (J Doyle) - Slow to begin.

**STAPHEE** (S Weatherley) - Began awkwardly losing ground. Clipped the heel of ALAVISTO and fell dislodging its rider near the 350 metres. Rider S Weatherley was attended to by St John Ambulance personnel and cleared to ride. STAPHEE - Underwent a post-race veterinary examination which found the gelding to be 3/5 lame in the left foreleg. Connections were advised that a veterinary clearance is required prior to racing next.

**EKSTATIQUE** (M Sanson) – Raced three wide without cover throughout.

**GOLDEN CENTURY** (R Elliot) - Held up for clear running early in the final straight.

**JUNGLELAND** (M Hashizume) - Inconvenienced passing the 350 metres as a result of the fallen runner.

**K Stott** (ALAVISTO) - Defended a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of STAPHEE which clipped a heel and fell dislodging its rider near the 350 metres. Due to K Stott's travel commitments to Christchurch, the hearing was adjourned by the Adjudicator pending a date to be set by RIB Executive Officer.

**Race 8** | **PRIMA PARK MAIDEN 1400**

**PERSPECTIVE** (S Weatherley) - Underwent a pre-race veterinary examination at the barriers and was cleared to start.

**SAINT TROPEZ** (R Elliot) - Slow to begin. Gave ground rounding the final bend and finished last. When questioned regarding performance the rider could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormalities.

**FINAL IMPACT** (D Mansour) - Slow to begin.

**CHAMBRAY** (M McNab) - Began awkwardly losing ground.

**ALICANTE** (S Spratt) – Raced three wide without cover throughout.
