Inconvenienced near the 500 metres when MALFY ROSA lay outwards.</p> <p>KOYAMA (L Hemi) - Slow to begin.</p> <p>SHEAF (T Comignaghi) - Raced three wide without cover until near the 1800 metres. Shifted inwards when struck with the whip passing the 300 metres having to be straightened. When questioned regarding performance, rider advised that the mare had tended to over race early and was of the opinion it had not backed up after its first day run.</p> <p>TITICACA (K Myers) - Was inclined to shift ground under pressure in the straight.</p> <p>MAHOE (K Stott) - Finished a distant last. When questioned regarding performance, rider advised that the gelding was feeling the effects of recent racing and was not comfortable in today's softer track conditions. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.</p>

<p>LADY BANKSIDE (D Cooper) - Shifted outwards at the start crowding outside runners.</p> <p>MOGUL (J Doyle) - Began awkwardly making contact with SASSMAN then was further hampered losing ground when LADY BANKSIDE shifted outwards.</p> <p>FULL MOON FEVER (D Tait) - Jumped away awkwardly unbalancing its rider.</p> <p>FOREVER BABE (K Stott) - Slow to begin then crowded and checked shortly afterwards when YARI shifted outwards.</p> <p>I AM ROMAN (S Weatherley) - Lay inwards throughout the run home.</p> <p>GRAND CRU (A Balloo) - Briefly steadied when becoming awkwardly placed near the heels of I AM ROMAN near the 400 metres.</p> <p>TEXAS DOLLY (M McNab) - Shifted ground inwards under pressure over the concluding stages.</p> <p>DANCING DREAM (K Myers) - When questioned regarding performance, rider was of the opinion the mare may have been feeling the effects of recent racing and may not have been entirely comfortable in today's track conditions.</p> <p>M McNab (TEXAS DOLLY) - Issued with a warning after making a celebratory gesture prior to the finish.</p>

<p>STREET FIGHTIN MAN (A Balloo) - Slipped leaving the birdcage dislodging its rider and escaped riderless for a short distance. A Balloo was uninjured. STREET FIGHTIN MAN underwent a veterinary inspection and was cleared to race. As a result this race ran approximately three minutes late.</p> <p>TAP 'N' GO (C Barnes) - Reared at the start losing ground.</p> <p>MASTER MARKO (Y Atchamah) - Jumped away awkwardly.</p> <p>THE GOOD SHEPHERD (L Callaway) - Over raced when being restrained in the middle stages.</p> <p>A Balloo (STREET FIGHTIN MAN) - Admitted a charge in that he struck his mount STREET FIGHTIN MAN 9 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of A Balloo's</p>	

licence to ride in races from the conclusion of racing on Thursday 28 November until the conclusion of racing on Saturday 7 December, 7 national riding days.

Race 5 | **FRANTIC BLOODSTOCK PREMIER 1400m**

BELLUTTA (R Muniandy) - Slow to begin.

BUGATTI (K Mudhoo) - Slow to begin.

THE IMMIGRANT (S Weatherley) - Crowded shortly after the start losing ground when inside runners shifted out.

STOP YELLING (L Callaway) - Over raced in the early stages.

VOICE OVER (Y Atchamah) - Under pressure turning for home eventually finishing a distant last. When questioned, rider advised that the gelding failed to handle today's track conditions.

Race 6 | **BARNESWOOD FARM 52ND NEW ZEALAND 1000 GUINEAS G1 1600m**

SKYMAX (B Rogerson) - Slow to begin.

RAZIAH (M McNab) - Began awkwardly shifting outwards having to be straightened by its rider.

KITTY FLASH (C Grylls) - Shifted outwards across the heels of ALABAMA LASS near the 1200 metres resulting in LOVE POEM having to be steadied away from heels. Crowded and checked having to steady near the 300 metres.

CONNELLO (T Comignaghi) - Over raced in the early stages. Hampered when contacted near the 300 metres.

LOVE POEM (M Cartwright) - Had to be restrained for a distance to avoid the heels of KITTY FLASH near the 1200 metres.

KITTY FLASH (C Grylls) - Checked near the 300 metres.

COSTAE (R Elliot) - Returned to the enclosure with blood present in the right nostril which following a veterinary inspection was found to be from a small nasal laceration.

C Grylls (KITTY FLASH) - Admitted a charge of careless riding in that he angled his mount KITTY FLASH outwards when not sufficiently clear of LOVE POEM with that runner having to be restrained to avoid heels near the 1200 metres. After considering submissions the Adjudicative Committee imposed a suspension of C Grylls' licence to ride in races from the conclusion of racing on Tuesday 19 November until the conclusion of racing on Thursday 28 November, 6 national riding days.

M Cartwright (LOVE POEM) - Admitted a charge of careless riding in that he permitted his mount LOVE POEM to shift outwards when not sufficiently clear of KITTY FLASH which was checked near the 300 metres making contact with CONNELLO which was hampered as a result. After considering submissions the Adjudicative Committee imposed a suspension of M Cartwright's licence to ride in races from the conclusion of racing on Saturday 23 November until the conclusion of racing on Thursday 5 December, 8 national riding days, and in addition imposed a fine of \$650.

Race 7 | **JENNY LAMING MEMORIAL PREMIER 1200m**

BELLO MIO (C Grylls) - Slow to begin before being further hampered when crowded losing ground. Held up near the 400 metres then having some difficulty obtaining clear running until near the 250 metres.

SYMPATHIQUE (S Wynne) - Slow to begin.

ZOULANDER (L Sutherland) - Slow to begin.

INSATIABLE (L Riordan) - Jumped in the air at the start.

MALMAISON (J Parr) - Jumped away awkwardly.

TENGIZ (K Hercock) - Over raced in the early to middle stages. Crowded and dictated outwards passing the 900 metres. Required post-race veterinary attention for a severe laceration to the right hind flexor tendon being transferred by the horse ambulance to a local veterinary clinic for further treatment.

MAGNETO (J Doyle) - Crowded and checked passing the 900 metres.

RUSSIAN ROSETTE (B Rogerson) - Held up near the 400 metres and did not obtain clear running until near the 200 metres.

BUOYANT (M McNab) - Lay inwards early in the run home and near the 300 metres made contact with BELLO MIO having to be straightened.

D Cooper (GEMMA FLITZ) - Admitted a charge of careless riding in that he permitted his mount GEMMA FLITZ to shift outwards passing the 900 metres dictating TENGIZ outwards onto MAGNETO which was checked. After considering submissions the Adjudicative Committee imposed a suspension of D Cooper's licence to ride in races from the conclusion of racing on Thursday 21 November until the conclusion of racing on Thursday 5 December, 10 national riding days. Due to concerns regarding his recent riding record, D Cooper was further directed to meet with an NZTR appointed Rider Skills Review Panel under the provision of Rule 358.

OUR ECHO (L Hemi) - Slow to begin.

IS THAT SO (J Doyle) - Slow to begin.

ILLICIT DREAMS (S Spratt) - Shifted ground inwards under pressure in the run home.

LINCOLN'S KRUZ (L Sutherland) - Held up early in the run home.

KANA (C Barnes) - Held up for clear running in the straight only gaining clear racing room near the 175 metres.

SPARTAN (T Newman) - Crowded when weakening near the 250 metres to the inside of MYSTIC PARK which was taken in by ILLICIT DREAMS.

MYSTIC PARK (S Weatherley) - Inconvenienced when dictated inwards near the 250 metres then had to be steadied away from the heels of ILLICIT DREAMS which again shifted inwards under pressure passing the 200 metres.

SOUTH OF HOUSTON (M Cartwright) - Crowded and steadied when tiring near the 100 metres when outside runners shifted in.

S Spratt (ILLICIT DREAMS) - Issued with a warning after permitting her mount ILLICIT DREAMS to shift inwards dictating MYSTIC PARK inwards resulting in SPARTAN being crowded and steadied near the 250 metres.

IT'S THE VIBE (D Montes de Oca) - Slow to begin.

MUZZLE CAT (D Cooper) - Slow to begin.

IFFIN DOUBT DANCE (S Wynne) - Slow to begin then was ridden forward in the early stages to take up a position outside the leader near the 1600 metres. Was inclined to shift ground throughout the run home.

JETALAL (K Hercock) - Raced wide without cover in the early stages before improving forward to sit outside the leader near the 1200 metres.

SCHEDAR (R Mudhoo) - Raced three wide without cover through the middle stages.

CAPTAIN UPHAM (A Balloo) - Under pressure passing the 800 metres finishing well back.

S Wynne (IFFIN DOUBT DANCE) - Admitted a charge in that she struck her mount IFFIN DOUBT DANCE 6 times prior to the 100 metre mark with 5 additional strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Thursday 21 November until the conclusion of racing on Thursday 28 November, 5 national riding days.

BEAVERTOWN BOY (K Myers) - Fractious in its barrier prior to the start and was removed to undergo a veterinary inspection and cleared to race.

MARY LOUISE (C Barnes) - Began very awkwardly losing ground.

FRANNI CACCINI (A Balloo) - Very slow to begin.

TRANZED (A Goindasamy) - Raced keenly in the early stages.

LOMBARDI (L Hemi) - Raced keenly in the early stages. Raced three wide without cover from the 1500 metres.

LOSTCAUSE (S Wynne) - Over raced in the early stages.

CANHEROC (S Spratt) - Over raced when three wide without cover before improving forward to sit outside the leader near the 1600 metres.

NOBLE KNIGHT (K Chowdhoo) - Over raced for a distance passing the 1900 metres.

FIERCE FLIGHT (L Riordan) - Made the bend near the 600 metres awkwardly.

L Sutherland (JUST CHARLIE) - Admitted a charge in that she struck her mount JUST CHARLIE 7 times prior to the 100 metre mark, with 5 additional strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$650.

K Myers (BEAVERTOWN BOY) - Admitted a charge in that she struck her mount BEAVERTOWN BOY 10 times prior to the 100 metre mark which included 2 consecutive strikes. After considering submissions the Adjudicative Committee imposed a suspension of K Myers' licence to ride in races from the conclusion of racing on Friday 29 November until the conclusion of racing on Wednesday 11 December, 8 national riding days, and in addition imposed a fine of \$1850.

S Wynne (LOSTCAUSE) - Admitted a charge in that she struck her mount LOSTCAUSE 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of S Wynne's licence to ride in races from the conclusion of racing on Thursday 28 November until the conclusion of racing on Thursday 12 December, 10 national riding days.
