**CITY GIRL (R Goyaram)** – Trainer Mr. A Forsman reported to Stewards, he was satisfied with the post-race condition of the mare, however, CITY GIRL has now been retired from racing.

#### **RACE COMMENTS**

### Race 1 DMAK ELECTRICAL HEAT PUMPS AND SOLAR MAIDEN 1200m

**ROCSTOKIN BARREL** (J Chung) - Jumped awkwardly, contacting GREEN PASTURES. Raced keenly in the early stages.

**GREEN PASTURES** (A Riddell) - Contacted at the start, losing ground.

RIOMOSA (M Hudson) - Slow to begin.

**CORSINI** (L Sutherland) - Raced keenly in the early stages.

**SUMOSAURUS** (L Kauri) - Raced keenly through the early stages.

**DAMIANO** (H Grace) - Unable to take advantage of a narrow gap near the 300 metres, having to angle outwards to gain clear racing room. A short distance further was hampered when RIOMOSA shifted outwards when racing greenly. Raced greenly over the final stages.

**GIOIA MAGICA** (C Grylls) - Finished towards the rear. C Grylls advised that GIOIA MAGICA pulled up in a normal postrace examination and he had no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

Track Upgraded to Heavy 8, retrospective to Race 1.

#### Race 2 CR GRACE LTD 1200m

**POPPY'S GIRL** (L Sutherland) - Began awkwardly, losing ground. Lay outwards under pressure over the concluding stages. POPPY'S GIRL returned to the enclosure with blood present in the nostrils. A post-race veterinary inspection found the mare to have experienced an episode of Epistaxis. POPPY'S GIRL shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian. Co-trainer S Fannin advised the mare would be retired.

**BIKINDY** (E Sole) - Slow to begin.

EVELYN RUSH (C Grylls) - Eased approaching the 800 metres.

#### Race 3 TOLL FREE TARARUA MAIDEN 1400m

**CUBA STREET** (N Parmar) - Began awkwardly, losing ground. Raced keenly through the early stages, having to be steadied off heels approaching the 900 metres. Lay outwards under pressure approaching the 200 metres. Steadied off heels near the 75 metres when CAN JOHNNY BE GOOD lay inwards under pressure.

PARKLIGHT PRINCE (C Grylls) - Shifted outwards shortly after the start, hampering TOUCH OF QUALITY.

# TOUCH OF QUALITY (M Hudson) - Slow to begin.

**MOLASSES** (M Singh) - Slow to begin, losing ground. Lay outwards throughout the home straight. Finished well back. Rider M Singh had no excuse. A post-race veterinary examination was clear. Stewards advised Trainer T Mason that they held concerns regarding the mare's overall poor record over the previous 12 months, advising that MOLASSES is stood down from racing for an indefinite period.

**CAN JOHNNY BE GOOD** (J Chung) - Lay inwards under pressure over the concluding stages.

Race 4	AWASSI MAIDEN 1400m
	(I Hemi) - Slow to begin

**DEALORNODEAL** (L Hemi) - Slow to begin.

LAGARDE (H Grace) - Slow to begin.

**LITTLE WIZARD** (C Lindsay) - Slow to begin. Finished some distance back. Trainer A Davies was advised a warning will be placed against the gelding regarding its competitiveness and in addition must trial to the satisfaction of Stewards prior to racing next.

**THE BICESTER** (T Davies) - Raced keenly for a distance shortly after the start.

**THE GOLDEN BOY** (N Parmar) - Went out to a long lead to the 1000 metres, then commenced to weaken in the home straight. When questioned, rider advised the gelding had commenced to over-race and he had little choice but to allow THE GOLDEN BOY to extend its lead.

**MAGIC CHARM** (M Singh) - Lay outwards over the concluding stages.

**NOZUMI** (J Riddell) - Was under pressure passing the 800 metres and commenced to give ground rounding the home turn and was not persevered with in the home straight. J Riddell advised Stewards that he considered something amiss with the gelding. A subsequent veterinary examination was clear. Stewards will follow up over coming days.

Race 5 HB FARMERS TRANSPORT LTD MAIDEN 1600m

**DUBAI'S POTIKI** (H Grace) - Steadied off heels shortly after the start which CROIX DE GUERRE (C Grylls) shifted inwards when not fully clear. Raced keenly approaching the 1400 metres. Lay outwards under pressure over the concluding stages.

**COLOUR CHART** (L Sutherland) - Struggled to maintain contact with the field throughout. Finished a distant last. L Sutherland advised that in her opinion her mount was unsuited to the Heavy conditions underfoot. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Trainer G Vile advised he would monitor COLOUR CHART over coming days and report any finding to the Stewards.

**COIX DE GUERRE** (C Grylls) - Lay outwards, having to be straightened passing the 250 metres.

LIBERTY PARK (K Hercock) - Inclined to shift ground over the concluding stages and had to be straightened.

**C Grylls** (CROIX DE GUERRE) - Issued with a warning after permitting CROIX DE GUERRE to shift inwards when not fully clear of DUBAI'S POTIKI shortly after the start, which resulted in DUBAI'S POTIKI having to steady. Stewards took into account DUBAI'S POTIKI'S tendency to over-race when assessing the interference.

Race 6	CENTRALINES 1600m	
RAGAMUFFIN (C Grylls) - Slow to begin.		

**VERARDINO** (A Riddell) - Slow to begin.

**HELLUVAH RETURN** (T Davies) - Raced three-wide without cover throughout. Lay inwards having to be straightened near the 350 metres.

**UTOPIAN WINE** (N Parmar) - Held up rounding the final turn and through the majority of the home straight, having to angle inwards passing the 50 metres to gain clear running.

#### Race 7 VALLEY D'VINE RESTAURANT WAIPUKURAU CUP 1600m

**FAY KHAN IT** (C Butler) - Put its head down as the gates opened, beginning awkwardly, losing ground (6L). Connections were advised a warning has been placed against the mare's barrier manners.

**TRAV** (M Singh) - Slow to begin. Raced wide throughout. Came together and bumped with GRIT near the 300 metres.

**DUNCAN CREEK** (J Chung) - Lay outwards under pressure over the concluding stages, momentarily hampering PUKE PARK near the 200 metres

**PUKE PARK** (A Riddell) - Lay inwards having to be straightened passing the 300 metres. Hampered near the 200 metres.

**GRIT** (N Parmar) - Came together and bumped with TRAV near the 300 metres. Lost the off-hind plate during the running.

**RENEGADE REBEL** (H Grace) - Finished towards the rear. When questioned rider could offer no excuse.

## Race 8 HAPPY 80<sup>TH</sup> BIRTHDAY JIM SCOTT 2100m

**CARIGNAN** (L Sutherland) - Began awkwardly. Shifted inwards over the final stages, making contact with JACKAROO, which reacted by turning its head outwards in an attempt to bite CARIGNAN. Hampered final stages.

**SISTER JANE** (L Kauri) - Raced ungenerously, making the first bend very awkwardly, hampering MORE TO BE WRITTEN by dictating it over extra ground.

MORE TO BE WRITTEN (E Sole) - Hampered and dictated over extra ground rounding the first bend.

**NOTHING UNUSUAL** (L Hemi) - Raced wide throughout.

**JACKAROO** (K Hercock) - Contacted by CARIGNAN over the final stages. Connections were advised that a warning had been placed on the gelding's racing manners.

Following the running of the race, Stewards lodged a protest alleging interference by the 1<sup>st</sup> placed JACKAROO which turned towards and made head contact with the 2<sup>nd</sup> placed CARIGNAN in an attempt to bite that runner. After hearing evidence from the Riders and Trainers of the respective horses and viewing all available footage, the Adjudicative Committee dismissed the protest.

#### Race 9 CHB RAM BREEDERS MAIDEN 2100m

There was a delay to the start when KERBLINE had become awkwardly placed in the barriers prior to the start.

**UNDERLINE** (T Davies) - Began awkwardly.

EL TAJIN (M Hudson) - Began awkwardly, hampering TUKITUKI, which in turn hampered NAKAJIMA.

TUKITUKI (M Singh) - Hampered at the start. Made the first bend awkwardly.

NAKAJIMA (L Hemi) - Hampered at the start. Raced keenly through the early and middle stages.

**WILLOUGHBY WHITE** (C Grylls) - Restrained to the rear from its wide draw. Weakened from the 800 metres. When questioned, rider had no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Trainer R Patterson advised Stewards that WILLOUGHBY WHITE will not be persevered with as a racing proposition from his stable.

Connections of the 2<sup>nd</sup> placed ELIVABER viewed footage of the final stages, alleging interference by the 1<sup>st</sup> placed TUKITUKI, but elected not to proceed with a protest.
