## Race 7 - NZB READY TO RUN SALE TRAINERS SERIES PREMIER 1400m

**VIVACIOUS** (L Riordan) Te Akau Racing Manager Mr R Trumper advised Stewards the stable was satisfied with the post-race condition of the mare, however VIVACIOUS has now been sent for a brief freshen up.

#### Race 10 - AL BASTI EQUIWORLD DUBAI 52ND NZ 2000 GUINEAS G1 1600m

WHEN STARS ALIGN (K Stott) - Te Akau Racing Manager Mr R Trumper advised Stewards that although the stable was satisfied with the post-race condition, WHEN STARS ALIGN has now been gelded and sent for a spell.

## Race 1 - THE GRAND TOUR IN CHRISTCHURCH PREMIER 1000m

**KINDRED SPIRIT** (J Fawcett) - Co-trainer Mr M Pitman reported to Stewards the stable was satisfied with the post-race condition of the mare and it is the stable's intention to trial KINDRED SPIRIT at the Ashburton RC on Tuesday 26 November.

#### **RACE COMMENTS**

## Race 1 LOVERACING.NZ MAIDEN 1200m

**JUST A BROWN HORSE** (Y Atchamah) - Slow to begin. Held up rounding the final turn then again held up passing the 150 metres having to steady and shift outwards across heels.

WOTACHATTABOX (D Cooper) - Contacted leaving the barriers and slow to begin as a result.

**RENAISSANCE MAN** (A Goindasamy) - Slow to begin. Held up early in the straight and did not obtain clear running until inside the final 150 metres.

**FLAT STANLEY** (R Mudhoo) - Slow to begin. Over raced through the middle stages. Held up rounding the final turn and did not obtain clear running until near the 250 metres.

**BONA FIDE** (U Holmquist) - Blundered jumping away. Steadied to avoid the heels of KNOWLEDGE IS POWER shortly after the start and shifted outwards contacting BAX FACTOR.

**BAX FACTOR** (C Campbell) - Contacted shortly after the start. Held up passing the 200 metres before obtaining clear racing room passing the 150 metres.

**SIR SIGARO** (S Wynne) - Over raced through the early stages getting its head up on a number of occasions.

**HOORAY FOR HARRY** (K Williams) - When questioned regarding performance, rider advised that she had got further back than intended after the gelding had been a little lost for early speed and had been inclined to race greenly amongst other runners, adding in her opinion HOORAY FOR HARRY would derive benefit from today's experience and first up race after a lengthy spell.

**D Montes de Oca** (KNOWLEDGE IS POWER) - Issued with a warning after angling his mount inwards shortly after the start when not fully clear of BONA FIDE.

## Race 2 ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1200m

**RED STAR BELLA** (T Moseley) - Declared a late scratching at 1:03pm after refusing to load. As a result this race ran approximately 4 minutes late. Connections were advised that RED STAR BELLA must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

VILETTE (B Murray) - Taken back from a wide draw to obtain cover shortly after the start.

AN MORRIGHAN (A Riddell) - Taken back from a wide draw to obtain cover shortly after the start.

ATTAHUAWHATADREAM (A Goindasamy) - Taken back from a wide draw to obtain cover shortly after the start.

PARKER BONNIE (D Tait) - Raced three wide without cover throughout.

AMAZE ME (C Campbell) - Lay in near the 300 metres.

**PORCIA CATONIS** (K Williams) - When questioned regarding performance, rider was unable to offer any excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

## Race 3 MCMILLAN FEEDS 1200m

SHAKABRAH (T Moseley) - Slow to begin. Held up early in the straight.

CHICAGO DREAM (L Hemi) - Over raced outside the leader through the early and middle stages.

**DIABLO BLANCO** (A Goindasamy) - When questioned regarding performance, rider advised that the filly had never hit out freely and in his opinion may be better suited by some easing of the ground. A post-race veterinary inspection found the mare to have an elevated heart rate and subsequently to be displaying signs of soreness in front. Trainer R Didham was advised that a veterinary clearance is required prior to racing next. Stewards will follow up with connections in coming days.

**PRINCESS SOLITAIRE** (B Murray) - When pulling up after the race the filly became entangled in the hedge in the back straight, dislodging its rider who was uninjured. Due to this delay B Murray was exempted from weighing in. PRINCESS SOLITAIRE was uninjured in this incident.

#### Race 4 NZB MEGA MAIDEN SERIES 1600m

PIRATES 'N' GOLD (D Tait) - Slow to begin.

**GRASSHOPPER** (D Cooper) - Raced three wide without cover throughout.

**THUNDERFIST** (C Campbell) - Lay out rounding the final bend running wide. Rider reported the gelding had hung outwards throughout the running.

**GATZBY** (K Williams) - Held up early in the straight until passing the 200 metres.

**RINGS OF SATIN** (T Moseley) - When questioned regarding performance, rider was unable to offer any excuse advising that the filly had been disappointing but may still be immature.

## Race 5 BORN TO GIVE 1600m

**OMINOUS** (S Wynne) - Slow to begin. Held up behind the weakening THE ARCHITECT rounding the bend from the 600 metres until near the 400 metres.

**SEFTON** (T Comignaghi) - Slow to begin. When questioned regarding performance, rider advised that after getting back from its outside barrier draw the gelding had been unable to recover in a truly run race.

**ASTERIAL** (L Hemi) - Raced three wide without cover throughout.

**CHEQUERED** (D Cooper) - Over raced in the early and middle stages with the saddle shifting forwards passing the 1400 metres placing the ridder at a disadvantage. Was not persevered with rounding the final bend and in the straight. Apprentice D Cooper was shown film footage in the presence of the Apprentice Riding Mentor.

**SPARTA** (A Goindasamy) - Over raced through the middle stages.

**AMIINIT** (D Tait) - When questioned regarding performance, rider was unable to offer any excuse.

#### Race 6 PALAMOUNTAINS SCIENTIFIC ANIMAL NUTRITION 1600m

The start was delayed approximately 4 minutes due to COMPLICATE needing to be resaddled.

CHASE 'N' GOLD (A Riddell) - Slow to begin.

**GIVEALITTLE** (L Hemi) - Slow to begin.

INFERNAPE (T Comignaghi) - Slow to begin.

IFF I GET PAAID (A Najib) - Slow to begin.

**IN AWE** (D Cooper) - Raced keenly in the early stages.

**GANGSTA GRANNY** (D Tait) - Raced three wide without cover throughout.

**ORSOME DUDE** (U Holmquist) - When weakening had to be steadied to avoid the heels of SAILING AWAY (D Montes de Oca) which shifted outwards when not fully clear near the 350 metres. D Montes de Oca was advised to exercise greater care.

**B Murray** (BOURBON CHIQUE) - Issued with a warning after weighing-in 0.7kg in excess of the weight at which he weighed out.

Trainer **L Robinson** (IN AWE) - Issued with a warning after entering the area of the racetrack behind the barriers and speaking briefly to his rider.

#### Race 7 YOUNG BUCKS NZ MOTOR CORPORATION 1600m

KINDLING SPARK (L Hemi) - Slow to begin.

**SESTINA** (S Wynne) - Crowded leaving the barriers losing ground.

MISS PEARL (D Tait) - Raced three wide without cover through the early and middle stages.

**VAGUE** (U Holmquist) - Had to be steadied off heels near the 500 metres. Held up early in the straight and did not obtain clear running until near the 250 metres.

#### Race 8 ECHOES OF HEAVEN & JON SNOW 2200m

**EKSTREMEMISS** (Y Atchamah) - Slow to begin then continuing to lose ground in the early stages. Rider was questioned in the presence of the Apprentice Riding Mentor as to his lack of vigour in the early stages and allowing

his mount to become tailed off. Y Atchamah advised that his instructions had been to allow the mare to find its feet in the early stages but agreed with Stewards that he had erred in his judgement on this occasion in allowing his mount to lose so much ground early. Y Atchamah was advised he is expected to ride his mounts in a manner that is not left open to query in future.

## Race 9 PURE CHAMPION@WILLOW GLEN MAIDEN 2200m

LEGEND BEAST (R Beeharry) - Over raced while being restrained to obtain cover in the early stages.

**SUNNINGDALE** (A Riddell) - Raced three wide without cover throughout.

**SIR EDENMORE** (T Ladouceur) - Raced wide without cover in the middle stages before commencing to give ground passing the 800 metres then being retired from the race. SIR EDENMORE was immediately attended to by the oncourse veterinarian with the horse ambulance being deployed. SIR EDENMORE was found to have suffered a fracture of the right fore pastern being humanely euthanised.

**LORD GREYSTOKE** (R Mudhoo) - Held up briefly in the early stages of the run home, having to shift off heels to obtain clear running passing the 250 metres. Rider reported that his saddle had shifted during the running, inconveniencing him to some degree.

**CALLMEGINGER** (B Murray) - Steadied when placed in restricted room approaching the 400 metres due to slight movement from runners to either side.

**R Beeharry** (LEGEND BEAST) - Issued with a warning after making a celebratory gesture just prior to the winning post.

**R Beeharry** (LEGEND BEAST) - Admitted a charge in that he struck his mount LEGEND BEAST 7 times prior to the 100 metre mark with a further 5 strikes inside the final 100 metres. After considering submissions the Adjudicator imposed a fine of \$250.
