RACE COMMENTS

Race 1 **BRIAN BAKER INSTRUMENTATION & ELECTRICAL MAIDEN 2000m**
HE'S TIKETIBOO (L Sutherland) - Raced keenly when being restrained approaching the 1600 metres.

LAZY (L Kauri) - Had to be firmly restrained to avoid the heels of AVORIAZ near the 1600 metres.

JAMAICA FAREWELL (T Newman) - Over raced passing the 1100 metres shifting outwards to avoid heels then racing three wide without cover.

AVORIAZ (M Hashizume) - Placed in restricted room near the 50 metres having to be briefly steadied.

NAVY ICON (M Cartwright) - Over raced passing the 1100 metres.

M Hashizume (AVORIAZ) - Admitted a charge of careless riding in that he permitted his mount AVORIAZ to shift inwards when not sufficiently clear of LAZY near the 1600 metres. After considering submissions the Adjudicator imposed a suspension of M Hashizume's licence to ride in races from the conclusion of racing on Saturday 30 November until the conclusion of racing on Friday 6 December, 4 national riding days.

Race 2 | **ENERGY CITY FORD MAIDEN 1200m**

I'M PEDRO (L Douglas) - Jumped away awkwardly losing ground. Commenced to over race shortly after the start, continuing to race fiercely through the middle stages and having to be firmly restrained off heels on a number of occasions.

SHE'S UNTOUCHABLE (M Cartwright) - Jumped away awkwardly.

BELLE TRIBUTE (H Grace) - Slow away then being further hampered by SHE'S UNTOUCHABLE.

LUCAN (R Goyaram) - Slow away.

YESINSKY PRINCESS (J Chung) - Raced three wide without cover.

Race 3 | **MURPHY & LANDRIGAN CHARTERED ACCOUNTANTS MAIDEN 3YO 1400m**

WYWORRY (E Sole) - Declared a late scratching at 3:57pm after refusing to parade to the start. Trainer J Wheeler was advised that WYWORRY must trial to the satisfaction of a Stipendiary Steward prior to racing next.

GOLDEN LINING (R Goyaram) - Jumped away awkwardly losing ground.

DERRYMAN (L Sutherland) - Slow away.

SICILLIAN (M Hashizume) - Blundered leaving the barriers before being further hampered by EASTANDWEST which jumped inwards.

MERCHANT BANKER (J Doyle) - Over raced in the early stages getting its head up.

Following this race the track was upgraded to Soft 5.

Race 4 | **ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1400m**

SAFE AZ DOUTE (E Sole) - Underwent a pre-race veterinary inspection after making contact with a vehicle behind the barriers being passed fit to run. Jumped away awkwardly after being fractious in the barriers. Connections were advised that a barrier manners warning would be placed against the mare's record. Over raced passing the 1200 metres. Dislodged its rider when pulling up, with both horse and rider being uninjured. Trainer T Hina advised that SAFE AZ DOUTE was now likely to be retired from racing.

PATRIOT (K Chowdhury) - Removed from the barriers after becoming fractious to undergo a veterinary inspection and being passed fit to run. Slow away.

LADYLOU (N Parmar) - Slow away.

SUMMERSTON (K Stott) - Jumped away awkwardly. Steadied when improving onto the heels of **WEOWNARANAWAY** near the 1100 metres and reacted poorly racing ungenerously for a distance losing ground.

SWEET AND SASSY (R Elliot) - Raced ungenerously when being steadied to avoid the heels of **BAK DA ANGEL** passing the 1200 metres.

Race 5 | **REVITAL FERTILISER 1400m**

TINY DIAMOND (H Grace) - Slow away. Got its head up when being steadied off heels passing the 1000 metres.

ALFRISTON (J Chung) - Restrained to obtain cover after jumping from a wide barrier.

MALACHY (M Hashizume) - Restrained to obtain cover after jumping from a wide barrier.

OH NO NO NO (R Goyaram) - Restrained off heels on a number of occasions when racing keenly through the middle stages.

PERSIFLAGE (J Doyle) - Held up when disappointed for a run near the 300 metres to the inside of **MESA VERDE** which lay in. **PERSIFLAGE** then made contact with **MESA VERDE** when shifting outwards to obtain clear running passing the 200 metres.

MESA VERDE (K Stott) - Lay inwards early in the straight then contacted passing the 200 metres. Inconvenienced over the concluding stages when **OH NO NO NO** (R Goyaram) shifted outwards. R Goyaram was advised to exercise greater care.

BRUNO (R Elliot) - Held up near the 250 metres when attempting a marginal run which closed, then having to be checked when becoming awkwardly placed on the heels of **WINSTON**. Continued to have trouble obtaining clear running until the concluding stages.

Race 6 | **SEATON PARK 1400m**

SHEEZ DOMINANT (M Singh) - Raced three wide without cover. Steadied when becoming awkwardly placed on the heels of **WET 'N' WILD** near the 250 metres.

BELLADONNA LILY (J Doyle) - Lay out rounding the final turn.

WET 'N' WILD (N Parmar) - Lay out rounding the final turn forcing **LOCH IN ORA**, **MALBOROUGH BAY** and **SEVENAYES** wider on the track.

LOCH IN ORA (L Sutherland) - Forced wider on the track rounding the bend near the 300 metres.

MALBOROUGH BAY (S Mxothwa) - Forced wider on the track rounding the bend near the 300 metres. Lay inwards under pressure over the final 100 metres. Rider S Mxothwa was shown film footage in the presence of the Apprentice Riding Mentor and reminded of his obligation to ride his mounts out fully to the finish after narrowly holding fourth placing after relaxing his ride just short of the finish.

SEVENAYES (M Hashizume) - Forced wider on the track rounding the bend near the 300 metres.

PENURIOUS (T Newman) - Held up when disappointed for a run near the 250 metres, having to steady and shift outwards across heels to obtain clear running near the 150 metres.

| <p>MARGHERITA VELOCE (K Stott) - Slow away.</p> <p>TISSE (L Sutherland) - Contacted leaving the barriers. Raced greenly going off-stride near the 1200 metres. Raced greenly ducking outwards abruptly away from the running rail near the 700 metres. Inconvenienced near the 250 metres when CELTIC ECHO shifted inwards under pressure.</p> <p>CELTIC ECHO (S Mxothwa) - Jumped away awkwardly making contact with TISSE. Raced three wide without cover. Shifted ground under pressure near the 250 metres and when being corrected made contact with RAVENNA ROSE near the 200 metres. S Mxothwa was advised to exercise greater care.</p> <p>RANGER (R Goyaram) - Over raced in the early stages.</p> <p>EL NYMPH (U Holmquist) - Got its head up and raced ungenerously after improving onto the heels of RANGER (R Goyaram) when the pace steadied to some degree near the 1200 metres. R Goyaram was reminded of his obligation not to steady the pace to a degree that puts other riders in difficulty. Contributing to this incident was RAVENNA ROSE commencing to over race when CELTIC ECHO was improving to its outside.</p> <p>RAVENNA ROSE (J Doyle) – Over raced near the 1200 metres. Contacted near the 250 metres.</p> | |
| Race 8 | CHRISTMAS AT THE RACES THURSDAY 5 DECEMBER 2024 MAIDEN 1600m |
| <p>FREEBELLE (L Douglas) - Declared a late scratching at 6:52pm after throwing itself to the track during the preliminary. Trainer R Patterson was advised that FREEBELLE must trial to the satisfaction of a Stipendiary Steward on two occasions prior to racing next.</p> <p>MR FANTASY (M Cartwright) - Declared a late scratching at 6:58pm on veterinary advice after becoming fractious in the barriers. The stable representative was advised that MR FANTASY must trial to the satisfaction of a Stipendiary Steward prior to racing next.</p> <p>As a result of the late scratchings this race ran approximately 7 minutes late.</p> <p>SATSUKI (N Parmar) - Jumped away awkwardly.</p> <p>BLUE JEANIE (H Grace) - Slow away and continued to lose ground in the early stages. When questioned, rider advised that the mare had felt indifferent in its action throughout. Stewards will follow up with connections in coming days.</p> <p>BLUE RATA WAREA (R Elliot) - Raced three wide without cover throughout.</p> <p>POETIC JUSTICE (K Stott) - Lay out under pressure in the straight. Made contact with BLACKWATERFOOT near the 75 metres when both runners shifted ground.</p> <p>BLACKWATERFOOT (L Sutherland) - Made contact with POETIC JUSTICE near the 75 metres when both runners shifted ground. Prior to the authorisation of dividends the rider of BLACKWATERFOOT viewed Stewards' film footage before electing not to proceed with a protest.</p> <p>K Stott (POETIC JUSTICE) - Reprimanded regarding the nature of his whip use in the final straight.</p> | |
