SUPPLEMENTARY
Racing Rotorua @ Arawa Park - Tuesday, 19 November 2024 Race 8 GREENLIGHT INSURANCE BROKERS 1400m KALLEDU THUNDER (J Riddell) – Co-trainer L Zydenbos advised Stewards the stable was satisfied with the post-race condition of the gelding, however, KALLEDU THUNDER has now been sent for a spell.

RACE COMMENTS
Race 1 JOHN REVELL MEMORIAL MAIDEN 1150

This race was delayed by 4 minutes due to POLLYISACRACKER being reluctant to hit out during its preliminary which resulted in the mare being late to arrive at the start.

POLLYISACRACKER (C Barnes) - Connections were advised that a warning would be placed against the mare's racing manners. Underwent a post-race veterinary examination which revealed no abnormalities.

BERTIE WOOSTER (S Spratt) - Slow to begin.

MIRABELLA (R Goyaram) - Began awkwardly.

PERFECT DIVIDENDS (B Rogerson) - Began awkwardly. Hung outwards in the final straight when placed under pressure. When questioned regarding the performance rider advised that the gelding hung outwards in the final straight causing her difficulty which proved detrimental to its chances. Underwent a post-race veterinary examination which found the gelding to have a slow recovery. Stewards will follow up with connections on the post-race condition of the gelding in the coming days.

ITHASSTOBE GIN (M Hashizume) – Crowded at the start.

MAD MAX (G Rooke) – Crowded at the start having to be steadied.

LYKOS (T Mitchell) – Raced keenly in the early stages.

MI BELLA (W Kennedy) – Had to be steadied off heels near the 900 metres.

BENJI (A Lawson-Carroll) - Lay outwards when placed under pressure near the 350 metres having to be corrected by its rider.

R Goyaram (MIRABELLA) - Issued with a warning after permitting his mount to shift inwards when not fully clear of POLLYISACRACKER which was dictated inwards resulting in MI BELLA having to be steadied off heels near the 900 metres. When assessing this incident Stewards took into account slight outward movement from BUCCINO which contributed to the incident.

Following this race the track was upgraded to Good 4.

Race 2	DIPROSE MILLER 3YO MAIDEN 1150

This race was delayed by 2 minutes due to T Mitchell (SEDUIRE) and G Rooke (SHE'S SINATRA) being dislodged from their mounts on the way to the barriers.

LOVE SYMBOL (W Kennedy) - Reared as the start was effected, losing ground.

SEDUIRE (T Mitchell) - Knuckled at the start. Improved onto the heels of a weakening runner near the 150 metres then ducked outwards abruptly losing ground.

SHE'S SINATRA (G Rooke) – Slow to begin then hampered shortly after. Improved onto heels before shifting ground outwards near the 700 metres.

FLORENZA (S Spratt) – Over-raced in the early stages.

ZERRE (N Parmar) - Weakened near the 150 metres. When questioned regarding the performance rider advised that the filly would be better suited to a softer track surface.

<p>This race was delayed by 2 minutes at the request of TAB control.</p> <p>WITHALLMYSOUL (M Hashizume) - Began awkwardly. Over-raced in the early stages.</p> <p>VENETIAN (W Kennedy) - Began awkwardly. Held up for clear running until near the 100 metres.</p> <p>GRAPHIC (S Spratt) – Slow to begin. Not persevered with over the final 200 metres when out of contention. When questioned, the rider could offer no explanation.</p> <p>KARYON (B Rogerson) – Raced wide without cover through the early and middle stages.</p> <p>TYCOON PRINCE (R Elliot) – Had to be steadied off heels approaching the 600 metres.</p>	
Race 4	CAPISTRANO LODGE 1000
<p>NAXOS (A Lawson-Carroll) - Began awkwardly then hampered shortly after.</p> <p>GRAHAM FRANCIS (L Sutherland) - Began awkwardly then hampered shortly after, losing ground.</p> <p>NOIVERN (R Goyaram) – Contacted shortly after the start. Shifted across heels to obtain clear running near the 350 metres.</p> <p>EVA MAGICAL (W Kennedy) – Raced wide without cover throughout. Lay inwards when placed under pressure having to be corrected by its rider passing the 200 metres.</p> <p>J Doyle - Issued with a Minor Infringement and fined \$100 after failing to make the weight on GRAHAM FRANCIS. J Doyle was replaced by L Sutherland.</p>	
Race 5	NZB MEGA MAIDEN SERIES 2200
<p>BACKDRAFT (L Sutherland) - Slow to begin.</p> <p>OUT OF SIGHT (B Rogerson) - Slow to begin. Had difficulty obtaining clear running until near the 200 metres.</p> <p>MR ACABELLO (A Lawson-Carroll) - Over-raced in the early stages. Held up early in the final straight.</p> <p>TURNAROUND (R Elliot) - Over-raced in the early stages.</p> <p>HALLER (C Barnes) – Raced wide without cover throughout.</p>	
Race 6	DIPROSE MILLER COMMUNITY FUND 1100
<p>FLEMING (R Elliot) - Became fractious in its barrier and was removed to undergo a veterinary examination being declared a late scratching at 4.05 pm. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p>HANKEE ALPHA (M Hashizume) – Slow to begin. Held up until near the 100 metres.</p> <p>MONIQUE TONNERRE (T Mitchell) – Raced three wide without cover throughout.</p> <p>EGYPTIAN QUEEN (A Lawson-Carroll) - Held up early in the final straight.</p>	

HEY HEY BABY (R Goyaram) - Had to be steadied when placed in restricted room to the inside of MARKET PLACE (J Doyle) which shifted inwards approaching the 150 metres. J Doyle was advised to exercise greater care in similar circumstances.

SAYAN (G Rooke) - Held up until near the 100 metres.

R Goyaram (HEY HEY BABY) - Issued with a warning for leaving the Jockeys Room without permission from a Steward.

Following this race the track was upgraded to Good 3.

Race 7 | **ENTAIN/NZB INSURANCE PEARL SERIES MAIDEN 1400**

MISS FLOWER (C Barnes) - Slow to begin.

SHE'S A BELLATRIX (A Lawson-Carroll) – Raced keenly in the early stages.

SUPER FLY (J Doyle) – Raced three wide without cover from the 1000 metres.

RIDGEVIEW VICKY (N Parmar) – Raced wide without cover throughout.

BERRY BROWN (W Kennedy) - Held up rounding the final bend.

PRETTY 'N' BLACK (S Spratt) - Held up for clear running until passing the 200 metres.

Race 8 | **KEITH MILLER 1400**

SCOUSER (M McNab) - M McNab was granted permission from Stewards to ride SCOUSER 1 kg over the handicapped weight. When questioned regarding the performance rider advised that after receiving an economical run, the mare had failed to respond when placed under pressure in the final straight. Underwent a post-race veterinary examination which found the mare to have a slow recovery.

DEEBEE BELLFER (G Rooke) - Slow to begin.

TALISKER (R Goyaram) - Raced keenly in the early stages. Forced wider on the track rounding the final bend.

SPANISH LAD (S Spratt) - Made the bend awkwardly shifting outwards near the 900 metres.

GIACOMO (N Parmar) - Shifted outwards rounding the final bend forcing TALISKER wider on the track.

Race 9 | **RACING TE AROHA LIFE MEMBERS 3YO 1400**

BRITANNIA GOLD (W Kennedy) – Crowded shortly after the start losing ground.

ASAL (N Parmar) - Slow to begin.

I PARK (A Lawson-Carroll) - Restrained in the early stages to obtain cover from a wide barrier. Had to be steadied off heels when racing keenly near the 1000 metres.

CASUAL KHAN (C Barnes) – Raced three wide without cover throughout.

RIDEFROMTHEASHES (M McNab) - Lay out when placed under pressure over the concluding stages.

Race 10 | **STABLES BOOKS MAIDEN 1400**

LEBASSO (T Mitchell) - Restrained in the early stages to obtain cover from a wide barrier. Made the bend awkwardly near the 900 metres running wider when racing keenly then was allowed to improve forward three wide without cover rounding the final bend.

I EXCEL (G Rooke) - Restrained in the early stages to obtain cover from a wide barrier.

CARMONA (L Sutherland) - Hampered shortly after the start losing ground. Made the bend near the 900 metres awkwardly running wider.

PROBOY (B Jacobson) – Began awkwardly making contact with CARMONA having to be corrected by its rider.

SMASHING SISTER (S Weatherley) - Over-raced through the early and middle stages. Underwent a post-race veterinary examination which revealed a laceration to the left eye which was treated.

TRUST ALONE (S Spratt) – Held up until near the 200 metres.

MCCLLENAGHAN (B Jacobson) - Began awkwardly losing ground.

MAYA BAY (A Lawson-Carroll) - Raced three wide without cover throughout.

PROUDTOBEHERE (W Kennedy) – Rider reported that the mare had made abnormal breathing noises throughout the running. Underwent a post-race veterinary and endoscopic examination which revealed further assessment would be recommended. Trainer A Forsman confirmed that the mare will be scoped in the coming days and Stewards will follow up with the results.
