Race 7 JENNY LAMING MEMORIAL PREMIER 1200m

TENGIZ (K Hercock) – Trainer Mr. S Woodsford reported to Stewards, after being transferred by the horse ambulance to a local veterinary clinic for further veterinary evaluation, results showed significant tendon damage to the right hind leg, with the mare having to be humanely euthanised.

RACE COMMENTS

Race 1 PETER LYON SHEARING & BREEN CONSTRUCTION MAIDEN (2030m)

Trainer **L Callaway** (LIGHT OF PLUTUS) - Issued with a warning after presenting LIGHT OF PLUTUS without the notified pre-race ear covers.

OUR PRINCESS BOOT (T Moseley) - Underwent a pre-race veterinary examination after contacting the running rail on route to the start and was cleared to race. Restrained from a wide draw to obtain cover shortly after the start.

TIGER SATIN (B May) - Began awkwardly shifting out contacting CLYDE BARROW. Made the bend near the 1600 metres awkwardly shifting wider on the track. Rider advised that the gelding had raced greenly throughout.

CLYDE BARROW (R Muniandy) - Began awkwardly and was further hampered when TIGER SATIN shifted out, becoming awkward in its stride and as a result lost considerable ground. Tailed the field throughout and failed to run on over the concluding stages with the rider unable to offer any tangible excuse other than being hampered at the start. Trainer J Blackadder advised he would be making gear changes for racing on the second day.

KASHIPURA (K Rathoar) - Raced keenly and wide in the early stages. Made the bend near the 1600 metres awkwardly shifting wider on the track. Continued to race keenly through the middle stages.

CHANNA (K Mudhoo) - Had to be steadied near the 1600 metres when KASHIPURA shifted in when not fully clear. Raced keenly in the middle stages and near the 1100 metres had to be shifted outwards across heels.

K Rathoar (KASHIPURA) - Issued with a warning after allowing his mount KASHIPURA to shift in near the 1600 metres when not fully clear of CHANNA which had to be steadied.

Race 2 JACKSON SMART ROOFING & OMAKAU AUTO CENTRE MAIDEN (1220m)

ON FILE (K Mudhoo) - Began awkwardly shifting out crowding LADY DIVA which lost some ground. When asked to comment on the seemingly improved performance stable connections advised that the mare had drawn well and this combined with gear changes had led to todays improved showing.

MORE SASS (S Khetoo) - Began awkwardly shifting out crowding outside runners. Shifted ground outwards under pressure in the run home. When asked to comment on the performance rider advised that the filly had raced greenly throughout which had led to the disappointing showing. Connections advised they would give consideration to sending the filly for a spell.

DASH OF RED (B Murray) - Crowded at the start losing ground.

WOTACHATTABOX (B May) - Crowded at the start losing ground.

CHICAGO DREAM (C Campbell) - Crowded at the start. Raced three wide without cover throughout. Became awkwardly placed on the heels of MORE SASS passing the 300 metres having to be steadied for some distance.

LADY DIVA (A Najib) - Crowded at the start losing some ground and was then ridden with urgency to recover shortly afterwards. Placed in restricted room near the 1100 metres and as a result had to be steadied losing further ground.

MORRIE (T Comignaghi) - Crowded at the start. Hampered near the 250 metres.

LOVE FIFTEEN (T Moseley) - Had to be steadied inwards shortly after the start when CAROLTON shifted in when not fully clear and when being steadied inwards placed LADY DIVA in restricted room near the 1100 metres.

ACESANJACKS (R Muniandy) - Over-raced through the early stages.

DOMPERION (K Williams) - When asked to comment on the performance rider advised that the mare had been trapped wide early and having to go back to obtain cover had been detrimental to its effort today.

SHEAINTSOPEACHY (Y Atchamah) - Lost both front plates during the running.

L Callaway (CAROLTON) - Issued with a warning after allowing his mount CAROLTON to shift in near the 1100 metres when not fully clear of LOVE FIFTEEN which when being steadied inwards placed LADY DIVA in restricted room.

S Khetoo (MORE SASS) - Admitted a charge, assisted by J Laking, of careless riding in that he permitted his mount MORE SASS to shift out passing the 250 metres crowding and checking CHICAGO DREAM and hampering MORRIE. After viewing replays and considering submissions on penalty the Adjudicative Committee imposed a suspension of Mr Khetoo's licence to ride in races from the conclusion of racing on Sunday 1 December until the conclusion of racing on Saturday 7 December 2024, 4 national riding days.

Race 3 FOWLER DECORATORS & VERSATILE CROMWELL MAIDEN (1400m)

Trainer **N Mitchell** (HARRY GEE) - Admitted a charge under Rule 614(2) after he presented GENIEINABOTTLE and HARRY GEE with the incorrect saddles and number cloths. After considering submissions on penalty the Adjudicative Committee imposed a fine of \$400.

Trainer **A McLeod** (WILD SECRETS) – Issued with a warning after presenting WILD SECRETS without the notified prerace ear covers.

HARRY GEE (Y Atchamah) - Began awkwardly.

MOOR (B Murray) - Began awkwardly losing some ground.

THE BLUE DIAMOND (A Goindasamy) - Shifted out at the start making firm contact with ARETHUSA.

SPARKY (L Callaway) - Shifted out abruptly at the start crowding WOODLANDS with both runners losing ground.

WOODLANDS (R Mudhoo) - Crowded at the start losing ground. Lost the off-hind plate during the running.

ARETHUSA (A Najib) - Contacted at the start. Over-raced in the early stages.

GENIEINABOTTLE (B May) - Slow to begin.

EL ULTIMO (D Tait) - Lost the near front plate during the running.

Race 4 CATALYST PERFORMANCE CLARE MEMORIAL CUP (1220m)

INFLAMED (R Muniandy) - Over-raced in the early stages and near the 1000 metres became awkwardly placed inside the heels of LA BELLA NERA having to be steadied as a result.

HASSTOBEYOU (A Goindasamy) - Began awkwardly losing ground. Over-raced for a distance near the 800 metres getting its head up and having to be steadied outwards away from heels. Briefly lost its footing near the 700 metres when making the bend very awkwardly. Rider A Goindasamy advised the mare had raced very erratically in the early and middle stages proving difficult to control.

BLUE VEIN (D Tait) - Raced three wide without cover throughout.

AMBERECHO (K Williams) - Lost the near hind plate during the running.

Race 5 METALCRAFT ROOFING & NEW WORLD ALEXANDRA (1220m)

LA CERVEZA (B Murray) - Shifted out abruptly at the start crowding AORANGI ASSASSIN and LOOSE SALLY with both runners losing ground. Raced three wide without cover for the majority of the event.

AORANGI ASSASSIN (B May) - Crowded at the start losing some ground.

LOOSE SALLY (R Muniandy) - Crowded at the start losing ground. Rider advised the filly had hung out throughout.

TRADER (A Goindasamy) - Had some difficulty obtaining clear running in the middle stages of the run home and was briefly crowded near the 50 metres having to avoid the heels of IDEAL DREAMS (L Callaway) which shifted in at this point. L Callaway was advised to exercise care.

MIS SPEAKS (T Moseley) - Lost both front plates during the running.

Race 6 GREG JOPSON PROPERTY BROKERS & CHATTO CREEK TAVERN (1400m)

CORRECTION F Moerman) - Jumped away awkwardly losing ground.

PONZI PONY (A Najib) - Began awkwardly shifting in and crowding SEVEN TWENTY and EPILOGUE.

SEVEN TWENTY (Y Atchamah) - Contacted and crowded at the start.

EPILOGUE (D Tait) - Contacted and crowded at the start. Over-raced in the early stages getting its head up.

STOP YELLING (L Callaway) - Raced keenly for a distance passing the 800 metres having to be steadied away from heels. When asked to comment on the performance rider advised that the gelding was not suited by today's firm track conditions.

RADIANT REACH (S Khetoo) - Lay outwards under pressure near the 200 metres having to be straightened by its rider.

SHE'S AN ACE (R Muniandy) - Returned to the birdcage enclosure with blood present in both nostrils. A post-race veterinary examination revealed the mare to have experienced an episode of Epistaxis. SHE'S AN ACE shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Race 7 GIRL ON THE GROUND & URBAN FENCING HANDICAP (2030m)

PATSYS LASS (T Moseley) - Began awkwardly losing some ground and was then ridden forward to the lead passing the 1600 metres.

FRANNI CACCINI (A Najib) - Slow to begin. Steadied off heels near the 800 metres.

VAMOS (K Williams) - Dictated wider on the track near the 1400 metres and was then obliged to improve forward to sit outside the leader near the 1200 metres. Under pressure on the home turn and was not persevered with in the final straight with the rider reporting that the gelding had not travelled well and had been disappointing. A post-race veterinary examination did not reveal any obvious abnormality. Stewards will follow up with connections in the coming days.

ALBATROSS (D Tait) - When asked to comment on the performance rider advised that in her opinion the mare had been feeling the effects of recent racing.

MR INTELLIGENCE (C Campbell) - When asked to comment on the seemingly improved performance co-trainer B Blatch advised the gelding was suited by today's firmer track conditions which it encountered for the first time since resuming racing.

Race 8 A1 HOMES & A WOMANS TOUCH CLEAN (2030m)

Trainer **E Turner** (THREE NINETY) - Issued with a Minor Infringement Notice after being late to declare a rider for THREE NINETY and was fined \$50.

MADISON ROSE (B Murray) - B Murray was granted permission by Stewards to ride the mare 1 kg over the handicapped weight. Raced wide into the first bend before improving forward to sit outside the leader near the 1300 metres.

THREE NINETY (K Rathoar) - Began awkwardly. Rider K Rathoar was shown the films and reminded of his obligation to ensure he rides his mounts out fully to the line when circumstances permit.

ZAMBEZI ZIPPER (S Khetoo) - Shifted out at the start crowding QUICK STORY. Crowded and raced in restricted room rounding the final bend.

QUICK STORY (D Tait) - Crowded at the start losing ground.

CHASE 'N' GOLD (B May) - Slow to begin.

QUICK CALL (A Najib) - Made the first bend awkwardly. Held up early in the run home.

TAKE THE DEEL (T Comignaghi) - Raced three wide without cover from the 1300 metres.

XRATED (A Goindasamy) - Lay in rounding the final bend making contact with LADYSWEY when that runner was tiring.

DANZA (C Campbell) - Held up rounding the final bend until obtaining clear racing room passing the 200 metres.

LADYSWEY (T Moseley) - Contacted when weakening rounding the final bend. When asked to comment on the performance rider advised he was disappointed and could offer no excuse. A post-race veterinary examination did not reveal any obvious abnormality. Stewards will follow up with connections in the coming days.
