Race 7 STELLA ARTOIS 1500 CHAMPIONSHIP QUALIFIER 1400m

INSPIRED BY ART (W Pinn) – Co-trainer S Bergerson advised Stewards the stable was satisfied with the post-race condition of the mare, however, **INSPIRED BY ART** has now been sent for a short spell.

SAKO (M McNab) – Stable representative R Mildon reported to Stewards that on Monday 25 November, **SAKO** underwent a veterinary examination which included blood tests with no abnormalities being detected. R Mildon further advised it is the stables intention to continue on with the gelding's current preparation.

Race 8 TAB COUNTIES CUP 2100m (G3)

WOLFGANG (M McNab) - Co-trainer P McKay reported to Stewards the stable was satisfied with the post-race condition of the gelding, and it is the stables intention to continue on with WOLFGANG'S current preparation.

B & R Foote – Issued with a Minor Infringement and fined \$100 for using an unlicensed person.

RACE COMMENTS**Race 1 | HARRISONS 2400**

VERISMO (J Doyle) - Slow to begin.

BRIAN LAMONT (W Kennedy) - Slow to begin.

NORTHERN RAIDER (U Holmquist) - Had to be steadied when placed in restricted room on the heels of VERDI'S OPERA near the 2100 metres.

ENRIGHT (R Goyaram) - Improved onto heels having to be steadied passing the 1600 metres.

Race 2 | PREZZY CARD MAIDEN 1300

GOOD DAY (A Lawson-Carroll) - Knuckled leaving the barriers.

FUN NEVER SETS (W Kennedy) - Began awkwardly.

FASHION ROYALE (G Rooke) – Restrained to obtain cover in the early stages from an outside barrier.

BOUND TO BE (U Holmquist) - Restrained to obtain cover in the early stages from the outside barrier.

HIGH ROLLER (C Grylls) - Began awkwardly losing ground.

SO BRASSY (L Satherley) – Raced keenly in the early stages.

SASPERELLA (M Hashizume) – Improved onto heels having to be steadied rounding the final bend.

FLYING ROSE (S Spratt) - Checked approaching the 100 metres.

M McNab (ASCENSION) - Admitted a charge of careless riding in that he angled his mount outwards when not sufficiently clear of FLYING ROSE which was checked approaching the 100 metres. After considering submissions the Adjudicator imposed a suspension of M McNab's licence to ride in races from the conclusion of racing on Saturday 7 December up to and including racing on Friday 13 December, 4 national riding days.

Race 3 | MONDIALE VGL MAIDEN 2YO 1100

The start of this race was delayed by approximately 3 minutes due to CIRCUS TRIX proving difficult to load.

CIRCUS TRIX (V Colgan) - Proved difficult to load. Co-trainer B Foote was advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next. Lay outwards when placed under pressure near the 200 metres having to be corrected by its rider.

TORETTO (R Elliot) - Slow to begin.

BELLATRIX (S Spratt) – Raced wide in the early stages.

NIGHT WOLF (M Hashizume) – Raced wide without cover throughout. Contacted passing the 300 metres.

DOROTHEA (M McNab) - Raced greenly passing the 300 metres shifting outwards making contact with NIGHT WOLF.

Race 4 | **SOVTECH 1200**

OH NO NO NO (B Jacobson) - Slow to begin. Held up until passing the 300 metres.

TEXAS HOLD 'EM (C Grylls) - Restrained to obtain cover in the early stages from the outside barrier.

FULL NOISE (A Lawson-Carroll) - Raced keenly through the middle stages.

Race 5 | **ARMACUP 3YO STAKES 1500 (Listed Race)**

ALTARI (V Colgan) - Began awkwardly. When questioned regarding the performance the rider advised that he had been disappointed, however, could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

LEVAKIA (S Spratt) - Raced in restricted room having to be steadied near the 1100 metres.

BOURBON PROOF (M McNab) - Held up before shifting across heels to obtain clear running near the 200 metres.

Race 6 | **NHR GROUP 1300**

POUR THE WINE (V Colgan) – Crowded leaving the barriers losing ground. Held up early in the final straight before shifting outwards to obtain clear running near the 250 metres.

OPEN MINDED (M McNab) - Crowded and checked passing the 1150 metres.

MACTHIEF (U Holmquist) – Crowded having to be steadied passing the 1150 metres. Raced three wide without cover throughout.

SHAMUS (A Lawson-Carroll) - Underwent a post-race veterinary and endoscopic examination which revealed a small laceration inside the right nostril.

G Rooke (ROCABABY) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear crowding MACTHIEF and OPEN MINDED near the 1150 metres. After considering submissions the Adjudicator imposed a suspension of G Rooke's licence to ride in races from the conclusion of racing on Saturday 7 December up to and including racing on Friday 13 December, 4 national riding days.

Race 7 | **BAYLEYS GREAT NORTHERN CHALLENGE STAKES 1600 (G3)**

MEANINGFUL STAR (M McNab) – Crowded leaving the barriers losing ground.

ISLINGTON LASS (J Doyle) - Slow to begin.

AEGON (V Colgan) - Restrained to obtain cover in the early stages from an outside barrier.

SAINT BATHANS (G Rooke) - Raced wide in the early stages before improving forward to sit outside the leader near the 1100 metres.

SUMI (M Hashizume) - Held up before shifting across heels to obtain clear running near the 300 metres.

Race 8	CURE KIDS 1100
<p>KINGFISHER (R Elliot) - Began awkwardly losing ground.</p> <p>TANGANYIKA (G Rooke) - Restrained to obtain cover in the early stages from the outside barrier. Had difficulty obtaining clear running early in the final straight.</p> <p>KIVA HAN (R Goyaram) - Raced three wide without cover throughout.</p> <p>SCREAMIN EAGLE (S Spratt) - Steadied when placed in restricted room when weakening approaching the 100 metres when runners either side shifted ground slightly.</p> <p>SEAMSEW (S Weatherley) - Underwent a post-race veterinary examination which did not reveal any abnormality.</p>	
Race 9	BUY KIWI 2100
<p>SPECTRIER (M Hashizume) - Escaped riderless during the preliminary dislodging the rider who was uninjured before being recaptured to undergo a pre-race veterinary examination and was cleared to start.</p> <p>REBECCHI (M McNab) - Began awkwardly losing ground.</p> <p>APACHE ANNE (A Lawson-Carroll) - Restrained to obtain cover in the early stages from the outside barrier.</p> <p>MARKET SQUARE (G Rooke) – Raced ungenerously for a distance passing the 1700 metres.</p> <p>IN THE LOOP (L Satherley) – Raced keenly through the early and middle stages.</p> <p>LADY PAPPYGATE (V Colgan) - Steadied when placed in restricted room passing the 1700 metres when RAMBLIN' ROSE shifted in and MARKET SQUARE shifted out when racing ungenerously with LADY PAPPYGATE then racing keenly for a distance. Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary inspection which found the mare to have experienced an episode of Epistaxis. LADY PAPPYGATE shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.</p> <p>UP THE ANTI (R Elliot) - Lay out when placed under pressure over the concluding stages.</p>
