<b>RACE COMMENTS</b>	
<b>Race 1</b>	<b>DAVE HOSKIN CARRIERS MAIDEN 2040m</b>
<p><b>LADY'S SECRET</b> (H Grace) - Slow away.</p> <p><b>SCAMANDER</b> (L Kauri) - Restrained from a wide draw to obtain cover.</p> <p><b>SELDOM SEEN</b> (M Singh) - Taken forward from a wide draw.</p> <p><b>CRAFTSMAN</b> (J Riddell) - – Raced keenly in the early stages. Improved on to heels having to be steadied near the 1400 metres.</p> <p><b>HURRY HOME</b> (E Sole) - Raced three-wide without cover in the early stages.</p> <p><b>PERFECT JUNE</b> (W Pinn) - Was not ridden out fully over the final 100 metres when rider W Pinn considered there was something amiss. A post-race veterinary examination revealed the mare to be 3/5 lame in the off foreleg. Connections were advised PERFECT JUNE requires a veterinary clearance prior to racing next.</p> <p><b>GREY INVADOR</b> (N Parmar) - Lay inwards under pressure rounding the final bend and throughout the straight.</p> <p><b>CLEO'S MAGIC</b> (A Riddell) - Held up early in the home straight, having to be angled outwards to obtain clear running near the 200 metres.</p> <p><b>M Sanson</b> (COLIN THE FOX) - Reminded of her obligations regarding the use of her whip on a runner out of contention.</p> <p><b>N Parmar</b> (GREY INVADOR) - Spoken to regarding his whip use in the home straight.</p>	
<b>Race 2</b>	<b>BOSS HOMES LTD 1200m</b>
<p><b>HEMI RIDAPEST</b> (T Newman) - Jumped away awkwardly, contacting IT'S DORIS. Raced keenly in the early stages and had to be heavily restrained for some distance off heels near the 1100 metres.</p> <p><b>IT'S DORIS</b> (C Barnes) - Contacted at the start. Jostled with TIVACI PRINCESS near the 900 metres. Returned to the enclosure with blood present in the nasal area. Underwent a post-race veterinary inspection which found the mare to have experienced an episode of Epistaxis. IT'S DORIS shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian. Trainer R Patterson advised IT'S DORIS has been retired as a racing proposition from his stable.</p> <p><b>LEINSTER</b> (M Hudson) - Shifted inwards near the 900 metres, dictating TIVACI PRINCESS inwards.</p> <p><b>TIVACI PRINCESS</b> (N Parmar) - Jostled with IT'S DORIS near the 900 metres.</p> <p><b>FREE BEE</b> (K Hercock) - Raced wide throughout.</p> <p><b>M Hudson</b> (LEINSTER) - Issued with a warning after allowing her mount to shift inwards near the 900 metres dictating TIVACI PRINCESS inwards, which jostled with IT'S DORIS for a short distance.</p>	
<b>Race 3</b>	<b>WANGANUI MOTORS AND THE DYKE FAMILY MAIDEN 1600m</b>
<p><b>RED RIBBON</b> (C Lindsay) - Slow away.</p>	

**WYWORRY** (L Douglas) - Restrained when racing in restricted room near the 1450 metres, then raced keenly for a distance.

**A SENSIBLE PRINCE** (M Singh) - Got back at the start. Restrained when improving on to heels near the 1450 metres. Held up rounding the home turn and when attempting to improve, clipped the heels of JULIANUS and blundered. When questioned, M Singh advised that despite getting further back than intended and suffering interference on the turn, the gelding only battled over the final stages and was disappointing.

**FIRST EDITION** (L Hemi) - Restrained off heels near the 900 metres.

**DOCTOR ASKAR** (C Barnes) - Disappointed. Rider advised the gelding pulled up in a normal post-race condition and in her opinion is better suited to more rain-affected going.

**Race 4** | **GAS & HEATING 1600m**

**PHATS** (L Kauri) - Slow away.

**THE CHOPPER** (C Barnes) - Slow away.

**YELLOW JERSEY** (L Sutherland) - Raced keenly in the early stages.

**MISS EMERALD** (T Newman) - Raced keenly in the early stages.

**GOD OF EROS** (N Parmar) - Held up entering the home straight, having to be angled outwards near the 200 metres to obtain clear running.

**LOVELY RITA** (C Lindsay) - Raced wide throughout. Would not hit out fully over the final stages. When questioned, rider was of the opinion the mare would prefer more rain-affected footing. Underwent a post-race veterinary examination which did not reveal any abnormality.

**L Kauri** (PHATS) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicative Committee imposed a fine of \$250.

**Race 5** | **PALAMOUNTAINS ANIMAL NUTRITION 1600m**

**SCELTA DI ELENA** (J Chung) - Began awkwardly.

**UNSCRIPTED** (L Sutherland) - Slow away.

**TITLED** (T Newman) - Slow away. Following the event, T Newman reported her mount had lost traction behind near the 500 metres. After viewing footage T Newman was satisfied her mount had become unbalanced when changing legs and laying inwards.

**ARCADIAN IYNX** (N Parmar) - Raced keenly in the early stages.

**MCKHAN** (L Kauri) - Raced keenly in the early stages.

**PLATINUM SIXTY SIX** (W Pinn) - Held up entering the final straight.

**NIGELLA LANE** (J Riddell) - Had to angle outwards inside the final 100 metres to gain clear running.

**ILLUSION OF PARIS** (M Singh) - Dropped out after contesting the lead in the early and middle stages. Rider reported the mare may benefit from today's fresh-up run.

<b>Race 6</b>	<b>THE O'LEARYS FILLIES STAKES (Listed Race) 1340M</b>
<p><b>ROCSTOKIN BARREL</b> (J Chung) - Slow away.</p> <p><b>ROMILLY</b> (L Sutherland) - Began awkwardly, contacting CONNELLO. Held up in the home straight and was unable to obtain clear running until inside the final 100 metres.</p> <p><b>CONNELLO</b> (C Dell) - Contacted at the start. C Dell was reminded of his obligation to ride his mounts out fully to the finish, after it was observed he relaxed his ride over the final stages.</p> <p><b>RENOVATIONS</b> (H Grace) - Shifted inwards near the 900 metres, tightening DEBBI HARRI and VESPHIRE, with VESPHIRE making contact with the running rail.</p> <p><b>DEBBI HARRI</b> (T Newman) - Raced keenly in the early stages. Tightened near the 900 metres. Rider reported the filly felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> <p><b>VESPHIRE</b> (L Hemi) - Tightened near the 900 metres, making contact with the running rail.</p> <p><b>PRETISSIMO</b> (K Hercock) - After finishing some distance last, rider advised the filly would be better suited to more rain-affected tracks.</p> <p><b>H Grace</b> (RENOVATIONS) - Admitted a charge of careless riding in that he permitted RENOVATIONS to shift inwards near the 900 metres, tightening DEBBI HARRI and VESPHIRE, with VESPHIRE making contact with the running rail. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 7 December, until the conclusion of racing on Sunday, 15 December, 6 national riding days.</p>	
<b>Race 7</b>	<b>STEELFORM ROOFING GROUP WANGANUI CUP (Listed Race) 2040m</b>
<p><b>NON DE PLUME</b> (M Hudson) - Hampered at the start losing ground. When questioned, rider reported the mare did not put in at any stage and was very disappointing. A post-race veterinary examination revealed the mare to have suffered cardiac arrhythmia. Trainer R Patterson was advised that NON DE PLUME will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.</p> <p><b>TRAV</b> (M Singh) - Slow away.</p> <p><b>URENUI</b> (N Parmar) - Raced three-wide without cover in the early and middle stages.</p> <p><b>PRIDE OF ASPEN</b> (W Pinn) - Improved on to heels near the 900 metres, having to be restrained.</p>	
<b>Race 8</b>	<b>LOADERS WANGANUI 2040m</b>
<p>The start of this race was put back one race, until 5.25pm, after WHO'S COMPLAININ (L Kauri) dislodged the rider in the preliminary, who was transferred to hospital for further assessment. Stewards made inquiries and were advised by paramedics that there were no other ambulance vehicles available in Whanganui at that present time and were unable to guarantee a time when a vehicle would become available. After consultation with Club officials, Stewards made the decision to abandon the last race.</p> <p><b>WHO'S COMPLAININ</b> (L Kauri) - Late scratching at 4.45pm after dislodging rider L Kauri during the preliminary and refusing to parade. L Kauri is required to provide a medical certificate prior to riding next. Stewards advised Trainer B</p>	

Crow that due to WHO'S COMPLAININ'S poor behaviour record, the gelding has been stood down from racing until further notice.
