Race 7 - WINDSOR NEW WORLD MAIDEN 1600m

CHANCE (D Bothamley) - Trainer Ms A Hewitson reported to Stewards that on Monday 2 December CHANCE was seen by the chiropractor and treated for overall general soreness. A Hewitson further advised it is her intention to carry on with the gelding's current preparation.

Race 9 - RYAL BUSH TRANSPORT & WAYNE "OX" MCEWAN MEMORIAL 1600m

GINTYS GIRL (K Williams) - Co-trainer Mr G Eade reported to Stewards that on Tuesday 26 November GINTYS GIRL underwent a veterinary examination including blood tests, which revealed a slight virus and was placed on a four day treatment. G Eade further advised it is the stable's intention to continue with the mare's current preparation where they may look to nominate GINTYS GIRL for the Southland RC meeting on Saturday 14 December.

Central Otago Racing Club @ Cromwell - Friday 29 November 2024

Race 7 - GIRL ON THE GROUND & URBAN FENCING HANDICAP 2030m

VAMOS (K Williams) - Trainer Mr K Tyler reported to Stewards that he was satisfied with the post-race condition of the gelding and it is his intention to carry on with VAMOS's current preparation, where he may look to nominate him for the Southland RC meeting on Saturday 14 December.

Race 8 - A1 HOMES & A WOMANS TOUCH CLEAN 2030m

LADYSWEY (T Moseley) - Trainer Mr M Jones advised Stewards he was satisfied with the post-race condition of the mare however LADYSWEY has now been sent for a spell.

RACE COMMENTS

Race 1 SPEIGHT'S SUMMIT ULTRA ON TAP HANDICAP 2100m

RAARDY RAAR (K Mudhoo) - Declared a late scratching behind the barriers at 2:57pm on veterinary advice when found to have grade 2 lameness in the leg hind leg. Connections were advised that a veterinary clearance is required prior to racing next.

MUZZLE CAT (T Moseley) - Restrained to obtain cover after jumping from the outside barrier.

CHASE 'N' GOLD (L Hemi) - Slow to begin before being further hampered when contacted by DEVIL IN DISGUISE.

HUTSON (L Callaway) - Steadied when placed in restricted room to the inside of MISSYWOOD which shifted inwards when not fully clear passing the 1900 metres. Had to be steadied away from the heels of the tiring CHASE 'N' GOLD near the 500 metres.

MISSYWOOD (D Montes de Oca) - Briefly steadied to avoid the heels of MORUS (K Williams) when that runner shifted inward near the 1700 metres. K Williams was advised to exercise greater care. Under pressure passing the 500 metres eventually finishing a distant last, with the rider advising that the mare had not seen out the distance of today's race. A post-race veterinary inspection revealed a slow recovery rate. Stewards will follow up with connections in coming days.

HEY MICKEY (Y Atchamah) - Briefly held up near the 400 metres.

D Montes de Oca (MISSYWOOD) - Issued with a warning when shifting ground placing HUTSON in restricted room and having to be steadied passing the 1900 metres.

Race 2 JOIN TAB RACING CLUB 2100m

SINCERE (B May) - Jumped away awkwardly before being further hampered when crowded between runners.

FRANNI CACCINI (H Grace) - Slow away.

ARISTOCRAT (K Williams) - Briefly steadied when placed in restricted room to the inside of TIARA ROSE passing the 75 metres, before again being steadied when placed in restricted room just short of the finish.

CAN'T KACH ME (W Pinn) - When questioned regarding performance, rider advised that the mare felt indifferent in its action in the run home when placed under pressure. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality. Stewards will follow up with connections in coming days.

MALFY ROSA (J Doyle) - Underwent a post-race veterinary inspection which revealed a poor recovery rate. Stewards will follow up with connections in coming days.

Race 3 RJ BEGG ORAL SURGERY MAIDEN 1600m

PIRATES 'N' GOLD (T Jonker) - Slow away.

BRUSSET (B May) - Jumped away awkwardly losing ground. Steadied when racing in restricted room to the inside of PIRATES 'N' GOLD as the field made the bend near the 1300 metres.

PERSONA (T Comignaghi) - When questioned regarding performance, rider could offer no tangible excuse. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

T Jonker (PIRATES 'N' GOLD) - Issued with a warning after permitting her mount PIRATES 'N' GOLD to shift inwards placing BRUSSET in restricted room near the 1300 metres. Issued with a warning after using her whip on PIRATES 'N' GOLD when out of contention. Stewards enquired into whip use by T Jonker, in particular passing the 50 metres, but could not be sure she had breached the consecutive whip use rule.

Race 4 JENNIAN HOMES CANTERBURY MAIDEN 1200m

RED STAR BELLA (T Moseley) - Declared a late scratching at 4:41pm after refusing to enter the barriers. Connections were advised that RED STAR BELLA must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next. As a result this race ran approximately 4 minutes late.

SPEED DIAL (A Goindasamy) - Steadied to avoid the heels of EL TIEMPO (U Holmquist) which shifted inwards when not fully clear near the 900 metres. U Holmquist was advised to exercise greater care. Held up near the 400 metres until obtaining clear running near the 300 metres.

PORCIA CATONIS (H Grace) - Raced three wide without cover.

PICK UP THE BLAZE (B May) - Shifted outwards under pressure passing the 150 metres having to be straightened by the rider.

FAH RONG (D Cooper) - Lay in near the 150 metres and when being straightened became awkwardly placed on the heels of ALI NEL which shifted inwards having to be steadied, and when doing so shifted in briefly crowding EL TIEMPO.

EL TIEMPO (U Holmquist) - Crowded when tiring near the 100 metres.

QUEEN CONSORT (W Pinn) - When asked to comment on performance, rider could offer no tangible excuse other than the filly would benefit from its first race day outing.

Race 5 NATIVE SOLUTIONS 1200m

GIANNIS (K Williams) - Reared at the start losing ground. Rider reported in her opinion the gelding had resented the addition of a nose band today, leading to a disappointing performance.

KINDRED SPIRIT (T Comignaghi) - Jumped away awkwardly losing ground.

THATS CHARMING (Y Atchamah) - Restrained to obtain cover after jumping from a wide barrier.

HEAD FIRST (T Moseley) - Raced three wide without cover.

KNOWLEDGE IS POWER (W Pinn) - Shifted outwards making contact with ELUSIVE IMPACT passing the winning post.

ELUSIVE IMPACT (U Holmquist) - Contacted passing the winning post.

Race 6 PENINSULAR BEACH RESORT MOOLOOLABA 1400m

CHAIRMAN (F Moerman) - Slow away. Commenced to over race when being restrained near the 1100 metres, becoming awkwardly placed when improving inside the heels of GEMMA FLITZ.

HEY NOW (T Moseley) - Raced three wide without cover. When questioned, rider advised he had been trapped wide throughout which had led to the disappointing performance.

MAGNETO (K Williams) - Got its head up when over racing in the early stages.

GEMMA FLITZ (D Cooper) - Became awkwardly placed inside the heels of CARAVELLA when racing keenly passing the 1000 metres having to be briefly steadied.

Race 7 NORTH CANTERBURY ENERGY CENTRE HANDICAP 1400m

ANALYST (A Goindasamy) - Jumped away awkwardly.

MISS SAILOR (T Moseley) - Slow away.

HIGHLAND FLING (H Grace) - Restrained to obtain cover after jumping from a wide barrier.

LA CERVEZA (C Campbell) - Raced ungenerously when being restrained passing the 1000 metres. Reported to have hung throughout the running, with trainer J Land advising she will be reassessing the racing future of the gelding.

BRACERO (L Hemi) - Raced wide without cover for the majority of the race.

SWAY UP (R Jaun) - Held up passing the 200 metres and when placed under pressure lay outwards over the concluding stages having to be straightened. Stewards questioned R Jaun in the presence of the Apprentice Riding Mentor in regard to his riding, particularly from the 600 metres. Of concern to Stewards was his lack of vigour from the 600 metres. After taking evidence from R Jaun, Stewards adjourned the inquiry to a later date.

TOA HAKA (W Pinn) - Rider W Pinn was dislodged post-race and stood down from his remaining ride suffering from a sore back and replaced as per above Summary.

Race 8 RACECOURSE HOTEL & MOTOR LODGE 1600m

CHEQUERED (C Campbell) - Slow away.

GIVEALITTLE (H Grace) - Slow away.

MR BULLY TEE (J Doyle) - Restrained to obtain cover after jumping from the outside barrier. Rider was of the opinion the gelding was not suited to synthetic racing. Trainer L Robinson advised he would restrict the gelding to grass racing and make some changes.

WARLAC (D Cooper) - Raced wide without cover through the early and middle stages. Rider advised that the mare had held her breath during the running.

MISCHIEF MANAGED (F Moerman) - Lay in making contact with the running rail near the 1100 metres.
