**RACE COMMENTS****Race 1** | **DUNSTAN HORSEFEEDS STAYERS CHAMPIONSHIP QUALIFIER 2100**

**SON OF SUN** (A Goindasamy) - Raced keenly through the early and middle stages.

**OUTOVSTOCK** (A Lawson-Carroll) - Raced keenly through the early and middle stages.

**MY MAEBELLINE GIRL** (L Satherley) - Raced keenly through the early and middle stages.

**TERRA MITICA** (W Kennedy) - Held up for clear running until near the 200 metres.

**ARBY** (M Cartwright) - Had some difficulty obtaining clear running early in the final straight before improving onto heels having to be steadied near the 50 metres.

**Race 2** | **TRELAWNEY STUD MAIDEN 1600**

**PENNINE WAY** (R Elliot) - Slow to begin.

**ALAVISTO** (L Satherley) - Crowded shortly after the start losing ground.

**GIVEUSAWINK** (V Colgan) - Began awkwardly losing ground. Steadied off heels when racing keenly near the 1200 metres then continued to race keenly for a distance before having to be firmly restrained off heels near the 1000 metres then continued to over-race through the middle stages.

**BERENHARD** (W Kennedy) – Raced keenly through the early and middle stages when leading. Lay outwards when placed under pressure in the final straight.

**VADASHA** (G Rooke) - Improved onto heels passing the 1000 metres having to be firmly restrained for a distance.

**W Kennedy** (BERENHARD) - Reminded of his obligations regarding the manner in which the pace steadied passing the 1000 metres placing trailing runners in some difficulty.

**N Parmar** (MEISHO TOOT) - Reminded of his obligations regarding the manner in which the pace steadied passing the 1000 metres placing trailing runners in some difficulty.

Following this race the track was upgraded to Good 4.

**Race 3** | **DUNSTAN HORSEFEEDS STAYERS CHAMPIONSHIP QUALIFIER 2100**

**ABOUT TIME** (W Kennedy) – Reared in the barriers dislodging its rider who was uninjured. Steadied to avoid the heels of NOVAK which shifted in slightly when making the crossing near the 1700 metres. Contributing was slight outward movement from LIQUID FIRE. U Holmquist was advised to exercise greater care in similar circumstances.

**ASGARD** (A Lawson-Carroll) - Slow to begin.

**GOLDEN** (M Hashizume) – Crowded shortly after the start losing ground. Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which found the mare to have experienced an episode of bilateral Epistaxis. GOLDEN shall not be ridden in exercise for a period of two months or start in any race or

trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

**LIQUID FIRE** (V Colgan) - Raced keenly through the middle stages.

**ROEDERER** (G Rooke) – Rider dropped his whip near the 150 metres. Steadied when placed in restricted room passing the 100 metres when PACIFICO shifted outwards and FINAL RETURN shifted in slightly.

**JOLTED** (R Elliot) - When questioned regarding the performance the rider advised that the mare may be better suited to more give in the ground.

**R Goyaram** (PACIFICO) - Issued with a warning for permitting his mount to shift out when not sufficiently clear of ROEDERER which had to be steadied when placed in restricted room near the 100 metres. Also contributing was slight inward movement from FINAL RETURN.

Following the running of this race connections of the fourth placed runner ROEDERER lodged a protest against the third placed runner PACIFICO alleging interference near the 100 metres. After considering submissions the Adjudicative Committee dismissed the protest with placings standing 1<sup>st</sup> ABOUT TIME, 2<sup>nd</sup> FINAL RETURN, 3<sup>rd</sup> PACIFICO, 4<sup>th</sup> ROEDERER.

**PAX MUNDI** (M Cartwright) - Slow to begin.

**ROCHMIE RAY** (W Kennedy) - Restrained to obtain cover in the early stages from the outside barrier.

**MISS MARTINI** (G Rooke) - Lay outwards when placed under pressure passing the 250 metres briefly inconveniencing GOOD SPOT.

**GOOD SPOT** (N Parmar) – Briefly inconvenienced passing the 250 metres.

**IRISH LEGACY** (R Elliot) - Held up for clear running until near the 200 metres.

**MALT TIME** (A Lawson-Carroll) - Slow to begin.

**WAITAK** (M Hashizume) - Slow to begin.

**SACRED SATONO** (G Rooke) – Raced three wide without cover throughout. Lay outwards when placed under pressure passing the 100 metres.

**BONNY LASS** (M Cartwright) - When questioned regarding the performance the rider advised that he had been disappointed however could offer no excuse. Underwent a post-race veterinary examination including an endoscopic examination which found the mare to have mucous in the trachea and an indication of mild inflammation in the upper airway.

<b>Race 6</b>	<b>BONECRUSHER STAKES 3YO 1400 (G3)</b>

**UNBRIDLED JOY** (A Lawson-Carroll) - Restrained to obtain cover in the early stages from an outside barrier. Contacted becoming unbalanced and forced wider passing the 400 metres.

**CRACKERCOL** (A Goindasamy) - Slow to begin. Improved onto heels just prior to the winning post.

**HONEY BADGER** (G Rooke) - Began awkwardly losing ground.

**SETHITO** (S Spratt) - Raced wide in the early stages before improving forward to sit outside the leader near the 800 metres.

**RIBKRAKA** (L Satherley) – Shifted ground outwards when not sufficiently clear passing the 400 metres contacting UNBRIDLED JOY.

**WHISKEY 'N' ROSES** (V Colgan) - When questioned regarding the performance the rider advised that the gelding would benefit from some easing in the ground.

**L Satherley** (RIBKRAKA) - Admitted a charge of careless riding in that she permitted her mount to shift outwards making contact with UNBRIDLED JOY which was contacted and unbalanced passing the 400 metres. After considering submissions the Adjudicative Committee imposed a suspension of L Satherley's licence to ride in races from the conclusion of racing on Saturday 14 December up to and including racing on Friday 20 December, 4 national riding days.

**Race 7** | **BARFOOT & THOMPSON 1400**

**EPARAIMA** (M Hashizume) - Slow to begin. Held up for clear running throughout the final straight.

**DIMAGGIO** (R Elliot) - Began awkwardly.

**FRANCEE** (V Colgan) - Had difficulty obtaining clear running throughout the final straight.

**LEROY BROWN** (U Holmquist) - Lay out when placed under pressure throughout the final straight.

**IMPERIAL EMPRESS** (W Kennedy) - Held up for clear running until near the 300 metres.

**Race 8** | **SKYCITY 1500**

**SHAKING STEVENS** (R Elliot) - Slow to begin then crowded shortly after.

**HE'S CLASSIC** (N Yuen) - Began awkwardly losing ground then crowded shortly after.

**SABIK** (S Spratt) - Raced three wide without cover throughout. When questioned regarding the performance the rider advised that the gelding would benefit from some easing in the ground.

**AFTERMATH** (V Colgan) - Had to be steadied off heels when racing keenly passing the 1200 metres.

**QUEEN ZOU** (M Cartwright) - Had difficulty obtaining clear running early in the final straight. Shifted out passing the 100 metres making contact with SUBTLE POWER which was forced wider.

**SLIPPER ISLAND** (U Holmquist) - Shifted out and away from SUPER SCHEME which was dictated outwards by DESERT MYSTIC which shifted outwards passing the 300 metres. B Jacobson was advised to exercise care.

**SINHAMAN** (M Hashizume) – Lay in when placed under pressure in the final straight having to shift inwards passing the 200 metres to obtain clear running.

**SUBTLE POWER** (W Kennedy) - Contacted and forced wider by QUEEN ZOU which shifted outwards passing the 100 metres. M Cartwright was advised to exercise care.

**C Ormsby** (RISING TIDE) - Issued with a Minor Infringement and fined \$50 for failing to declare a rider for RISING TIDE by the required time.

Following this race connections of the 2<sup>nd</sup> placed runner viewed Stewards video footage of the final straight before electing not to proceed with a protest against the 1<sup>st</sup> placed runner.
