SUPPLEMENTARY

THE UNDERBELLY (C Grylls) – Trainer Mr. R Patterson advised Stewards, he was satisfied with the post-race condition of THE UNDERBELLY, and it is his intention to carry on with the gelding's current preparation.

RACE COMMENTS

Race 1 WANGANUI FUNCTION CENTRE MAIDEN 1600m

SLEIGHT OF HAND (J Riddell) - Slow to begin. Made the first bend awkwardly. J Riddell reported the gelding was unsuited to the conditions underfoot but nevertheless was disappointing.

GOLDEN LINING (A Riddell) - Slow to begin.

CAPITANI (L Sutherland) - Raced wide in the early stages. Raced greenly early in the home straight.

TU TANGATA (A Lawson-Carroll) - Improved on to heels having to be steadied approaching the 800 metres.

TRIATHLON (C Lindsay) - Raced fiercely throughout. Rider confirmed the gelding had pulled hard and hung throughout placing her at a disadvantage in that she was unable to ride her mount out in the home straight. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

SOL DE OTONO (M Lerner) - Raced greenly early in the home straight.

GODDESS (M Singh) - When questioned regarding the improved performance of GODDESS, Trainer L Tanner advised Stewards the addition of blinkers had contributed to today's improved performance.

M Lerner (SOL DE OTONO) - Admitted a charge in that he used his whip with an action which raised the Rider's arm above shoulder height. After considering submissions the Adjudicative Committee imposed a fine of \$350.

Race 2 PALAMOUNTAINS ANIMAL NUTRITION MAIDEN 1360m

CAN DO (T Davies) - Slow to begin. Lay inwards under pressure in the home straight. Hampered by the fallen runner near the 1100 metres.

TIZZNOT (L Sutherland) - Raced greenly through the early stages. Underwent a post-race veterinary examination at the request of the trainer which revealed abrasions on the hind legs consistent with being galloped on.

AGENT BLACK HAND (J Chung) - Commenced to race keenly near the 1100 metres and improved onto the heels of TIZZNOT, clipping that runner's heels and falling, hampering CAN DO, COULTHARD and EVERENDING. J Chung was attended to by St John ambulance personnel and stood down for the remainder of his rides today. Replacements as above. Underwent a post-race veterinary examination which revealed lameness in the right hind leg. Connections were advised AGENT BLACK HAND requires a veterinary clearance prior to racing next.

COULTHARD (J Riddell) - Hampered by the fallen runner near the 1100 metres.

EVERENDING (K Hercock) - Hampered by the fallen runner near the 1100 metres.

TENSCAPE PRINCE (L Allpress) - Over-raced through the middle stages.

Race 3 BRIAN FM MAIDEN 1200m

WISEMEN'S DIVA (K Hercock) - Underwent and passed a veterinary examination behind the barrier after receiving a kick.

LA DULCIN'EE (L Allpress) – Hampered shortly after the start. Over-raced in the early stages. Checked approaching the 100 metres.

MARYROSE (A Lawson-Carroll)- Shifted inwards approaching the 100 metres, checking LA DULCIN'EE (L Allpress). Lay outwards over the concluding stages

PERSONALLY (M Lerner) – Hampered shortly after the start. Bumped IT'S AMELIA entering the home straight. Held up for the majority of the home straight.

IT'S AMELIA (L Hemi) - Bumped entering the home straight, becoming unbalanced.

K Hercock (WISEMEN'S DIVA) – was advised to exercise greater care after allowing her mount to shift in shortly after the start hampering PERSONALLY (M Lerner), which in turn shifted in hampering LA DULCIN'EE (L Allpress).

Following the running of the race the rider of the second placed horse LA DULCIN'EE, L Allpress lodged a protest with the Adjudicative Committee alleging interference in the final straight by the first placed horse MARYROSE. After considering submissions the Adjudicative Committee dismissed the protest.

A Lawson-Carroll (MARYROSE) - Admitted a charge of careless riding in that he permitted MARYROSE to shift inwards when not sufficiently clear of LA DULCIN'EE, which was checked approaching the 100 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 4 January 2025, until the conclusion of racing on Saturday, 11 January 2025, 6 days.

Race 4 HAPPY HIRE MAIDEN 2060m

ALTEZZA (M Hudson) - Began awkwardly, hampering outside runners.

GREY INVADOR (M Lerner) - Hampered at the start.

HE'S TIKETIBOO (T Davies) - Hampered at the start. Raced keenly for a distance shortly after the start.

BLUE JEANIE (K Chowdhoory) - Hampered at the start.

HIGHLY LETHAL (M Singh) - Raced wide through the early and middle stages and over-raced when being restrained to the rear. Lay inwards over the concluding stages.

DUBAI'S POTIKI (A Lawson-Carroll) - Hung outwards throughout, making the final bend awkwardly, laying outwards and hampering UNDERLINE. Weakened over the concluding stages. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

UNDERLINE (L Sutherland) - Hampered on the final bend having to be steadied.

Race 5

WANGANUI-TARANAKI RACEHORSE OWNERS ASSOCIATION 1200m

PARTY ROCKING (M Lerner) - Underwent and passed a pre-race veterinary examination behind the barriers after contacting a gate when leaving the birdcage. Connections were advised a warning has been placed against the gelding's pre-race manners.

BRAZINCO (A Lawson-Carroll) - Slow to begin.

DUNEAGLE (M Singh) - Raced wide throughout.

SCELTA DI ELENA (L Hemi) - Lay outwards rounding the final bend. Held up for the majority of the home straight having to angle outwards near the 100 metres to gain clear racing room.

SCORCHA (J Riddell) - Finished well back. Rider was unable to offer any excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

FRENCH ROSE (L Allpress) - Finished well back. Rider was unable to offer any excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

Race 6 SHANE STONE BUILDERS 1360m

LOVE JANIE (A Lawson-Carroll) - Began awkwardly hampering HORONUKU.

VEE VEE (J Riddell) - Began awkwardly hampering HORONUKU.

HORONUKU (M Lerner) - Hampered at the start, losing ground, when runners either side shifted ground.

FABULOUS GAL (L Hemi) - Began awkwardly, hampering ANUSHKA SHESASTAR.

TIVACI'S AFFAIR (L Allpress) - Began awkwardly, hampering ANUSHKA SHESASTAR.

ANUSHKA SHESASTAR (L Sutherland) - Hampered at the start when runners either side shifted ground.

METAVERSE (K Chowdhoory) - Lost the right front plate during the running.

Race 7 WANGANUI INSURANCE BROKERS 1600m

ROCABURY (M Hudson) - Dislodged the rider during the preliminary but was quickly recaptured and cleared to race following a veterinary examination. M Hudson was uninjured.

SHEAF (L Allpress) - Slow to begin.

NEVER LOOK BACK (T Davies) - Held up for clear racing room throughout the home straight, having to angle outwards inside the final 50 metres to gain clear racing room.

Race 8 BEST WISHES & KA KITE ANO DEBBIE 2060m

LOVE NESST (E Sole) - Slow to begin.

VERARDINO (A Lawson-Carroll) - Restrained to obtain cover from its wide draw.

MOSSRAAJ (K Hercock) - Raced wide throughout. Lay inwards under pressure over the concluding stages.

ZACKERY (U Holmquist) - Held up rounding the final bend.

K Chowdhoory (LEAVE A LIGHT ON) - Admitted a charge of careless riding in that he permitted LEAVE A LIGHT ON to shift inwards when not sufficiently clear of MOSSRAAJ, which checked near the 1800 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Thursday, 2 January, until the conclusion of racing on Thursday, 16 January, 10 national riding days.

J Riddell (ANDERSONS BAY) and T Davies (CHERISHED LADY) reported that their respective mounts had slipped rounding the bend going into the back straight near the 1400 metres. J Riddell advised Stewards he was concerned with the contour of the running rail at that particular point. Stewards met with Club officials who advised that they would rectify the situation prior to the next race meeting.
