KEEGAN (J Doyle) - Co-trainer B Foote reported to Stewards the stable was satisfied with the post-race condition of KEEGAN, and it is his intention to carry on with the gelding’s current preparation.

Race 11 ARDEX TECHNOLOGY INTRODUCING EPONA MAIDEN 1400m

PROUDTOBEHERE (W Kennedy) – Trainer A Forsman reported to Stewards PROUDTOBEHERE underwent a veterinary examination on Friday 29 November, which included a dynamic endoscopic examination which showed abnormalities with the mare. A Forsman further advised that on Thursday 5 December, a wind operation was performed on PROUDTOBEHERE, and the mare has now been sent for a spell.

Race 2 ARAWA PARK HOTEL MAIDEN 1230m

CAMEL SAUCE (W Pinn) – Co-trainer A Scott reported to Stewards that on Thursday 5 December, CAMEL SAUCE, underwent a veterinary examination which revealed the filly showing signs of being shin sore. A Scott further advised the filly has now been sent for a brief spell.

RACE COMMENTS

Race 1 TAB 1600

TURNMEON (R Goyaram) - Slow away.

HANAIEI STAR (W Pinn) – Restrained in the early stages to obtain cover after jumping from the outside barrier.

IN THE LOOP (C Barnes) - Contacted and unbalanced near the 400 metres.

R Goyaram (TURNMEON) - Admitted a charge of careless riding in that he permitted his mount to shift outwards when not sufficiently clear of IN THE LOOP which was contacted and unbalanced near the 400 metres. After considering submissions the Adjudicator imposed a suspension of R Goyaram’s licence to ride in races from the conclusion of racing on Monday 23 December up to and including racing on Tuesday 31 December, 6 national riding days.

Race 2 CAMBRIDGE STUD 1200

SWERVE (L Satherley) – Jumped away awkwardly after anticipating the start making contact with the front of its barrier stall which then opened marginally early. Stewards were satisfied that the gelding did not obtain any unfair advantage. Raced three wide without cover throughout. Lay outwards when placed under pressure near the 200 metres.

FERNANDEZ (A Lawson-Carroll) – Jumped away awkwardly inconveniencing OH NO NO NO and FIRST DANCE. Steadied losing ground near the 200 metres.

OH NO NO NO (J Nishizuka) - Inconvenienced at the start. Contacted over the concluding stages.

FIRST DANCE (W Kennedy) - Inconvenienced at the start. When questioned regarding the performance rider advised that the filly peaked on its run and would derive benefit from today’s race.

GOLDILUXE (S Spratt) - Lay outwards when placed under pressure contacting OH NO NO NO over the concluding stages.

J Nishizuka (OH NO NO NO) - Issued with a warning after permitting his mount to shift inwards when not fully clear of FERNANDEZ which had to be steadied off heels near the 200 metres. When assessing this incident Stewards took into account that SWERVE contributed when shifting ground outwards simultaneously near the 200 metres.

Race 3 | **STELLA ARTOIS MAIDEN 1200**

DISTINGUISHED (J Fawcett) – Jumped away awkwardly making contact with the hindquarters of CHLOE’S COMET losing ground. Had to be steadied off the heels of ZAHTAR passing the 1000 metres. R Goyaram was advised to exercise greater care when shifting ground. Had difficulty obtaining clear running until near the 150 metres.

CRIMSON MISS (J Doyle) - Slow away. Held up for clear running until near the 150 metres.

PADDY HILL (R Elliot) – Jumped away awkwardly then being restrained to obtain cover. Connections were advised that a warning would be placed against the gelding’s barrier manners and performance (uncompetitive). Became detached from the body of the field passing the 600 metres and finished a distant last. When questioned, rider could offer no explanation. Underwent a post-race veterinary examination which revealed no abnormalities.

ZAHTAR (R Goyaram) - Shifted ground inwards when not fully clear of DISTINGUISHED which had to be steadied off heels passing the 1000 metres.

PERFECT DIVIDENDS (S Spratt) - Raced wide through the early and middle stages.

CHLOE’S COMET (S Weatherley) - Had difficulty obtaining clear running until near the 200 metres. When questioned regarding the performance rider advised that he was disappointed with the mare’s effort and could offer no explanation.

SANTARELLI (W Pinn) - Hung inwards under pressure in the final straight. When questioned regarding his ride over the concluding stages when narrowly beaten for second placing, W Pinn advised that the mare had hung badly throughout and after changing leg near the 100 metres the mare had felt indifferent in its action over the concluding stages. Underwent a post-race veterinary examination which did not reveal any obvious abnormality. Stewards will follow up with connections on the post-race condition of the mare in the coming days.

FIRST UP (V Colgan) - When questioned regarding the performance rider advised that the filly raced greenly throughout.

W Pinn (SANTARELLI) - Issued with a charge in that he failed to ride his mount SANTARELLI out fully to the end of the race when there was a reasonable chance of finishing in second placing. W Pinn indicated that he wished to defend the charge however needed to travel to the hospital for assessment of a back injury which was aggravated when being dislodged behind the barriers prior to Race 5. Accordingly, the Adjudicator adjourned the hearing until a date to be set.

Race 4 | **ENTAIN/NZB PEARL SERIES MAIDEN 1400**

BONITA (R Elliot) - Slow away before being further hampered when crowded.

LOVE SYMBOL (W Kennedy) - Jumped away awkwardly. Steadied to avoid heels near the 1200 metres losing ground.

SABRINA HALL (C Grylls) - Jumped away awkwardly making contact with STAPHANOS QUEEN.

STAPHANOS QUEEN (M Carwright) – Contacted leaving the barriers.

SATIN DOLL (J Doyle) - Made the bend near the 1200 metres awkwardly when having to be restrained to avoid the heels of CHATEAU VALLEE and shifted outwards forcing STAPHANOS QUEEN into the line of LOVE SYMBOL which had to be steadied away from that runner's heels losing ground. Raced three wide without cover throughout. Contacted approaching the 600 metres.

CAMDEN (S Weatherley) – Lay out rounding the final turn.

TOP SHELF (W Pinn) - Raced keenly being inclined to shift ground under pressure in the straight.

MOSCHINO (M Hashizume) - Lay out under pressure in the straight.

PURE DELIGHT (S Spratt) - When questioned regarding the performance rider advised that the mare travelled well during the running however had failed to respond when placed under pressure. Lost the off front plate during the running.

LUVABEEL (W Pinn) – Whilst attempting to load into the barriers, reared over backwards dislodging its rider with LUVABEEL being declared a late scratching at 6.12 pm on veterinary advice. W Pinn was attended to by St John personal and was stood down with a back injury. W Pinn is to provide a medical clearance prior to riding next. Connections were advised the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next.

WILLYDOIT (M Hashizume) - Slow away. Clipped a heel of I'M FEELING LUCKY near the 1100 metres.

LITTLE THIEF (V Colgan) - Slow away.

VENETIAN (W Kennedy) – Raced three wide without cover throughout.

I'M FEELING LUCKY (T Mitchell) - Raced keenly in the early stages getting its head up placing its rider at a disadvantage.

GOLD CARD (J Doyle) - Held up rounding the final turn. Struck a heel of LA VOISIN and blundered badly near the 300 metres.

J Fawcett (LA VOISIN) - Admitted a charge of careless riding in that she permitted her mount to shift inwards near the 300 metres when not sufficiently clear of GOLD CARD which struck a heel and blundered. After considering submissions the Adjudicator imposed a suspension of J Fawcett's licence to ride in races from the conclusion of racing on Saturday 21 December up to and including racing on Monday 30 December, 6 national riding days.

Race 6	SKYCITY HORIZON 1600

ULTIMATE FOCUS (B Jacobson) - Began awkwardly losing ground. Raced keenly through the middle stages having to be steadied off heels near the 800 metres.

MALDINI (S Weatherley) - Began awkwardly losing ground.

POSTER BOY (R Goyaram) - Lay outwards when placed under pressure passing the 250 metres having to be corrected by its rider.

I'M LULU (J Doyle) - Placed in restricted room approaching the 250 metres when POSTER BOY lay outwards.

S&E Clotworthy (BELLA LUCE) Issued with a warning for presenting the mare to race without the notified nasal strip.
