RACE COMMENTS**Race 1****PULLMAN MELBOURNE CITY CENTRE MAIDEN 1600m**

CRAFTSMAN (J Riddell) - Jumped away awkwardly, crowding inside runners. Raced keenly throughout and was inclined to lay inwards in the home straight. J Riddell had no excuse. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

EL TAJIN (A Mudhoo) - Contacted at the start, losing ground.

KEEPING TIME (A Riddell) - Contacted at the start.

KWANZA (L Sutherland) - Jumped away awkwardly, contacting **FIRST EDITION**.

FIRST EDITION (L Hemi) - Contacted at the start.

CORSINI (A Lawson-Carroll) - Raced keenly in the early stages. Finished some distance last. Underwent a post-race veterinary examination which was clear. Connections advised that **CORSINI** is retired.

Race 2**ROTHLEY MAIDEN 1300m**

SOL DE OTONO (L Allpress) - Slow to begin. Held up rounding the home turn before being angled outwards near the 500 metres. Was reluctant to take a gap near the 250 metres. When questioned L Allpress confirmed the mare raced greenly and was reluctant to improve when in restricted room.

BROADWAY GIRL (C Dell) - Slow to begin.

RUSHIN HOME (M Hashizume) - Restrained to obtain cover from a wide draw.

THE LIQUIDATOR (L Sutherland) - Slow to begin. Held up rounding the home turn and was unable to obtain clear running in the home straight, being held up for some distance between the 200 metres and 100 metres, gaining clear running over the final stages. L Sutherland advised the gelding, which was making its debut, raced greenly and would improve with experience.

WHOOSHKA (A Lawson-Carroll) - Began awkwardly, contacting **COMPLEX**. Held up in the home straight and unable to improve until angled outwards near the 150 metres.

COMPLEX (M Hudson) - Contacted at the start. Raced three-wide without cover throughout.

DUDADAY (L Hemi) - Made the bend near the 1000 awkwardly and shifted outwards dictating **KERRYANNA** into the line of **FASTER SOONER NOW** resulting in both those runners being hampered and forced over extra ground.

KERRYANNA (K Hercock) - Hampered and forced over extra ground near the 1000 metres.

FASTER SOONER NOW (C Barnes) - Hampered and forced over extra ground near the 1000 metres.

NOVERN (J Doyle) - Rider reported the gelding raced greenly and hung outwards throughout.

Race 3**TAYLOR PROPERTY PLUS 2100m**

FREE SPIRIT (T Davies) - Charged the gates as the start was made and lost ground.

COLORADO STAR (J Chung) - Began awkwardly, contacting SAILOR JACK.

SAILOR JACK (J Doyle) - Contacted at the start.

OPAWA JACK (K Hercock) - Restrained off heels shortly after the start then commenced to race keenly in the early stages.

MANIFIQUE (M Hashizume) - Restrained from a wide draw to obtain over.

SACRED PEARL (A Riddell) - Raced wide without cover throughout. Underwent a post-race veterinary examination which was clear.

J Doyle (SAILOR JACK) - Issued with a warning after permitting SAILOR JACK to shift inwards shortly after the start when not sufficiently clear of OPAWA JACK, which was restrained off heels going into the first bend.

LATEST MODEL (L Sutherland) - Restrained at the start to obtain cover after jumping from the outside barrier.

LADY'S SECRET (J Doyle) - Restrained from its wide draw to obtain cover. Held up for the majority of the home straight, going to the line without being fully tested over the final stages.

PHATS (M Hashizume) - Shifted inwards shortly after the start contacting ROULADE.

ROULADE (C Dell) - Contacted at the start.

DOJAKATA (M Hudson) - Slow to begin.

TUKITUKI (M Singh) - Jumped away awkwardly, contacting MY ALIBI.

MY ALIBI (J Chung) - Contacted at the start. Raced three-wide without cover throughout.

MR TWINKLETOES (L Allpress) - Raced wide in the early stages.

MOSSRAJ (T Davies) - Raced keenly throughout. Shifted inwards near the 350 metres, dictating NO BIZZ inwards on to DOLLYBIRD, which was checked.

NO BIZZ (A Lawson-Carroll) - Dictated inwards near the 350 metres.

DOLLYBIRD (K Hercock) - Checked near the 350 metres.

COMEDY (J Riddell) - Held up and unable to improve in the home straight, gaining clear running inside the 150 metres.

T Davies (MOSSRAJ) - Admitted a charge of careless riding in that she permitted MOSSRAJ to shift inwards when not sufficiently clear of NO BIZZ and DOLLYBIRD, which was checked near the 350 metres. After considering submissions the Adjudicative Committee imposed a suspension of her licence to ride in races from the conclusion of racing on Sunday, 15 December, until the conclusion of racing on Saturday, 21 December, 4 national riding days.

A Lawson-Carroll (NO BIZZ) - Admitted a charge in that he used his whip with an action which raised the rider's arm above shoulder height. After considering submissions the Adjudicative Committee imposed a fine of \$300.

Race 5	RACECOURSE ROAD CAFE AND BAR 1200m
<p>PARTY ROCKING (J Chung) - Underwent and passed a pre-race veterinary examination at the start after a coming into contact with a fence in the parade ring.</p> <p>BROONZY (J Doyle) - Slow to begin. Put in a faulty stride after making contact with a runner to its outside near the 600 metres. J Doyle considered there may have been something amiss and did not persevere with the gelding over the concluding stages. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.</p> <p>EVELYN RUSH (L Allpress) - Raced keenly in the early stages. Held up in the straight, gaining clear running near the 200 metres.</p>	
Race 6	BLUE STAR CHRISTMAS CUP HANDICAP 1200m
<p>There was a delay to the start of this race due to a miscommunication regarding start times in publications.</p> <p>LINCOLN'S KRUZ (L Sutherland) - Raced keenly in the early stages. Held up approaching the 350 metres.</p> <p>DUNCAN CREEK (M Hashizume) - Was not persevered with over the concluding stages after the rider felt there may have been something amiss with the gelding. A post-race veterinary examination revealed the gelding to be showing signs of shin-soreness.</p>	
Race 7	JR & N BERKETT 1400m
<p>FIELD OF GOLD (S Mxothwa) - Restrained at the start to obtain cover from its wide draw. Angled outwards entering the home straight when SCouser shifted outwards. Lay inwards under pressure over the concluding stages.</p> <p>REGAL DICE (L Douglas) - Jumped away awkwardly, crowding DIVINE SPIRIT and got back from its wide draw.</p> <p>DIVINE SPIRIT (J Chung) - Crowded at the start. Raced wide throughout so was taken forward near the 1000 metres.</p> <p>BRAZINCO (T Davies) - Raced keenly in the early stages. Steadied off heels approaching the 800 metres.</p> <p>JESTIN CASE (C Dell) - Held up early in the home straight, obtaining clear running near the 250 metres.</p> <p>STRINGLINE (J Doyle) - Returned to the enclosure with blood present in the nostril area. A post-race veterinary examination revealed a minor cut to the nose.</p> <p>M Hashizume (SCouser) - Issued with a warning after permitting SCouser to shift outwards near the 400 metres when not sufficiently clear of FIELD OF GOLD, which had to shift off that runner's heels.</p>	
Race 8	GRANT PLUMBING 1600m
<p>PUDDIN 'N PIE (L Sutherland) - Restrained at the start to obtain cover after jumping from the outside barrier. Returned to the enclosure with blood present in one nostril. A post-race veterinary examination revealed a small cut in one nostril.</p> <p>BEAN A PLEASURE (C Barnes) - Raced keenly in the early stages. Hampered and dictated wide in the home straight when AM I BLUE shifted outwards under hard riding.</p> <p>DOWNTROU (K Hercock) - Raced keenly in the early stages</p> <p>VESPACIAN (A Riddell) - Raced wide until the 900 metres prior to being taken forward.</p>	

AM I BLUE (A Mudhoo) - Lay outwards over the concluding stages. A Mudhoo, in the presence of the Apprentice Mentor, was advised he is expected to straighten his mount sooner than he did on this occasion. When questioned into the improved performance of AM I BLUE, Trainer I Kelly was of the opinion the mare was better suited to the slower pace of today's race than the quicker tempo of previous start.

SHEEZ DOMINANT (M Hashizume) - Lay outwards throughout the home straight with the rider having to straighten his mount on several occasions. M Hashizume advised Stewards his mount was feeling the firm footing and may prefer more rain-affected going.
