<b>SUPPLEMENTARY</b>
<p><b>Kurow Jockey Club - Monday 30 December 2024</b>  <b>Race 10 - COUPLANDS WORKING DOGS R75 1400m</b>  Subsequent to the race day at Kurow on 30 December 2024, it was brought to the Stewards' attention that there may be an error in the placings for Race 10. On review of the evidence, the Stewards ascertained that the judge incorrectly placed the horses in third and fourth position. The issue was raised with the Judge who accepted that an error had been made. There are no provisions in the Rules for Stewards to amend Judges' placings after the payment of dividends has commenced and accordingly the official placings will remain unchanged.</p> <p><b>Kumara Racing Club – Saturday 11 January 2025</b>  <b>Race 3 – HYNDS PIPE SYSTEMS/ALEX HAYWARD &amp; NOEL WAFER POW MDN 1810m</b>  <b>R Mudhoo</b> (YUNGBLUD) pleaded guilty to a charge in that he misconducted himself after the race by jaggging on YUNGBLUD's mouth and slapping him unnecessarily with the whip on 3 occasions when pulling his mount up. After hearing from Stewards and Mr Mudhoo, the Adjudicator imposed a suspension of R Mudhoo's licence to ride in races from the conclusion of racing on Sunday 2 February until the conclusion of racing on Wednesday 12 February 2025, 6 national riding days.</p> <p><b>Canterbury Jockey Club - Wednesday 15 January 2025</b>  <b>Race 6 – CORIN &amp; BOBBITY MURFITT 1400m</b>  <b>RUBICON REIGNS</b> - Trainer J Bullard advised Stewards that after a disappointing performance in this event the gelding underwent a subsequent veterinary inspection at the home stable which did not reveal any significant abnormality. J Bullard further advised he would be continuing with the current campaign.</p> <p><b>Waikouaiti Racing Club at Wingatui – Saturday 18 January 2025</b>  <b>Race 7 - WAE WAIKOUAITI CUP 2200m</b>  <b>HUMBUCKER</b> - Trainer E Winsloe advised Stewards that after the disappointing performance a subsequent veterinary inspection on return to the home stable did not reveal any obvious abnormality. E Winsloe further advised he would be continuing with the current campaign.</p>

Held up rounding the final bend and had to shift ground inwards near the 250 metres to find clear racing room.</p> <p><b>LITTLE BUT FIERCE</b> (T Moodley) - Began very awkwardly then reared unbalancing its rider and losing ground. Shortly after the start was taken in by AIRPARK HUSTLER when that runner shifted ground abruptly. Had some trouble obtaining clear running early in the run home. Briefly steadied to avoid the heels of AIRPARK HUSTLER (A Goindasamy) near the 150 metres when that runner shifted inwards. **AIRPARK HUSTLER** (A Goindasamy) - Slow to begin. Shifted inwards near the 1300 metres dictating LITTLE BUT FIERCE inwards. Over raced in the early stages.

**MAGGIE MCMUFFIN** (L Hemi) - Restrained from its wide barrier draw to obtain cover shortly after the start.

**MANALI** (T Comignaghi) - Got its head up when over racing through the early stages. Raced wide without cover throughout.

**THE BETTER ONE** (L Callaway) - Over raced on a number of occasions in the early stages getting its head up.

**AGAPE** (R Mudhoo) - Got its head up when being steadied to take a trailing position in the early stages. Crowded and raced in restricted room near the 1000 metres when AIRPARK HUSTLER which was racing greenly shifted in abruptly again before being straightened by its rider.

**A Goindasamy** (AIRPARK HUSTLER) - Issued with a warning after allowing his mount AIRPARK HUSTLER to shift inwards near the 1300 metres dictating LITTLE BUT FIERCE inwards off its racing line. In assessing this Stewards took into account the racing manners of both horses.

**BY HER RULES** (A Lawson-Carroll) - Slow to begin. Rider could offer no tangible excuse for the disappointing performance. A post-race veterinary inspection did not reveal any obvious abnormality.

**HANGINBYATHREAD** (B May) - Blundered at the start. Shifted inwards under pressure near the 100 metres crowding SIR SIGARO which was placed in restricted room. When asked to comment on the improved performance, trainer N Mitchell advised that the gelding had no luck on the tight turning Kumara track and after a good run at its previous start at Timaru a forward showing was not unexpected today.

**GENIEINABOTTLE** (A Mudhoo) - Began awkwardly losing ground.

**HOUSE OF TUDOR** (T Comignaghi) - Began awkwardly.

**KING PALM** (A Balloo) - Shifted outwards at the start making contact with GROUSE.

**GROUSE** (D Cooper) - Contacted at the start. Crowded and had to steady near the 125 metres.

**FAH RONG** (T Moseley) - Got its head up and then commenced to race ungenerously when being restrained to obtain cover through the early and middle stages. Shifted in hampering THE BOSS LADY near the 200 metres having to be straightened by its rider.

**SIR SIGARO** (S Wynne) - Raced keenly through the early and middle stages. Placed in restricted room approaching the 100 metres when HANGINBYATHREAD shifted in before being straightened by its rider.

**FLAT STANLEY** (F Moerman) - Improved onto heels near the 900 metres clipping a heel of FANTAIL and blundering briefly.

**FANTAIL** (L Hemi) - Improved quickly onto the heels of GROUSE near the 850 metres having to be steadied. Rider could offer no tangible excuse for the disappointing performance, adding in her opinion the filly may be looking for more ground.

**OSONET** (R Jaun) - Raced greenly in the run home and near the 250 metres shifted inwards abruptly, having to be straightened by its rider.

**THE BOSS LADY** (B Murray) - Hampered near the 200 metres.

**Race 3** | **KARAKA 2025 2YO 800m**

**BEST ROSE** (A Lawson-Carroll) - Made contact with SANUR at the start.

**SANUR** (T Moseley) - Made contact with BEST ROSE at the start losing some ground.

**Race 4** | **BERKLEY STUD AT KARAKA 2025 1200m**

**MISS BRITTANY** (U Holmquist) - Jumped away awkwardly.

**QUARTZ QUEEN** (A Lindahl) - Shifted outwards at the start dictating AVITUS wider on the track.

**AVITUS** (A Balloo) - Began awkwardly and then dictated wider crowding GOLDEN HARVEST.

**GOLDEN HARVEST** (T Comignaghi) - Crowded shortly after the start losing ground when AVITUS was dictated outwards, with GOLDEN HARVEST also being dictated outwards making contact with BONA FIDE. Held up from the 600 metres, only gaining clear racing room inside the final 300 metres.

**BONA FIDE** (A Goindasamy) - Contacted at the start. Held up rounding the bend, only gaining clear racing room near the 300 metres.

**ANGELS WINGS** (M Lerner) - Slow to begin.

**CINNAMON GIRL** (S Wynne) - Slow to begin.

**LILLY** (D Cooper) - Knuckled leaving the barriers losing ground.

**Race 5** | **BRIAN WILSON – HAPPY RETIREMENT 1400m**

**T Rae** (CANDYCANE) - Admitted a charge in that she presented CANDYCANE with incorrect gear, namely blinkers instead of side winkers, with the Adjudicative Committee imposing a fine of \$150.

**FLOWER MOON** (K Mudhoo) - Began awkwardly losing ground.

**HIVARI** (B Murray) - Shifted inwards at the start making contact with CORRECTION. Lay inwards in the run home having to be straightened on a number of occasions.

**CORRECTION** (T Moseley) - Contacted at the start losing ground.

**JAFFA** (D Cooper) - Slow to begin.

**ALMANAC** (A Najib) - Began awkwardly losing ground.

**VICTORIAN CHARM** (A Goindasamy) - Began awkwardly. Over raced in the early stages and near the 1200 metres had to be steadied away from the heels of MISS PEARL.

**TIDE AND TIME** (F Moerman) - Slow to begin.

**MISS PEARL** (S Wynne) - Raced ungenerously when being restrained to take cover near the 1100 metres and continued to get its head up when racing keenly for some distance thereafter. Received veterinary treatment after returning to the birdcage with lacerations on the right hind leg consistent with being galloped on during the running.

<p><b>QUINTABELLE</b> (S Wynne) - Became fractious in its barrier prior to the start and as a result began awkwardly.</p> <p><b>TOMYTURBO</b> (U Holmquist) - Stood flat footed as the start was effected losing ground.</p> <p><b>FAMILY TIES</b> (M Lerner) - Restrained behind runners to obtain cover shortly after the start. Crowded and had to steady near the winning post when ROYAL VALOUR shifted inwards under pressure.</p> <p><b>TREYBON</b> (D Cooper) - Shifted outwards abruptly at the start dictating outside runners wider on the track.</p> <p><b>ROYAL VALOUR</b> (L Callaway) - Dictated wider shortly after the start and then restrained behind runners to obtain cover.</p> <p><b>OUR APPROVAL</b> (A Goindasamy) - Dictated wider shortly after the start and then restrained behind runners to obtain cover. Held up near the 150 metres when becoming awkwardly placed on the heels of BEAU BRUMMELL.</p> <p><b>FAR SITE</b> (B Murray) - Raced three wide without cover throughout.</p> <p><b>BEAU BRUMMELL</b> (A Lawson-Carroll) - Made contact with TOMMY SHELBY near the 300 metres and again near the 200 metres when both runners shifted ground.</p> <p><b>TOMMY SHELBY</b> (T Moseley) - Contacted by BEAU BRUMMELL near the 300 metres and again near the 200 metres when both runners shifted ground.</p> <p><b>L Callaway</b> (ROYAL VALOUR) - Issued with a warning after shifting inwards when not fully clear of FAMILY TIES which was crowded and had to steady approaching the winning post.</p> <p><b>S Wynne</b> (QUINTABELLE) - Admitted a charge of using the whip in two consecutive strides on her mount QUINTABELLE just prior to the winning post. After considering submissions the Adjudicative Committee imposed a fine of \$200.</p>	
<b>Race 7</b>	<b>WOODBOURNE TAVERN MARLBOROUGH CUP 2000m</b>
<p><b>PRINCE ALBY</b> (F Moerman) - Began awkwardly. Raced four wide from the 900 metres.</p> <p><b>STAR BALLOT</b> (A Goindasamy) - Slow to begin.</p> <p><b>SIR ALBERT</b> (L Hemi) - Slow to begin then crowded shortly after.</p> <p><b>IFFIDIDIT</b> (D Montes de Oca) - Shifted inwards shortly after the start crowding SIR ALBERT. Crowded near the 50 metres.</p> <p><b>CAPO DELL IMPERO</b> (K Mudhoo) - Restrained behind runners to obtain cover shortly after the start. Had to be steadied near the 1600 metres when the pace of the race eased. Held up by a tiring runner near the 250 metres, only gaining clear racing room inside the final 100 metres.</p> <p><b>MAHOE</b> (U Holmquist) - Had to be steadied outwards away from the heels of RICHARD STOMPER passing the 1800 metres when that runner eased the pace.</p> <p><b>ELEGANT LADY</b> (A Lawson-Carroll) - Raced three wide without cover for the majority of the race.</p>	

**TIMES TICKING** (K Williams) - Shifted in abruptly near the 225 metres crowding NOBLE KNIGHT before being straightened by its rider. Shifted in again in the shadows of the winning post, with NOBLE KNIGHT having to be steadied in consequence.

**NOBLE KNIGHT** (T Comignaghi) - Crowded near the 225 metres. Crowded and steadied in the shadows of the winning post when TIMES TICKING (K Williams) shifted inwards. K Williams was advised to exercise greater care.

**MR INTELLIGENCE** (D Cooper) - Shifted in under pressure passing the 50 metres crowding IFFIDIDIT before being straightened by its rider.

**B May** (RICHARD STOMPER) - Issued with a warning after slowing the pace near the 1800 metres placing runners behind in difficulty.

**Race 8**

**SPEIGHT'S TIMARU STAKES 1200m**

**D Montes de Oca** (TANZANITE ROSE) - Admitted a charge in that he was unable to make the contracted weight for TANZANITE, being fined \$200 by the Adjudicative Committee and replaced by B May who was permitted to ride 1kg over his declared weight due to lack of an available rider able to make the carded weight.

**TUMUCH** (A Balloo) - Slow to begin.

**AMBERECHO** (S Wynne) - Began awkwardly making contact with TANZANITE ROSE.

**TANZANITE ROSE** (B May) - Contacted at the start. Had to be steadied when awkwardly placed on heels near the 750 metres having to be steadied as a result. Held up in the run home having to shift ground outwards near the 250 metres to find clear racing room.

**PETRUCCI** (A Lawson-Carroll) - Reared at the start losing ground. Raced keenly through the early and middle stages.

**ADANNAYA** (U Holmquist) - Had to be steadied when placed in restricted room shortly after the start, losing ground as a result.

**TEXAS DOLLY** (L Hemi) - Had some trouble obtaining clear running early in the run home, having to shift ground inwards near the 300 metres.

**SHOES** (N Yuen) - Lay outwards in the run home.

**BELLUCCI** (K Williams) - Crowded and had to steady approaching the 100 metres.

**THIRD DECREE** (A Goindasamy) - Crowded and had to steady near the 100 metres when TUMUCH shifted in under pressure before being straightened by its rider.

**PERFECT SCENARIO** (M Lerner) - When questioned regarding performance, rider reported his intention had been to gain cover during the running however as the gelding began well he went forward and was then obliged to race in the open without cover which in his opinion had led to a disappointing performance.

**N Yuen** (SHOES) - Issued with a warning after allowing her mount SHOES to shift outwards under pressure crowding BELLUCCI which had to steady when tiring approaching the 100 metres. In assessing this matter Stewards took into account some inwards movement from outside runners.

**A Balloo** (TUMUCH) - Issued with a warning after allowing his mount TUMUCH to shift inwards near the 100 metres resulting in THIRD DECREE having to be steadied briefly.

The track was upgraded to Good 4 following Race 8.

**Race 9** | **INGLEWOOD STUD AT KARAKA 2025 1400m**

**STAR IN THE SKY** (A Lawson-Carroll) - Very fractious in its barrier prior to the start and when the blind fold was removed reared and began awkwardly losing considerable ground. Connections were advised that STAR IN THE SKY would be placed on a barrier manners warning. Stewards viewed footage of the start prior to correct weight being declared and after speaking with the rider could not be satisfied the mare had been denied a fair start, believing STAR IN THE SKY was a victim of its own manners. When questioned regarding performance, rider advised that after losing considerable ground at the start the mare had worked hard to catch the field but when placed under pressure in the straight failed to respond and dropped out finishing a distant last. Underwent a post-race veterinary examination which revealed the mare to have suffered cardiac arrhythmia. Stable representative H Durrant was advised that STAR IN THE SKY will not be permitted to start in any race or trial until a veterinary certificate declaring the horse free of any cardiac arrhythmia following a gallop of at least 1000 metres.

**POWERFUL MOSS** (A Goindasamy) - Slow to begin.

**SECOND CHANCE** (S Wynne) - Began very awkwardly losing ground. Over raced in the early stages getting its head up.

**BUGATTI** (K Mudhoo) - Slow to begin. Had to be steadied when racing in restricted room near the 700 metres.

**VAUDEVIRE** (T Moseley) - Slow to begin.

**MR BULLY TEE** (T Moodley) - Knuckled at the start losing ground.

**AN MORRIGHAN** (T Jonker) - Slow to begin.

**TOA HAKA** (R Mudhoo) - Raced three wide without cover throughout.

**DAPHNE DIOR** (T Comignaghi) - Shifted away from an outside runner near the 200 metres, making firm contact with SUPER RED DRAGON and having to be straightened by its rider.

**THE DIVINER** (B May) - Raced in restricted room over the concluding stages when taking a marginal run between runners.

**T Moodley** (MR BULLY TEE) - Issued with a warning after using the whip in two consecutive strides on MR BULLY TEE near the 150 metres.

**Race 10** | **RACECOURSE HOTEL & MOTOR LODGE 1800m**

**KINDLING SPARK** (L Hemi) - Slow to begin.

**WATERGATE** (T Comignaghi) - Slow to begin.

**HAYATE** (A Lawson-Carroll) - Began awkwardly losing ground.

**IFF I GET PAAID** (A Goindasamy) - Blundered at the start losing ground.

**IFFIN DOUBT DANCE** (S Wynne) - Had to be steadied when awkwardly placed inside heels near the 1600 metres. Rider advised she had been disappointed with the effort of the mare and may look to give her a brief freshen up.

**JING JING** (R Mudhoo) - Raced three wide without cover throughout. Crowded and buffeted near the 450 metres when DECLARE lay outwards. Shifted outwards near the 100 metres and when being straightened by its rider over-reacted becoming briefly awkward in its stride.

**BRACERO** (B May) - When questioned regarding performance, rider advised he had been very disappointed with today's effort. Underwent a post-race veterinary inspection which did not reveal any obvious abnormality.

**T Jonker** (DECLARE) - Issued with a warning after allowing her mount DECLARE to shift outwards contacting and crowding JING JING which was unbalanced near the 450 metres.
