RACE COMMENTS	
Race 1	GRAHAM'S PAINTERS 1400m
DETRIMENTAL (J Riddell) - Shifted outwards at the start hampering ONLY THE LONELY, which was then dictated outwards on to outside runners. Raced keenly through the early and middle stages.	
ONLY THE LONELY (V Colgan) - Hampered and dictated outwards at the start, losing ground. Raced greenly throughout and shifted inwards bumping KIDS GOT GEARS rounding the home turn. Came together with KERETI	

passing the 400 metres when both runners shifted ground simultaneously and became unbalanced. Steadied a short distance further.

WINGMAN (C Grylls) - Slow to begin and then contacted at the start.

KERETI (K Chowdhooory) - Jumped away awkwardly, losing ground. Over-raced through the early and middle stages when racing greenly. Came together with **ONLY THE LONELY** passing the 400 metres when both runners shifted ground simultaneously. Shifted inwards approaching the 200 metres, resulting in **ONLY THE LONELY** having to steady. K Chowdhooory was issued with a warning.

KIDS GOT GEARS (K Myers) - Lost the off-front plate during the running.

K Chowdhooory (KERETI) - Issued with a warning after permitting KERETI to shift inwards approaching the 200 metres, resulting in **ONLY THE LONELY** having to steady.

Track Upgraded to Good 4 retrospective to Race 1.

KIWI ROGUE (T Comignaghi) - Underwent a pre-race veterinary examination and was cleared to start after slipping in the birdcage.

NOZUMI (J Doyle) - Shifted outwards at the start, hampering **KOSTA**. Lay inwards near the 1000 metres and shifted inwards when not fully clear of **ARGYLE**. J Doyle was advised to exercise care. Went off stride approaching the 400 metres, becoming unbalanced. J Doyle advised his mount over-reacted when making contact with the running rail.

KOSTA (H Grace) - Hampered at the start, losing ground.

CHELSEA ROSE (K Chowdhooory) - Jumped away awkwardly, losing ground. Improved on to heels when the pace eased passing the 1000 metres and was steadied.

SLEIGHT OF HAND (A Mudhoo) - Slow to begin.

DUBAI'S POTIKI (L Hemi) - Over-raced in the back straight.

EARLY ONE'S (J Riddell) - Lost the off-hind plate during the running.

ONE BOLD GIGOLO (C Grylls) - Shifted outwards at the start, crowding **ANUSHKA SHESASTAR**.

ANUSHKA SHESASTAR (H Grace) - Crowded at the start, losing ground. Shifted inwards over the final stages.

REDANA (C Dell) - Slow to begin. Eased over the final stages when **ANUSHKA SHESASTAR** shifted in.

CARAJILLO (M McNab) - Dropped its head as the gates opened and as a result lost ground.

HE'S A BATTLER (K Stott) - Began awkwardly, losing ground.

GURTLYN (M Hudson) - Began awkwardly, losing ground.

PEPEHA (J Chung) - Restrained behind runners to obtain cover shortly after the start.

MY BOY ZAC (J Riddell) - From its wide barrier draw was restrained behind runners to obtain cover.

BEAN A PLEASURE (A Mudhoo) - Raced keenly through the early and middle stages.

LINARA (K Hercock) - Race three-wide without cover throughout.

Race 4 | **MILESTONE HOMES 2200m**

TITLED (G Rooke) - Jumped away awkwardly, losing ground.

RUBY ROCKS (C Grylls) - Rider advised after being taken on in front, the mare had failed to respond once placed under pressure and also added RUBY ROCKS may benefit from an easing in track conditions.

CROUCH (T Comignaghi) - Slow to begin. When questioned, rider was of the opinion the gelding would appreciate more rain-affected footing. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

DANJURO (K Chowdhury) - Slow to begin. Raced keenly through the early and middle stages. When questioned, rider was of the opinion the gelding would prefer an easing in the ground. Underwent a post-race veterinary examination which revealed increased upper respiratory noise.

Track Upgraded to Good 3 following Race 4.

Race 5 | **MANA PLUMBING 2100m**

BLUE JEANIE (K Hercock) - Slow to begin.

DRESSE' PAR JOLI (M McNab) - Blundered at the start, losing ground. M McNab advised that after missing the start the mare had got too far out of its ground and in his opinion is better suited to more rain-affected footing.

UNSCRIPTED (J Riddell) - Slow to begin.

LADY'S SECRET (H Grace) - Slow to begin.

CAST OF DIAMONDS (K Stott) - Got its head up when being restrained to obtain cover shortly after the start and got further back than what the rider intended, taking into account the short run into the first bend.

SIR BRUCE (C Grylls) - From a wide barrier draw was restrained to obtain cover shortly after the start.

SUNSET BOULEVARD (L Sutherland) - Raced three-wide without cover throughout.

CALL A FRIEND (J Doyle) - Over-raced through the early and middle stages.

REBECCHI (L Hemi) - Underwent a post-race veterinary examination at the request of the trainer, which revealed increased respiratory noise.

Race 6 | **MG TILING & CLARKY'S PAINTING 1200m**

RAYET (K Myers) - Slow away and then bumped. Checked near the 200 metres. Underwent a post-race veterinary examination did not reveal any abnormality.

SLIPPER ISLAND (M McNab) - Slow away. Held up until near the 200 metres, and when attempting a marginal run, buffeted severely with RAYET, which was checked.

SEAMSEW (J Doyle) - Tightened when weaking shortly after turning into the home straight after IVY DAZZLER was dictated inwards by BRAVE SPIRIT. K Stott was advised to exercise greater care.

AQUILIFER (G Rooke) - Held up and unable to improve until near the 200 metres. Lost the off-front plate during the running.

DISCOVERY BAY (T Comignaghi) - Angled outwards passing the 200 metres.

SINBIN (C Grylls) - Hampered passing the 200 metres

DUNEAGLE (V Colgan) - Hampered passing the 200 metres.

GEE STRING (K Hercock) - Hampered passing the 200 metres when DISCOVERY BAY was angled outwards. T Comignaghi was advised to exercise greater care.

M McNab (SLIPPER ISLAND) - Admitted a charge of careless riding in that he directed SLIPPER ISLAND outwards when not sufficiently clear of RAYET, which was checked near the 200 metres. After considering submissions the Adjudicative Committee imposed a suspension of his licence to ride in races from the conclusion of racing on Saturday, 8 March, until the conclusion of racing on Friday, 21 March, 8 national riding days.

Race 7 | **IRT 1200m**

BELLE'S ECHO (K Myers) - Began awkwardly, losing ground.

LIGHTNING JACK (A Riddell) - Slow to begin and was then crowded when runners to either side shifted ground.

ROYAL FLOWER (L Hemi) - Raced wide in the early and middle stages.

HAVARTI (K Chowdhoory) - Over-raced through the early and middle stages. Returned to the enclosure with blood present in both nostrils. HAVARTI underwent a post-race veterinary inspection which found the gelding to have experienced an episode of Epistaxis. HAVARTI shall not be ridden in exercise for a period of two months or start in any race or trial for a period of three months, and then only after a satisfactory gallop of at least 1000 metres in the presence of a Veterinarian.

Race 8 | **JENNIAN HOMES LOWLAND STAKES (G2) 2100m**

THRILLING (K Myers) - Began awkwardly, losing ground.

PICCOLINO (L Sutherland) - Slow to begin. L Sutherland reported that after being slow away, the filly had got further back than intended after getting well out of its ground in the early stages.

EVERYMOVEYOUMAKE (W Pinn) - Restrained behind runners to obtain cover shortly after the start. Awkward in the home straight. When questioned, W Pinn advised the filly felt awkward in its action and changed legs several times in the home straight. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

CONNELLO (T Comignaghi) - Made the first bend awkwardly when over-racing.

MONOLOGUE (J Doyle) - Raced three-wide without cover throughout.

ALASKAN (G Rooke) - Held up briefly at the top of the home straight.

Race 9 | **LASER ELECTRICAL 1600m**

JESTIN CASE (W Pinn) - Slow to begin.

KHANSHE (C Grylls) - Raced three-wide without cover throughout.

LATRELLE (M McNab) - Shifted inwards over the final stages, resulting in LANIKAI having to be steadied.

LANIKAI (K Stott) - Steadied immediately prior to and passing the winning post when LATRELLE shifted inwards over the final stages.

RUSTY LANE (A Riddell) - Underwent a veterinary examination including an endoscopic examination at the request of the trainer, which revealed grade 3 out of 4 mucus.

M McNab (LATRELLE) - Issued with a warning after allowing his mount to shift inwards over the final stages, resulting in LANIKAI having to be steadied immediately prior to and passing the winning post. After questioning riders and connections, Stewards were satisfied that LANIKAI'S finishing position was not compromised.
