BLUE DENIM GIRL (C Grylls) – Trainer A Forsman reported to Stewards **BLUE DENIM GIRL** pulled up post-race with mild muscle soreness and has now been sent for a spell.

| Race 1 | GARTSHORE CONSTRUCTION MAIDEN 1600 |
| <p>QUASI (L Satherley) - Crowded shortly after the start losing ground.</p> <p>MARIA (B Rogerson) – Raced wide without cover through the early and middle stages.</p> <p>WHOSHE’S BOY (V Jalalkuncha) – Rider dropped his whip near the 200 metres.</p> <p>ATAVUS (R Hutchings) – When questioned regarding the performance rider advised that the gelding would appreciate a step up in distance.</p> <p>N Yuen (NASHA MALA) - Admitted a charge in that she struck her mount eight times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a fine of \$500.</p> | |
| Race 2 | LASER ELECTRICAL TAURANGA MAIDEN 1400 |
| <p>SEDUIRE (L Satherley) - Began awkwardly then crowded shortly after, losing ground.</p> <p>LITTLE THIEF (A Lawson-Carroll) - Restrained at the start to obtain cover from a wide barrier. When questioned regarding the performance rider advised that the gelding found it difficult to make up ground from a rearward position given the early moderate tempo of the race.</p> <p>IAMEXCITEMENT (H Grace) - Crowded shortly after the start having to be steadied. Shifted outwards when placed under pressure inconveniencing LINIOUS near the 175 metres. H Grace was advised to exercise greater care in similar circumstances.</p> <p>ANDORRA (W Kennedy) - Steadied off heels when racing keenly near the 1000 metres. Forced wider on the track rounding the final bend. Inconvenienced passing the 75 metres.</p> <p>SARRACINA (J Fawcett) - Raced wide in the early stages before improving forward to settle outside the leader near the 900 metres. Shifted out and away from ANDORRA rounding the final bend contacting FOREVER YOUNG which was forced wider on the track.</p> <p>FOREVER YOUNG (K Stott) - Contacted and forced wider on the track rounding the final bend.</p> <p>SPERLARI (M McNab) - Lay outwards rounding the final bend. Shifted outwards when placed under pressure inconveniencing ANDORRA passing the 75 metres. M McNab was advised to exercise greater care in similar circumstances.</p> <p>LINIOUS (N Yuen) - Inconvenienced near the 175 metres.</p> <p>LET’S DANCE (M Lerner) – Lost the near hind plate during the running.</p> <p>Following this race the track was upgraded to Good 4.</p> | |

| <p>DOMAIN ACE (C Grylls) - Restrained to obtain cover in the early stages from the outside barrier.</p> <p>PENMAN (G Rooke) – Ducked outwards just prior to the finish line.</p> | |

COGNOSCENTI (W Pinn) - When questioned regarding the performance rider advised that the gelding had never travelled throughout the running, and he felt there may be something amiss. Underwent a post-race veterinary examination which revealed no abnormalities.

Race 4 | **J.A. RUSSELL LTD MAIDEN 2100**

TRUST ALONE (C Grylls) - Began awkwardly losing ground. Held up rounding the final bend and early in the straight.

ALAVISTO (M Lerner) - Slow to begin. Shifted outwards when not fully clear of BLUE LINES which was inconvenienced entering the final straight. M Lerner was advised to exercise greater care in similar circumstances.

GREY AREA (W Kennedy) - Shifted outwards entering the final straight forcing SONORAN wider on the track.

GOOD DAY (K Stott) - Held up rounding the final bend.

BLUE LINES (A Lawson-Carroll) - Inconvenienced entering the final straight.

SONORAN (L Satherley) - When questioned regarding the performance rider advised that the gelding had travelled well during the running, however when placed under pressure, had failed to respond. Underwent a post-race veterinary examination which revealed the gelding to have a delayed recovery. Stewards will follow up with connections on the post-race condition of the gelding in the coming days.

POETIC JUSTICE (R Hutchings) - When questioned regarding the performance rider advised that the gelding raced flat and was one-paced. Underwent a post-race veterinary examination which revealed no abnormalities.

Race 5 | **LASER ELECTRICAL MT MAUNGANUI MAIDEN 3YO 1200**

IVY'S DANCER (H Grace) - Slow to begin.

APEX (W Kennedy) - Restrained to obtain cover in the early stages from the outside barrier.

LINE DANCER (M McNab) – Raced three wide without cover throughout.

CATOCA (C Grylls) - Raced keenly for a distance passing the 1000 metres.

BASEL WARRIOR (K Stott) - Held up for clear running throughout the final straight.

VIVA GLAM (W Pinn) – Checked losing ground near the 50 metres.

FIRST UP (C Barnes) – Returned to the enclosure with blood present in its mouth. Underwent a post-race veterinary examination which revealed a minor laceration inside the mouth.

ZORRO'S REVENGE (R Elliot) - When questioned regarding the performance rider advised that the gelding felt indifferent in its action. Underwent a post-race veterinary examination which found the gelding to be 3/5 lame in the right foreleg. Connections were advised a veterinary clearance would be required prior to racing next.

A Lawson-Carroll (SISTA SUGAR) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when insufficiently clear of VIVA GLAM which was checked losing ground near the 50 metres. After considering submissions the Adjudicative Committee imposed a suspension of A Lawson-Carroll's licence to ride in races from the conclusion of racing on Saturday 15 February up to and including racing on Saturday 22 February, 4 national riding days.

Race 6 | **EMAC ELECTRICAL 1200**

NOT IDEAL (N Yuen) - Late scratched at 3.17 pm after rearing over in the parade ring dislodging its rider. N Yuen was attended to by oncourse Paramedics and advised a medical clearance would be required prior to riding next. Underwent a post-race veterinary examination which found the gelding to have blood in the right nostril with abnormal head carriage and head flicking. Connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next with a veterinary clearance also being required prior to racing next. Stewards will follow up with connections on the post-race condition of the gelding in the coming days.

FALL FOR CINDY (T Moodley) - Began awkwardly losing ground.

TROBRIAND (W Pinn) - Steadied off the heels of GLAMOUR TYCOON (M McNab) which shifted inwards when not fully clear near the 900 metres. M McNab was advised to exercise greater care in similar circumstances.

Race 7 | **SUPER LIQUOR GREERTON 1400**

KOHEROA (W Kennedy) - Began awkwardly then crowded shortly after, losing ground. When questioned regarding the performance rider advised that the gelding raced keenly through the middle stages which impacted on its finishing effort.

VAL DI ZOLDO (K Stott) - Restrained to obtain cover in the early stages from an outside barrier.

FRANCEE (W Pinn) - Shifted inwards leaving the barriers crowding KOHEROA.

SPECIAL SWEY (T Newman) – Raced three wide without cover throughout.

Race 8 | **SOCIAL CLUB GREERTON 1400**

ROCHMIE RAY (W Kennedy) – Slow to begin. Shifted inwards to obtain clear running near the 200 metres.

HOT SALSA (K Stott) - Slow to begin.

NAXOS (T Mitchell) – Raced three wide without cover throughout.

LADY OF COURT (C Grylls) - Raced keenly in the early stages. When questioned regarding the performance rider advised that the mare had failed to respond when placed under pressure. Underwent a post-race veterinary examination which revealed the mare to have a small laceration to the inside right hock.

RUBELLITE (A Lawson-Carroll) - Rider dropped his outside rein early in the final straight before being quickly regathered.
