Race 8 - POSITIVE SIGNS + PRINT 65 1200m

HERE I AM (S Weatherley) - Co-trainer Mr M Pitman reported to Stewards he was satisfied with the post-race condition of **HERE I AM** and will continue on with the gelding's current preparation.

RACE COMMENTS

Race 1 ENTAIN/NZB INSURANCE PEARL SERIES 800m

ZELIA (K Kwo) - Began awkwardly shifting outwards making heavy contact with **ROC 'N' READY** losing some ground as a result. Raced greenly in the early stages. When questioned regarding performance, rider reported the filly had not felt comfortable in today's track conditions. Received post-race treatment for minor abrasions to the right hind leg consistent with having been galloped on during the running.

ROC 'N' READY (S Wynne) - Contacted at the start losing ground then further hampered when ZELIA shifted outwards to avoid the heels of QUISIERA shortly after the start. Lay inwards throughout the run home having to be straightened on a number of occasions.

ELIZA JAMES (J Fawcett) - When questioned regarding performance, rider reported the filly had struggled in today's track conditions.

Race 2 | **CUP WEEK TICKETS – DON'T MISS OUT 1200m**

TAIL LIGHTS (A Najib) - Slow to begin.

MR BULLY TEE (K Hercock) - Slow to begin then raced keenly in the early stages. Had to be steadied away from heels near the 800 metres.

Race 3 | **COMMODORE HOTEL 1200m**

INFLAMED (R Muniandy) - Over raced in the early stages. Lost the right front plate during the running.

RETAIL THERAPY (T Comignaghi) - When questioned regarding the performance of this runner which finished last, rider advised that the mare had failed to handle today's track conditions. A post-race veterinary inspection did not reveal any obvious abnormality.

W Pinn (MALMAISON) - Admitted a charge in that he struck his mount MALMAISON 7 times prior to the 100 metre mark with a further 4 strikes inside the final 100 metres. After considering submissions the Adjudicative Committee imposed a fine of \$500.

Race 4 | **CANTERBURY LANDSCAPE SUPPLIES MAIDEN 1400m**

BEALEY VALLEY (J Fawcett) - Slow to begin. When questioned regarding performance, rider advised that the mare had struggled to quicken in today's track conditions.

DUJOUR (D Cooper) - Over raced in the early stages when leading. Lay outwards when placed under pressure in the straight.

BAGGIO (J Riddell) - Finished in last placing, with the rider unable to offer any excuse. A post-race veterinary inspection did not reveal any obvious abnormality.

Race 5 | **TAB MILE TRIAL 1400m**

GOLDIE'S CHANCE (T Comignaghi) - Slow to begin. Over raced in the early stages and got its head up when being steadied off heels.

TIMES TICKING (D Tait) - Jumped away awkwardly losing ground then being ridden forward to recover and lead. When questioned regarding performance, rider reported the gelding had struggled to quicken once placed under pressure in today's track conditions which she described as shifty. A post-race veterinary inspection did not reveal any obvious abnormality.

BETTY SPAGHETTI (J Fawcett) - Steadied shortly after the start when becoming awkwardly placed on the heels of SIR ALBERT. Rider reported the mare failed to handle today's heavy track conditions.

Race 6 | **NZB AIRFREIGHT ROAD TO JERICHO 3000m**

ICE EMPRESS (T Jonker) - Slow to begin. Became detached from the field passing the 800 metres. When questioned regarding performance, rider was of the opinion the mare had struggled with the rise in class.

NOBLE KNIGHT (K Chowdhury) - Over raced in the early stages.

PEECEE PUSSYCAT (R Muniandy) - Over raced in the early stages.

PROSERVE (W Pinn) - Over raced through the middle stages. Rider reported that after over racing the gelding had been quickly beaten once placed under pressure.

RAARDY RAAR (L Callaway) - Rider advised that the gelding failed to handle today's track conditions.

Race 7 | **WAR DECREE STAKES (G3) 1600m**

CLOCHE (C Campbell) - Slow to begin. The saddle shifted backwards during the running.

HE'S LUCID (L Sutherland) - Began awkwardly shifting outwards abruptly.

LIL ZENA (T Comignaghi) - Blundered leaving the barriers. Over raced in the early stages. Made contact with **LAVENDER HAZE** when shifting inwards to avoid the heels of the weakening **WHEN STARS ALIGN**, then having to be steadied when becoming awkwardly placed near the heels of **LAVENDER HAZE**.

WHEN STARS ALIGN (J Riddell) - Over raced while leading in the early stages. Gave ground from near the 500 metres and was not persevered with over the concluding stages finishing last. Rider reported the colt failed to see out the 1600 metre distance in today's testing track conditions and in his opinion may be better suited dropping back in distance. A post-race veterinary inspection did not reveal any obvious abnormality.

RAZIAH (S Wynne) - Steadied away from the heels of **HE'S LUCID** which lay outwards away from **WHEN STARS ALIGN** near the 450 metres. Prior to the authorisation of dividends, a stable representative viewed Stewards' footage before electing not to proceed with a protest.

LAVENDER HAZE (L Hemi) - Raced in restricted room approaching the 400 metres.

Race 8 | **PRYDE'S EASIFEED 1600m**

PONZI PONY (K Mudhoo) - Slow to begin then over raced in the early stages. Hampered when weakening after **COMPLICATE** lay outwards near the 600 metres.

IFFIN DOUBT DANCE (S Wynne) - Crowded and lost ground shortly after the start. Rider reported that the mare had never travelled in today's track conditions.

BELLUTTA (R Muniandy) - Began awkwardly losing ground.

HOT COCO (T Comignaghi) - Rider advised that the mare failed to handle today's track conditions.

Race 9 | **SOTHYS SPRING CLASSIC 2000m**

STAR BALLOT (A Goindasamy) - Slow to begin.

FIERCE FLIGHT (J Chung) - Slow to begin. Was a beaten runner entering the final straight, with the rider unable to offer any excuse advising that the gelding had felt disinterested.

ALJAY (J Riddell) - Slow to begin.

MISS LAYLA (J Fawcett) - Over raced through the middle stages.

SACRED DREAM (T Comignaghi) - Raced three wide without cover throughout.

W Pinn (FELLINI) - Admitted a charge in that he struck his mount FELLINI 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of W Pinn's licence to ride in races from the conclusion of racing on Sunday 10 November until the conclusion of racing on Sunday 17 November, 5 national riding days.

Race 10 | **HELSTON & ASSOCIATES 1800m**

KOYAMA (L Kauri) - Due to a misunderstanding D Tait was unaware of this riding engagement and as she was unable to ride at her declared riding weight was replaced by L Kauri.

PEACHY KEEN (A Goindasamy) - Slow to begin. Hampered passing the 400 metres.

SHEAF (J Chung) - Slow to begin. Held up early in the run home and had to shift ground inwards passing the 300 metres to obtain clear racing room.

OCEAN LIGHT (A Najib) - Slow to begin then being ridden forward to be handy.

TREYBON (T Comignaghi) - Raced keenly through the early to middle stages. Rider reported the gelding failed to handle today's track conditions.

IFFIDIDIT (Y Atchamah) - Held up rounding the final bend and near the 450 metres shifted inwards contacting BEAU BRUMMELL which was forced inwards, with IFFIDIDIT then blundering.

BEAU BRUMMELL (W Pinn) - Contacted and forced inwards passing the 400 metres.

POWERFUL MOSS (L Sutherland) - Hampered passing the 400 metres.

MISS PEARL (J Fawcett) - Hampered passing the 400 metres.

SPROCKET ROCKET (R Muniandy) - Rider dropped his whip near the 350 metres.

A Najib (OCEAN LIGHT) - Admitted a charge in that he struck his mount OCEAN LIGHT 8 times prior to the 100 metre mark. After considering submissions the Adjudicative Committee imposed a suspension of A Najib's licence to ride in races from the conclusion of racing on Tuesday 5 November until the conclusion of racing on Sunday 17 November, 9 national riding days.

Y Atchamah (IFFIDIDIT) - Admitted a charge of careless riding in that he shifted ground inwards approaching the 400 metres making contact with BEAU BRUMMELL which was forced inwards causing interference to PEACHY KEEN, POWERFUL MOSS and MISS PEARL. After considering submissions the Adjudicative Committee imposed a suspension of Y Atchamah's licence to ride in races from the conclusion of racing today Saturday 26 October until the conclusion of racing on Tuesday 5 November, 7 national riding days.
