GENERAL

At time of acceptances Stewards granted permission for T Newman to ride WHOSHE'S GIRL (R4) 1kg over at 55 kgs.

MR PUCCI (R6) was re-handicapped +2kg following a win at Rotorua on 03/07/2024. MR PUCCI will now carry 62kg.

B Grylls advised she would not be attending today's race meeting due to injury with a medical clearance required prior to riding next.

M Cameron advised he would not be attending today's race meeting due to injury with a medical clearance required prior to riding next.

RACE COMMENTS

Race 1 | **JUDEA TAVERN MAIDEN 1600**

LITTLE MISS WONDER (S Spratt) - Slow away (3L).

FANTOMETTE (J Fawcett) - Jumped away awkwardly. Raced wide without cover throughout. When questioned regarding the performance rider advised that the mare was not suited to today's track conditions. Underwent a post-race veterinary examination which did not reveal any abnormalities.

I'LL HAVA SEMILLON (T Mitchell) – Jumped away awkwardly losing ground. Hampered approaching the 1000 metres.

SHOWME DA MOOLAH (R Goyaram) - Raced in restricted room shortly after the start having to be steadied.

ESTELLA KHAN (B Rogerson) – Checked approaching the 1000 metres to avoid the dislodged rider.

SALLY (M Hashizume) - Hampered approaching the 1000 metres.

GENIEINABOTTLE (L Sutherland) - Hampered approaching the 1000 metres.

RIDE SALLY RIDE (J Nishizuka) - Blundered when crowded approaching the 1000 metres, dislodging its rider. J Nishizuka was attended to by St John Ambulance personnel and found to be uninjured.

NIGHT WARRIOR (W Pinn) - When questioned regarding the improved performance Trainer D Wiles advised that the gelding had been able to go forward and get a soft lead, further adding that the horse was not suited to the synthetic surface at its most recent start, and he was hopeful of an improved showing today.

W Pinn (NIGHT WARRIOR) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear of RIDE SALLY RIDE which blundered when crowded approaching the 1000 metres, dislodging its rider. After considering submissions the Adjudicator imposed a suspension of W Pinn's licence to ride in races from the conclusion of racing on Saturday 13 July up to and including racing on Saturday 10 August, 4 weeks.

Race 2 | **OWENS IFS MAIDEN 1400**

BOSUN (M Hashizume) - Jumped away awkwardly losing ground.

I'LLBERIDINGSHOTGUN (L Sutherland) - Slow away before being further hampered by CONQUISTAR which jumped inwards.

CONQUISTAR (K Asano) - Jumped away awkwardly making contact with I'LLBERIDINGSHOTGUN.

FALCON WARRIOR (C Barnes) - Slow away. Raced four wide without cover throughout.

DENZEL (T Moodley) - Slow away.

SHE'LL BE RIGHT (B Rogerson) - Raced three wide without cover throughout.

MOLDY (J Nishizuka) - Briefly raced in restricted room approaching the 1000 metres. Improved onto heels having to be steadied near the 450 metres. Lay outwards rounding the final bend and continued to do so when placed under pressure in the final straight.

ST VINCENT (W Pinn) - Raced in restricted room when SHE'LL BE RIGHT lay inwards approaching the 1000 metres having to be steadied. B Rogerson (SHE'LL BE RIGHT) was advised to exercise greater care in similar circumstances. Lay inwards when placed under pressure in the final straight.

PRISCA (J Fawcett) - Rider reported that the mare had hung outwards throughout.

Race 3

SADDLERY WAREHOUSE CAMBRIDGE & TAURANGA MAIDEN 1200

MONIQUE TONNERRE (J Nishizuka) - Jumped away awkwardly.

KERRYANNA (J Fawcett) - Restrained to obtain cover after jumping from a wide barrier and was then inclined to over-race through the middle stages.

TWAIN (T Moodley) - Crowded leaving the barriers. Raced greenly under pressure in the straight.

CARTER RUSSELL (L Sutherland) – Raced wide without cover.

JETHRO TULL (W Pinn) - Hung outwards rounding the final turn, continuing to hang badly in the straight and was unable to be ridden out by its rider. Connections were advised a warning would be placed against the gelding's racing manners.

Race 4

I.C.I.B FINANCIAL INDEPENDENCE 1200

SEA A PENNY (T Moodley) - Slow away. Commenced to over-race shortly after the start having to firmly restrain to avoid heels going into the first turn passing the 1000 metres. Raced four wide without cover from the 1000 metres.

GELDOF (M Hashizume) – Restrained to obtain cover after jumping from the outside barrier.

YARI (B Rogerson) - Jumped away awkwardly. Raced keenly through the early and middle stages.

WEY TOO COOL (J Nishizuka) - Jumped away awkwardly.

LA RUCHE (L Sutherland) - Raced three wide without cover throughout.

MADIRAN (S Spratt) - Raced keenly through the early and middle stages. Steadied to avoid the heels of SUPER TIME which had shifted inwards when not fully clear near the 900 metres.

HIGHLY ANTICIPATED (W Kennedy) – Held up entering the straight approaching the 300 metres having to steady and shift ground inward across heels to obtain clear running passing the 200 metres.

T Mitchell (SUPER TIME) - Issued with a warning after permitting her mount to shift inwards when not fully clear of MADIRAN which had to be steadied near the 900 metres.

Race 5 | **TRITON PACIFIC MAIDEN 2100**

SATIN DOLL (K Asano) - Slow away. Improved onto heels having to steady near the 1700 metres then again near the 1600 metres. When questioned regarding performance the rider could offer no explanation.

HOOTIE JOHNSON (T Newman) - Jumped away awkwardly making contact with SHELYS LAST DOLLAR on two occasions then having to be steadied when bumped across the heels of STORMS AHEAD. Improved onto heels having to be steadied near the 1800 metres.

SHELYS LAST DOLLAR (R Goyaram) - Contacted on two occasions shortly after leaving the barriers. Checked near the 1800 metres to avoid the heels of PROCELLA which had been dictated inwards. Made the crossing awkwardly shifting outwards forcing KEEPZ OCCURRING wider on the track.

TE AROHA BOY (L Sutherland) - Raced keenly through the early and middle stages.

STORMS AHEAD (W Pinn) - Raced keenly through the early and middle stages.

VERDI'S OPERA (J Nishizuka) – Steadied to avoid the heels of ZEE HEIGHTS near the 1800 metres. Raced three wide without cover for majority of the event. When questioned regarding the improved performance Trainer S Ralph advised that he had been happy with the mare's previous performances and added that she had taken benefit from recent racing.

PROCELLA (W Kennedy) - Steadied when dictated inwards by ROSINA which was shifting inwards when not sufficiently clear near the 1800 metres.

ZEE HEIGHTS (S Spratt) – Hampered and forced wider near the 1800 metres when SHELYS LAST DOLLAR shifted outwards.

OUR EASY STREET (J Fawcett) - Improved onto heels having to steady near the 1700 metres.

KEEPZ OCCURRING (C Barnes) – Forced wider near the 1600 metres.

CANULOVEMEAGAIN (M Hashizume) - Lay outwards when placed under pressure in the final straight.

BEAU ONDAGO (B Jacobson) - Raced in restricted room over the concluding stages when runners to either side shifted ground slightly.

T Moodley (ROSINA) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear dictating PROCELLA into the line of SHELYS LAST DOLLAR which was checked near the 1800 metres. After considering submissions the Adjudicator imposed a suspension of T Moodley's licence to ride in races from the conclusion of racing on Saturday 13 July up to and including racing on Wednesday 24 July, 5 national riding days. Stewards directed T Moodley to meet with a NZTR appointed Rider Skills Review Panel for remedial training under the provisions of Rule 343 due to his poor record of careless riding breaches in the previous twelve months.

Race 6 | **CHEERS TAVERN 1600**

MISTER PUCCI (J Nishizuka) - Crowded at the start losing ground.

CHILLI CON KHAN (S Spratt) - Forced wider near the 400 metres when RUACH shifted outwards.

KORO'S PRINCESS (M Hashizume) - Slow to begin. Underwent a post-race veterinary examination which did not reveal any abnormalities.

WHISKEY N' RYE (T Moodley) – Raced three wide without cover throughout.

AQUA MAN (S Brown) - Steadied when placed in restricted room to the outside of CHILLI CON KHAN near the 400 metres when RUACH shifted outwards.

FOOTLOOSE (C Barnes) - When questioned regarding the performance the rider could offer no explanation. Underwent a post-race veterinary examination which did not reveal any abnormalities.

B Jacobson (RUACH) - Admitted a charge of using his whip in two consecutive strides near the 125 metres with the Adjudicator imposing a fine of \$150.

B Jacobson (RUACH) - Issued with a warning after permitting his mount to shift outwards when not fully clear crowding CHILLI CON KHAN onto AQUA MAN near the 400 metres.
